

ORDINANCE NO. 23

AN ORDINANCE PROVIDING FOR A SUPPLEMENTAL APPROPRIATION IN THE APPROXIMATE AMOUNT OF \$1040.00 FROM REVENUE SHARING FUNDS TO THE PARK FUND, THE HIGHWAYS AND STREETS FUND, AND THE SENIOR CITIZENS FUND FOR THE ROUTINE OPERATION OF THE TOWN OF CROOKS FOR THE YEAR, 1981; AND DECLARING AN EMERGENCY.

WHEREAS, since the adoption of the Annual Appropriation Ordinance of the Town of Crooks, South Dakota, in October of 1980, it has been found necessary for the operation of the Town of Crooks, South Dakota, and the discharge of its lawful duties and the performance of its indispensable functions to provide additional funds for the Park Fund, the Highways and Streets Fund, and the Senior Citizens Fund of the Town of Crooks, South Dakota;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES, TOWN OF CROOKS, SOUTH DAKOTA:

Section 1. There is hereby appropriated from Revenue Sharing Funds of the Town of Crooks, South Dakota, the sum of approximately \$1040.00 to the funds hereinafter specified, for the purpose of paying any lawful claim incurred by said departments for the remainder of the calendar year, 1981.

Section 2. The above amount of \$1040.00 is an approximation only and this ordinance shall be deemed to appropriate and authorize the expenditure of all such Revenue Sharing Funds received by the Town of Crooks during the calendar year, 1981.

Section 3. That the total amount of Revenue Sharing Funds received in 1981 shall be appropriated to the following funds and expended accordingly, in the following proportions:

Section 4. Whereas this Ordinance is necessary for the immediate preservation of the public peace, health, safety and support of the municipal government of the Town of Crooks, and its existing public institutions, an emergency is hereby declared to exist, and this Ordinance shall take effect upon the passage and publication hereof.
