

ORDINANCE NO. 25

AN ORDINANCE PROVIDING FOR THE ANNUAL APPROPRIATION FOR THE TOWN OF CROOKS, SOUTH DAKOTA, AND LEVYING THE ANNUAL TAX ON THE TAXABLE PROPERTY IN THE TOWN OF CROOKS, SOUTH DAKOTA, FOR THE PURPOSE OF DEFRAYING THE EXPENSES AND LIABILITIES OF THE TOWN OF CROOKS, SOUTH DAKOTA, FOR THE FISCAL YEAR, JANUARY 1, 1982, THROUGH DECEMBER 31, 1982.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF CROOKS, SOUTH DAKOTA:

Section 1. That there be and hereby is appropriated by the Board of Trustees of the Town of Crooks, South Dakota, for the fiscal year, January 1, 1982, through December 31, 1982, the following sums of money for the following purposes, to defray the necessary expenses and liabilities of the Town of Crooks, South Dakota:

Section 2. That there be and hereby is levied upon all taxable property within the Town of Crooks, South Dakota, for the purpose of funds to meet the lawful expenses and liabilities of the Town of Crooks, South Dakota, as hereinbefore set forth, for the fiscal year, January 1, 1982, through December 31, 1982, a tax sufficient to raise the total of the 1982 Appropriation Budget as above specified, according to the following designation of funds and amounts:
