

ORDINANCE NO. 178

AN ORDINANCE PROVIDING FOR A SUPPLEMENTAL APPROPRIATION IN THE SUM OF \$44,627 FROM 2010 GENERAL FUNDS DEPARTMENT CARRYOVER, \$1500 FROM PARK DONATIONS AND \$22,500 GENERAL FUNDS TO THE FOLLOWING DEPARTMENTAL FUNDS IN THE FOLLOWING AMOUNTS: \$1500 PARK DEPARTMENT, \$10,500 FIRE DEPARTMENT, \$28,000 STREETS, \$19,261 FRONT FOOTAGE ASSESSMENT, \$2000 SNOW REMOVAL AND \$7366 PARK DEVELOPMENT FOR THE ROUTINE OPERATION OF THE CITY OF CROOKS FOR THE YEAR 2011; AND DECLARING AN EMERGENCY.

WHEREAS, since the adoption of the Annual Appropriation Ordinance of the City of Crooks, South Dakota, in October of 2010, it has been found necessary for the operation of the City of Crooks, South Dakota and the discharge of its lawful duties and the performance of its indispensable functions to provide additional funds for the PARK, FIRE DEPARTMENT, STREET, FRONT FOOTAGE ASSESSMENT, SNOW REMOVAL & PARK DEVELOPMENT funds of the City of Crooks, South Dakota.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROOKS, SOUTH DAKOTA:

Section 1. There is hereby appropriated from General Funds of the City of Crooks, South Dakota, the sum of \$88,627 to the following departmental funds, in the following amounts, for the purpose of paying any lawful claim incurred by said departments for the remainder of the calendar year, 2011.
