

ORDINANCE NO. 200

AN ORDINANCE PROVIDING FOR A SUPPLEMENTAL APPROPRIATION IN THE SUM OF \$76,000 FROM 2013 GENERAL FUNDS DEPARTMENT CARRYOVER AND \$3000 UNOBLIGATED GENERAL FUNDS TO THE FOLLOWING DEPARTMENTAL FUNDS IN THE FOLLOWING AMOUNTS: \$4,000 FINANCE OFFICE DEPARTMENT, \$53,000 STREET DEPARTMENT, \$5,000 SPECIAL MAINTENANCE ASSESSMENT\ STREET DEPARTMENT, \$6,000 COMMUNITY CENTER DEPARTMENT, \$8,000 SNOW REMOVAL DEPARTMENT AND \$3000 CODE\ENFORCEMENT\SANITATION DEPARTMENT FOR THE ROUTINE OPERATION OF THE CITY OF CROOKS FOR THE YEAR 2014; AND DECLARING AN EMERGENCY.

WHEREAS, since the adoption of the Annual Appropriation Ordinance of the City of Crooks, South Dakota, in October of 2013, it has been found necessary for the operation of the City of Crooks, South Dakota and the discharge of its lawful duties and the performance of its indispensable functions to provide additional funds for the FINANCE OFFICE DEPARTMENT, STREET DEPARTMENT, SPECIAL MAINTENANCE ASSESSMENT, COMMUNITY CENTER DEPARTMENT, COMMUNITY CENTER DEPARTMENT, SNOW REMOVAL DEPARTMENT & CODE ENFORCEMENT\SANITATION DEPARTMENT funds of the City of Crooks, South Dakota.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROOKS, SOUTH DAKOTA:

Section 1. There is hereby appropriated from General Funds of the City of Crooks, South Dakota, the sum of \$79,000 to the following departmental funds, in the following amounts, for the purpose of paying any lawful claim incurred by said departments for the remainder of the calendar year, 2014


