

ORDINANCE NO. 203

AN ORDINANCE OF THE CITY OF CROOKS, SOUTH DAKOTA, PROVIDING FOR A CHANGE OF THE WATER AND SEWER RATES WITHIN THE CITY OF CROOKS, EFFECTIVE JANUARY 1, 2016. BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROOKS, SOUTH DAKOTA.

Section 1. The following rates are hereby established for the water consumers and sewer users connected to the municipal water and sewer systems of the City effective for the Month of December 2016 and as implemented as noted in Section 2.

All water in excess of 20,000 gallons shall be at the rate of 4.25 per 1000 gallons. All sewer in excess of 20,000 gallons shall be at a rate of \$56.50 per month. The foregoing rates shall apply to locations within the city limits for water consumption and sewer usage for one (1) month period for single family residences and commercial usages.

Beginning January 1, 2017 and there after, the water and sewer rates shall be adjusted annually in conjunction with the State of South Dakota CPI.

Section 2. One third of the change from the current rates to the rates noted in Section 1 shall be effective beginning the month of January, 2016, an additional third shall become effective beginning the month of September 2016, and the final third and full change shall be effective the month of December 2016.

Section 3. That all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.
