

ORDINANCE NO. 34

AN ORDINANCE PROVIDING FOR A SUPPLEMENTAL APPROPRIATION IN THE AMOUNT OF \$1817.00 FROM MONIES IN THE GENERAL FUND AND FOR A TRANSFER IN THE AMOUNT OF \$475.00 FROM MONIES IN THE ELECTION FUND, ALL TO THE FOLLOWING DEPARTMENTAL FUNDS AS FOLLOWS: TO THE FINANCE OFFICE THE SUM OF \$130.00, TO THE GOVERNMENT BUILDING FUND THE SUM OF \$720.00, TO THE STREET LIGHTING FUND THE SUM OF \$25.00 AND TO THE PARK FUND THE SUM OF \$1417.00; FOR THE ROUTINE OPERATION OF THE CITY OF CROOKS FOR THE YEAR 1982; AND DECLARING AN EMERGENCY.

WHEREAS, since the adoption of the Annual Appropriation Ordinance of the City of Crooks, South Dakota in October of 1981, it has been found necessary for the operation of the City of Crooks, South Dakota, and the discharge of its lawful duties and the performance of its indispensable functions to provide additional funds for the Finance Office, the Government Building Fund, the Street Lighting Fund and the Park Fund of the City of Crooks, South Dakota.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROOKS, SOUTH DAKOTA:

Section 1. There is hereby appropriated from previously unappropriated funds in the General Fund of the City of Crooks, South Dakota, the sum of \$1817.00 and there is hereby transferred from previously appropriated funds in the Election Fund of said City, the sum of \$475.00, all to the following departmental funds, in the following amounts, for the purpose of paying any lawful claim incurred by said departments for the remainder of the calendar year, 1982:

Whereas this Ordinance is necessary for the immediate preservation of the public peace, health, safety and support of the municipal government of the City of Crooks, and its existing public institutions, an emergency is hereby declared to exist, and this Ordinance shall take effect upon the passage and publication hereof.
