

AN ORDINANCE PROVIDING FOR THE ANNUAL APPROPRIATION FOR THE CITY OF CROOKS, SOUTH DAKOTA, AND LEVYING THE ANNUAL TAX ON THE TAXABLE PROPERTY IN THE CITY OF CROOKS, SOUTH DAKOTA, FOR THE PURPOSE OF DEFRAYING THE EXPENSES AND LIABILITIES OF THE CITY OF CROOKS, SOUTH DAKOTA, FOR THE FISCAL YEAR, JANUARY 1, 1985, THROUGH DECEMBER 31, 1985.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CROOKS, SOUTH DAKOTA:

Section 1. That there be and hereby is appropriated by the Council of the City of Crooks, South Dakota, for the fiscal year January 1, 1985, through December 31, 1985, the following sums of money for the following purposes, to defray the necessary expenses and liabilities of the City of Crooks, South Dakota:
