

ORDINANCE NO. 102

AN ORDINANCE PROVIDING FOR A SUPPLEMENTAL APPROPRIATION IN THE SUM OF \$12,775.00 FROM REVENUE SHARING FUNDS TO THE FOLLOWING DEPARTMENTAL FUNDS IN THE FOLLOWING AMOUNTS: \$1550.00 COUNCIL/ \$800.00 ORDINANCES & RESOLUTIONS/ \$75.00 MAYOR/ \$950.00 FINANCE OFFICER/\$500.00 GOVT.BUILDINGS/\$1000.00 PLANNING AND ZONING/\$3400.00 PAVED STREETS/ \$3600.00 SNOW REMOVAL/\$100 ANIMAL CONTROL/\$800 PARKS FOR THE ROUTINE OPERATION OF THE CITY OF CROOKS FOR THE YEAR 1999; AND DECLARING AN EMERGENCY.

WHEREAS, since the adoption of the Annual Appropriation Ordinance of the City of Crooks, South Dakota, in September of 1998, it has been found necessary for the operation of the City of Crooks, South Dakota and the discharge of its lawful duties and the performance of its indispensable functions to provide additional funds for the COUNCIL, ORDINANCES & RESOLUTIONS, ELECTIONS, FINANCE OFFICER, PAVED STREETS, AND SNOW REMOVAL funds of the City of Crooks, South Dakota.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CROOKS, SOUTH DAKOTA:

Section 1. There is hereby appropriated from Revenue Sharing Funds of the City of Crooks, South Dakota, the sum of \$12775.00 to the following departmental funds, in the following amounts, for the purpose of paying any lawful claim incurred by said departments for the remainder of the calendar year, 1999.

Whereas this Ordinance is necessary for the immediate preservation of the public peace, health, safety and support of the municipal government of the City of Crooks, and its existing public institutions, an emergency is hereby declared to exist, and this Ordinance shall take effect upon the passage and publication hereof.
