# Proclamation Declaring the Month of September as Attendance Awareness Month

WHEREAS the Covid-19 pandemic and other crises have negatively impacted positive conditions for learning and created an absenteeism crisis,

WHEREAS families and parents are their child's first teacher and lay the foundation for the importance of school attendance,

WHEREAS promoting attendance requires noticing - as soon as possible - when students start to miss too much school, engage students and families, and identify needed support(s) and early intervention resources,

WHEREAS showing up for school is an opportunity for students to build routines that creates a sense of safety and belonging, increases engagement and develops trusting relationships with peers, teachers and school staff that increase engagement and motivate them to participate in learning,

WHEREAS taking a positive problem-solving approach to reducing absenteeism requires expanding data to include reviewing chronic absence and attendance data availability of working contact information for families, connectivity (devices and internet) and positive relationships,

WHEREAS improving attendance and reducing absenteeism takes schools, families and community partners working together to identify and address factors contributing to students missing school, particularly a lack of digital access, mental and physical health services and access to basic economic supports including food and housing,

WHEREAS partnering with students and families to monitor attendance as well as understand and address barriers to attendance requires building and sustaining caring relationships and regular communications in the home language spoken by families,

WHEREAS ensuring an equal opportunity to learn requires using data to detect high levels of absenteeism and missed opportunities to learn by school, grade, and student population,

**NOW, THEREFORE BE IT RESOLVED** that the City of Deming stands with the nation and Deming Public Schools in recognizing the month of September as "Attendance Awareness Month." We hereby commit to focusing on reducing absenteeism and addressing the factors that cause students to miss school in order to ensure all children an equitable opportunity to learn, grow and thrive academically, emotionally and socially. We recognize that we must work together to engage students and families and send the message that learning can and must continue.

Specifically, we will:

1. Affirm the importance of the family's role in ensuring their child shows up for school every day.

- 2. Make clear that improving student attendance, including taking daily attendance in a consistent manner and monitoring absenteeism, continues to be a top priority.
- 3. Engage students, families, educators, and the broader community including civic and elected leaders, local businesses, clergy members and nonprofit organizations in working together to identify and remove barriers to getting to school and develop meaningful solutions that ensure all children and youth keep learning despite the challenges of Covid-19.

The Annual Business Meeting will be conducted in accordance with Robert's Rules of Order Revised, and the Annual Business Meeting Rules and Procedures, which shall govern the actions and deliberations of the League membership assembled in convention. The Voting Delegate and Alternate must be persons planning to attend the Conference. ## 7. Public Hearing: To consider an ordinance Approving the Sale of Lot 35, in the Industrial Area

Mr. Sera explained that Ms. Ward had been working with the company to find a location which would fit the needs for their business.

Councilor Rodriguez asked what the Nacho company is. Mr. Sera stated that Nacho Investments, LLC is a building warehouser who will ship and store Frito Lay products and employ 4-5 employees. Mr. Sera added that the business will be located where the chili plant is to the west side on G Street.

Ms. Ward commented that they are pleased with Nacho Investments, LLC and adding a distributing facility for Frito Lay. She added that construction would begin once permits are obtained.

Mayor Jasso opened the public hearing for public comments.

Ms. Schiffner asked what the selling price was. Mr. Sera stated \$30,750. Ms. Schiffner stated the amount is cheap. Mr. Sera explained the City can only sell the property at the appraised value.

With no further comments, Mayor Jasso closed the public hearing and asked Council if they were prepared to make a motion.

## AN ORDINANCE APPROVING THE SALE OF REAL ESTATE OWNED BY THE CITY OF DEMING, NEW MEXICO TO NACHO INVESTMENTS, LLC.

WHEREAS, the City of Deming is proposing the sale of real estate, as described in Exhibit A, to Nacho Investments, LLC., whose address is 2590 E. State HWY 60, Loveland, Colorado 80537.

WHEREAS, Nacho Investments, LLC. has expressed interest in utilizing the lands described herein for developing a warehousing operation for the purpose of economic development.

WHEREAS, the City of Deming pursuant to section 3-54-1 and 3-17-3 NMSA 1978 Comp. has published a Notice of Proposed Ordinance Approving the Sale of Real Estate owned by the City of Deming.

#### NOW BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEMING, NEW MEXICO:

- 1. The City of Deming, New Mexico shall sell to Nacho Investments, LLC., certain real estate in Luna County, New Mexico described in Exhibit A, attached hereto by reference.
- 2. The purchaser has proposed to pay a total price of \$30,750.00 for 2.05 non-water righted acres, referred to as "Lot 35" with the legal description listed in (Exhibit A).
- 3. The appraised market value of the parcel is \$30,750.00.
- 4. The City of Deming's purpose in entering into this land sale with Nacho Investments, LLC is to stimulate economic activity, facilitate investment in our community, enhance the local government tax base, and add employment to our area.
- 5. The approval of this sale may be subject to a referendum pursuant to Section 3-54-1D, NMSA 1978. This ordinance shall become effective forty-five days after its adoption unless a referendum election is held pursuant to Section 3-54-1(H) NMSA 1978 Comp.
