

ORDINANCE NO. 1328

**AN ORDINANCE AMENDING TITLE 8, CHAPTER 2 PARKS AND RECREATION AREAS,
WITH THE ADDITION OF ARTICLE 6, PERU MILL LAW ENFORCEMENT TRAINING
FACILITY, OF THE MUNICIPAL CODE OF THE CITY OF DEMING, NEW MEXICO**

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEMING, NEW MEXICO:

Title, 8, Chapter 2, shall be amended with the addition, as follows:

Article 6 PERU MILL LAW ENFORCEMENT TRAINING FACILITY

A. The Purpose and Scope: To provide a safe and stable location for law enforcement and the general public to practice shooting in a structured environment.

B. OPERATING POLICY:

1. Public Hours of Operation will be set from Friday to Sunday beginning at sunrise and ending at sunset unless times have been reserved by shooting organizations.

a. Shooting Organizations must apply for exclusive reservation(s), three weeks in advance.

2. Defined area for the use of Law Enforcement will not allow member access.

C. Rules and Regulations: Established for the health and well-being of the citizens of Deming and Luna County, that use the facility.

1. Access to Range: Access is by membership only. Membership is only considered for applicants ages 18 years and older, unless associated with a youth shooting organization.

a. Membership(s) shall be established by personally appearing to complete membership application at City Offices, at the hour determined by city management. Each adult member must accompany one minor, unless membership ID Card identifies otherwise. Membership will be terminated upon violation to range rules.

b. Membership(s) do not allow the access to have pets on the range, excluding service animals as identified on membership ID Card. Service animals must be restrained at all times.

c. Non-members entering the range without being accompanied by a member will be trespassed and may be fined according to the penalties specified within this section.

2. Approved Targets: Paper or cardboard targets that will attach to frames on site.

3. Prohibited items: tracer rounds; exploding targets, ground level targets; household items and appliances; fully automatic weapons, including slide fire stocks; alcohol; drugs including cannabis. There will be no ground targets or silhouettes permitted.



D. Penalty: Any person who violates any of the provisions of this section will have privileges suspended and be assessed a fine of five hundred dollars (\$500.00) or imprisonment for not more than ninety (90) days or both.
