The DuPage County Community Development Commission hereby announces the availability of funding and the application process for the 2023 and 2024 program years.

Request for applications from Agencies for CDBG Public Services is limited to salary and benefits for programs providing emergency shelter; legal assistance to support the homeless or those at risk of homelessness; financial resources to homeless or those at risk of homelessness; foreclosure prevention; or support for Tenant-Based Rental Assistance (TBRA) administration for homeless and those at risk of homelessness.

Request for applications from Agencies for ESG is limited to Homelessness Prevention, Emergency Shelter, Street Outreach, and Homeless Management Information System (HMIS).

Applicants must complete each of the following steps:

- 1) Attend the Pre-Application Mandatory virtual meeting on **August 10, 2022**, through Zoom.

After registering, you will receive a confirmation email containing information about joining the meeting.

Agencies who do not have at least one representative attending the mandatory meeting will not be eligible to submit an application.

- 2) Submit a Letter of Intent through the on-line application process. The letter must be submitted by 4:30pm on **August 19, 2022**. Any agency that does not submit a Letter of Intent by the required date and time will be disqualified from the application process.
- 3) Participate in a public hearing to explain their project to interested stakeholders. This can be a group public hearing with other agencies, or a public hearing held individually by the applicant. Published notice of the public hearing must be done at least ten (10) calendar days prior to the public hearing and the hearing must be accessible to those with physical or language barriers. A sample public hearing notice will be provided at the mandatory meeting.

- 5) Submit an Application through the on-line application process. The Application must be submitted by 4:30pm on **September 26, 2022**. Any agency that does not submit the Application by the required date and time will be disqualified from the application process.
