GUIDE TO THE TRANSPORTATION IMPROVEMENT PROGRAM

The DuPage County Division of Transportation (DuDOT) Fiscal Year 2024-2028 Transportation Improvement Program (Program) is intended as a short-term prospectus on DuPage County DOT revenues and major capital expenditures. This Program is not intended as a budget document and does not include personnel, operating, contractual, and equipment costs.

The Program reflects capital and capital maintenance projects that are anticipated to be active during the five years of the Program. Projects that are included in the Program list may be single-year, multi-year or recurring annual projects. The individual project summaries reflect a variety of pieces of information including:

- Project location and limits
- Section number and Activity code (project identifiers)
- CMAP TIP reference
- Project Type
- Leading and Letting Agencies
- Year of Project Letting
- County Board Districts
- Municipalities
- Project Partnerships
- Congressional Districts
- Project Description
- Project Cost by phase of Project
- Project Funding and Allocation of funds by fund source

Projects that have been recently completed where the County is awaiting final invoicing from the State or other agency are included in the project summaries as evidence of County obligation and level of commitment.

PROJECT TYPE

The Long Range Transportation Plan (Plan) identified a number of categories or types of projects to track related to the goals expressed in that Plan. Key project types include:

- Facilities
- Maintenance
- Mobility
- Operations
- Safety
- State of Good Repair
- Sustainability & Resilience
- System Enhancement
- System Expansion

Facilities refers to the construction or reconstruction of highway facilities such as garages, offices, and material storage, necessary for accomplishing the mission of the DOT..

Mobility projects include a variety of bicycle and pedestrian improvements from trail construction or extensions, sidewalks, and multi-use path construction or paving.

Operations refers to traffic signal and system operations. Projects that are found under this category might include signal modernization, signal interconnections, remote communications, and lighting.

Safety projects encompass a wide variety of improvements from installation of crosswalks, signage, medians, guardrails and other protective barriers or appurtenances. Safety projects also include intersection improvements that provide channelization, signal modernization and signal operation and phasing changes.

State of Good Repair is the category that reflects improvements that extend the useful service life of DOT assets including roadways, bridges, signals. Typical projects include pavement preservation (patching, crack sealing), resurfacing, bridge repairs, and signal modernization.

Sustainability and Resilience is a category that reflects improvements intended to reduce emissions and pollutants and to ensure our infrastructure is resilient to the effects of climate change. Typical projects include those that reduce congestion, provide mode choices and address recurrent flooding impacts caused by flooding.

System Enhancement represents projects that enhance the performance of our transportation network including intersection improvements, widening, signal interconnects, and trail, path and sidewalk connections.

System Expansion includes adding lanes to roadways, extended roadways or trail systems, grade separations and new roadway alignments.

The Plan summaries also indicate project subtypes and activities that elaborate on the type of work being performed with each project.

PROJECT PHASE

Two tables are included in the project summary sheets: the Project Cost by Phase Table and the Project Funding by Source Table.

It is our objective to demonstrate a) the present status of the project in terms of project readiness or project schedule, and b) the sources of funding that will be used to pay for the project.

Project phase refers to the stages typical of a project from feasibility study to through construction. The phases (and abbreviations) that are found in the document include:

- **FEAS_PLAN** –Feasibility studies are usually performed when the scope of a project, limits, support, or cost magnitude is unknown.
- **E1** – Preliminary Engineering or Environmental Engineering phase where existing conditions and environmental constraints of a project are examined, preliminary geometry and scope defined, public and stakeholder engagement to ensure project support is undertaken and property acquisition determined ahead of design work.

- **E2** – Design engineering phase and includes the preparation of detailed improvement plans, , specifications, estimates of cost and schedule, local, utility and railroad coordination and agreement preparation, and permitting.
- **LA** – Land Acquisition phase involves the procedures necessary to secure needed property interests for a project. Scope includes title services, preparation of plats and legal descriptions, appraisals, right of way negotiation, and right of way and easement acquisition.
- **E3** – Construction Engineering includes oversight, inspection, documentation, insurance the contractor adheres to the contract plans and specifications and materials testing of construction projects.
- **C** – Construction includes the actual construction phase of a project through a contract awarded to a contractor. C is used when DOT is the letting and contracting authority.
- **PA** – refers to Participation. Use of the Participation phase code means that either the County or some other agency is participating in the cost of a project but is not the contract awarding agency. This designation is most often used when DOT is matching federal funds that have been awarded the project.
- **M** – refers to a project that is considered as capital maintenance activity. An example of this will be our annual pavement maintenance contracts where highways are being resurfaced as part of a State of Good Repair project.

For each project, the table will show the phases that are anticipated to be active during the Program. As projects advance, phases will appear or disappear from the table. Please note that not all projects will have all phases active during this Program and it is common to see phases extend over multiple fiscal years.

It should be noted that many of the phase costs in the tables are engineering estimates. Estimates are derived from the scope of the project generated in E1 or E2 of the project. Construction cost estimates that are 3-5 years out in the schedule are estimates and will change and be refined over the duration of the project as the details of the project and market conditions emerge and construction schedule is established.

PROJECT FUNDING

In the Project Funding by Source Table, DOT references the known project funding sources as of the time of the publication of the Program. It is not uncommon that new or revised funding sources will occur as a result of grant awards, changes in revenue forecasts, or new partnerships as a project progresses.

Program funding source definitions:

- **County Local Gas Tax:** local option motor fuel tax imposed by DuPage County..
- **County Motor Fuel Tax:** County share of the motor fuel taxes collected by the State and distributed by formula.

- **County Motor Fuel Tax Bond:** County share of proceeds of bonds sold by the State on behalf of local agencies as authorized by under the State’s Rebuild Illinois Capital program.
- **County Impact Fee:** funds from the impact fee program can be used on capital projects only and expenditures are limited to projects qualified under the Comprehensive Road Improvement Plan. Funds can only be expended in the fee district in which they were collected.
- **Federal STP:** Federal Surface Transportation Program funds administered by the DuPage Mayors and Managers Conference. Projects awarded these funds require a local match.
- **Federal CMAQ:** Congestion Mitigation Air Quality federal funds are competitive awards granted by the Chicago Metropolitan Agency for Planning (CMAP) to projects that reduce congestion and carbon emissions. Projects awarded these funds require a 20% local match.
- **Federal HSIP:** Highway Safety Improvement Program are competitive awards for projects that improve safety and administered by the State of Illinois. Projects awarded these funds require a 10% local match.
- **ICC GCPF:** Illinois Commerce Commission Grade Crossing Protection Fund. This funding source generally pertains when DOT is working to improve a highway or pedestrian rail crossing, when crossing gates or grade separation designs are components of a project.
- **Participation:** Local, Tollway and IDOT agreements that stipulate cost participation in DOT projects for improvements to assets under their jurisdiction.

Multiple funding sources are often used throughout the life cycle of a project. Funding sequencing is often complex in multi-year projects and DOT endeavors to represent the amount of each fund anticipated to be used in each year. When project delays occur, DOT will attempt to update the TIP in the succeeding annual program.

Both tables shown in the project summaries include an MYB column. This column represents project phases beyond the Program 5-year term MYB total costs are listed for information only and are not part of the five-year TIP rollup statistics or totals.

FISCAL YEAR 2024-2028 PROGRAM

The DuPage County Division of Transportation is responsible for 220 miles of highway (with approximately 970 lane-miles of pavement), 250 miles of sidewalk and bike path, 55 miles of multi-purpose trail, 343 traffic signals (with more than 80% of signals in coordinated systems), and 50 bridges. Numerous other assets such as guardrail, retaining wall, detention basins, lighting and landscaping are part of this program as well.

The typical county highway is a 4/5 lane pavement, generally has enclosed drainage and is usually accompanied by sidewalk or path within rights of way ranging from 66 to 200 feet in width. The typical county highway carries between 20 and 25,000 vehicles per day, about 5% of which are commercial vehicles. The trail system is unpaved except in locations approaching streets and highways. The DOT maintains 11 pedestrian bridges which cross high-volume road or rail corridors.

The Division of Transportation does not own, operate, or maintain any transit, ride-hailing, para-transit or similar services and, therefore, transit projects will not be found in this program. DuPage County is supportive of Pace and Metra services and will often cooperate with these agencies regarding specific infrastructure projects.



2024-2028 PROGRAM DETAILS

The program features 98 projects including the following breakdown of project types:


The majority of the capital projects included in the TIP are tied to State of Good Repair, System Enhancement and Mobility. Very few projects in the five-year program (2) are considered System Expansion. Please note that while there are eight (8) projects called out as “Safety” projects, all DuDOT projects include some element of safety.

Likewise, many of the capital roadway, intersection and operations projects include construction of accommodations that are compliant with the Americans with Disability Act regulations on sidewalks, path, and curb ramps.

Professional service projects (e.g., Various – Bridge Design) are included because they directly support the capital improvement program and are often employed in the project development process.

Figure 1 below demonstrates the breadth of the DuDOT program. State of Good Repair is again at the forefront of the County’s mission in this five-year program. However, Mobility, Operations and Sustainability projects continue to grow in number and importance as DuDOT transitions away from a capacity-driven program. This program includes over 50 million in funding for the new DuDOT office and maintenance building.

Figure 1 - FY24-28 TIP Investment by Project Type



The ninety-eight (98) projects in the program have a projected cost of over \$327 million. More than half of the program (58 percent or almost 190 million) is related to construction or participation in construction activities. Participation can include reimbursements for engineering services or for construction. Table 2 describes the cost allocation by project phase across the program.

Engineering costs represent a little under 20% of the overall program. For most capital projects, Planning, Preliminary Engineering, Design and Construction engineering often constitute 30% of the overall project costs.

Maintenance activities such as pavement maintenance and electrical and lighting maintenance represent almost one quarter of the overall program. These two programs are extremely important to the safety and efficiency of the highway system.

The estimated capital expenditures by year is shown below in Table 3:



MYB represents projects that may become active in the five-year program as funding becomes available. The annual program averages a little more than \$65 million per year. Many of the projects in the capital program are multi-year, are annual or biennial in nature. The typical DuDOT capital project will have four or five stages including engineering, land acquisition, construction and maintenance.

PROGRAM FUNDING

DuDOT has a variety of revenue sources that contribute to the delivery of the projects in the program. Eleven (11) sources are utilized (see Figure 3 below). Overwhelmingly, DuDOT expects to utilize County Option Local Gas Tax, County Motor Fuel Tax and Motor Fuel Tax Bond proceeds. However, more than \$31 million in federal funds are projected to be included in paying for projects in the program. Federal funding represents about 9.5% of the County’s capital program.

Revenue for County Option Local Gas Tax and County Motor Fuel Tax is approximately \$60 million annually. This is currently supplemented by State of Illinois Rebuild Illinois MFT Bonds, which were made available to select projects through the State’s 2019 Capital Bill. DuDOT also has residual funds available through the County Impact Fee program. These funds are limited to use within specific districts and for projects that add capacity to the county network.

GEOGRAPHIC DISTRIBUTION OF PROJECTS





Figure 5 – Capital Projects by Congressional District

DuDOT reports where the locations of the projects are specifically (as shown in the maps) and by county board and congressional districts. Figures 4 and 5 indicate the concentration of projects in the board and congressional districts. Please note that many DuDOT projects cross political and municipal lines and are difficult to classify as exclusive to one district. Most of the “various” projects contain work that is done throughout the county with a great likelihood that most districts will benefit from work in that contract. Those projects are reflected in the “ALL” district category.

Figure 4 – Capital Projects by County Board District
