Planning/Engineering Review Fees for Site Plan Approval

In addition to the above fees, a cash deposit of One Thousand Dollars (\$1,000) shall be placed with the City of Durand. All fees, as determined by agreement with the City's planning and/or

engineering consulting firm or other fees as adopted by the City of Durand may be deducted at a rate of 112% by the City and the balance remitted to the depositor. Any fees in excess of the deposits shall be paid, in full, immediately to the City of Durand by the owner and/or agent. The City may withhold all approvals until receipt of such payment. A schedule of current consultant fees is included with this packet.

2023 Development Review Fee Schedule for City of Durand, Shiawassee County, Michigan

The following Development Review Fee Schedule is to be employed for estimating the consultant's costs for undertaking a professional planning review and preparing a written report to the community regarding the various types of development proposals. These costs may be passed through to the developer, along with any additional costs (publication, reviews by others, etc.), incurred by the community.

The developer's deposit, in an amount determined from this review fee schedule, is collected by the community prior to forwarding the plans to Wade Trim for review. Development review costs may vary depending on the completeness and complexity of the application.

1. Subdivision (Plat) Review (for Conventional, Manufactured Home, Commercial or Industrial Subdivision)

a. Pre-Preliminary plat review \$500

b. Preliminary plat review

1) Tentative approval \$750 plus \$5 per lot

2) Final approval \$250 plus \$2.50 per lot

2. Site Plan Reviews

a. Detached single-family
