V. APPOINTMENTS

A) POLICE DEPARTMENT

Supervisor Anthony Colavita offered a motion that was seconded by Councilman Joseph Dooley to approve a RESOLUTION authorizing the probationary appointment of Elizabeth Vuksanaj, Scarsdale, NY to the position of Police Officer. Ms. Vuksanaj is currently employed as a Police Officer in the City of White Plains.

The appointment is contingent upon receipt of final approval from Westchester County Dept. of Personnel of the transfer and her pending successful completion of her medical and background requirements. As provided in the Westchester County Civil Service rules it is necessary for her to serve a probationary period of a minimum of twelve weeks to a maximum of fifty-two weeks.

The appointment would be effective May 12, 2023 at a salary of:

On the roll call, all voted "AYE," except Councilwoman Nicholson, who was "ABSENT." Motion carried.

B) BUILDING INSPECTOR

Councilwoman Sheila Marcotte offered a motion that was seconded by Councilman Joseph Dooley to approve a RESOLUTION authorizing the probationary appointment of Carlo Valente of Hawthorne, NY to the position of Building Inspector. Carlo has been with the Town since 2021 as Asst. Building Inspector.

Carlo has successfully passed the civil service exam and his name appears on the Westchester County Civil Service List #68-098.

If approved, the appointment will be effective May 5, 2023, at the annual rate of \$130,000.

The probationary period will not run less than twelve weeks and not more than fifty-two weeks. Funds have been provided in the 2023 budget.

On the roll call, all voted "AYE," except Councilwoman Nicholson, who was "ABSENT." Motion carried.

C) ASSISTANT BUILDING INSPECTOR

Councilman Luigi Marcoccia offered a motion that was seconded by Councilman Joseph Dooley to approve a RESOLUTION authorizing the probationary appointment of Justin Hoyt of Tarrytown, NY to the position of Asst. Building Inspector. Justin holds permanent status as Asst. Building Inspector with the Village of Hasting-on- Hudson.

Justin will be appointed with the approval of Westchester County Civil Service Rules with regard to transfers. The appointment is contingent on the successful completion of the background investigation and pre-employment testing.

He will be required to serve a probation period of not less than twelve weeks and not more than fifty-two weeks.

If approved his starting date will be May 15, 2023 at the annual salary of \$85,236.

Funds are provided in the 2023 budget.

On the roll call, all voted "AYE," except Councilwoman Nicholson, who was "ABSENT." Motion carried.

D) DEPUTY TOWN COMPTROLLER

Councilwoman Sheila Marcotte offered a motion that was seconded by Councilman Luigi Marcoccia to approve a RESOLUTION authorizing the probationary appointment of Bing Morris of Larchmont, NY to the position of Deputy Town Comptroller.

Bing has successfully passed the civil service exam and her name appears on the Westchester County Civil Service List #69-080.

If approved, the appointment will be effective May 19, 2023, at the annual rate of \$98,000.

The probationary period will not run less than twelve weeks and not more than fifty-two weeks. Funds have been provided in the 2023 budget.

On the roll call, all voted "AYE," except Councilwoman Nicholson, who was "ABSENT." Motion carried.

E) SR. RECREATION LEADER

Supervisor Anthony Colavita offered a motion that was seconded by Councilman Joseph Dooley to approve a RESOLUTION authorizing the provisional appointment of Jamie Corradina of Dobbs Ferry, New York to the position of Sr. Recreation Leader. Ms. Corradina has been with the Town since 2019. She understands that she must successfully complete the civil service exam for this position when given.

If approved, the appointment will be effective May 12, 2023 at the annual salary of \$71,181.00 and an annual stipend of \$5,000.00.

On the roll call, all voted "AYE," except Councilwoman Nicholson, who was "ABSENT." Motion carried.

F) COMMUNITY LIAISON

Supervisor Anthony Colavita offered a motion that was seconded by Councilman Joseph Dooley to approve a RESOLUTION authorizing the probationary appointment of Patricia George of Tuckahoe, NY to the position of Community Liaison. She has successfully completed the examination and her name appears on the Westchester County Civil Service list # 68-481.

Patricia is currently in this position as a provisional appointment. She will be required to serve a probation period of not less than twelve weeks and not more than fifty-two weeks.

If approved her probationary appointment will be effective on May 3, 2023 and her salary will remain at \$2,000.00.

X. COUNCIL MEMBER REPORTS

Councilman Marcoccia announced that both the outdoor tennis courts and pool seasons begin on Saturday, May 27th. The membership office hours are from 9:00am to 5:00pm on weekdays, and from 10am to 4pm on weekends. Councilman Marcoccia noted that Lake Isle is hosting the American Cancer Society's fundraiser again on Saturday, May 13th, and stated the next Lake Isle Advisory Board meeting is scheduled for Wednesday, May 3.

Councilman Dooley invited residents to attend the Memorial Day Ceremony Tribute to the 70th Anniversary of the Korean War Armistice to be held at the Eastchester HS Auditorium on Thursday May 18th. Doors open at 6:30 and the program begins at 7:00. The Ceremony will also recognize the 50th Anniversary of the End of the Vietnam War and the 20th Anniversary of the Operation Iraqi Freedom. Councilman Dooley stated the Memorial Day Parade on Monday, May 29th will Assemble at the Eastchester Library Lower Parking Lot at 10:00 am, with the kick-off at 11:00 am, and will be led by *Grand Marshals, Korean Veterans, Anthony Rabasco and Edward Stowe*. The parade route will proceed south on White Plains Road to Main Street through Waverly Square and continue down Main Street to the Depot Square ending at the WWII Monument and the Tuckahoe Train Station. A brief Ceremony will be conducted at the conclusion of the parade.

Councilwoman Marcotte invited all to attend Bronxville's 101st Memorial Parade to be held on Monday, May 29th. The parade kicks off at 9:00am at Leonard Morange Square and ends at the Bronxville School. Following the parade there are services at the school with a concluding ceremony to be held at the cemetery.

Councilwoman Marcotte thanked Tracy Wright, Eastchester Library Director, and her staff for hosting the Historical Society this past Sunday, where they gave a presentation on Route 22 and the changing landscapes.

Supervisor Colavita stated the housing compact was removed from the governor and state legislature's budget. The Supervisor stated that, in his opinion, it was an ill-conceived, unconstitutional, meritless, ridiculous idea and got many excited about the destruction of suburban New York State. The Supervisor stated that fortunately our Assemblywoman Paulin, State Senator Mayer, Mayor Marvin of Bronxville and Mayor Andino of Tuckahoe were also strongly against this.
