## 1.0 INTRODUCTION

#### 1.1 PURPOSE

The Eastchester Comprehensive Plan has been produced to illustrate Eastchester's future vision. The document is a policy oriented, long range guide to the future physical development of the community. The Plan includes a survey and detailed analysis of existing conditions, a statement of goals, and a set of recommendations for implementing these goals. Additionally, the Comprehensive Plan identifies those assets and resources the town collectively values most.

The Plan is constructed upon the recognition of Eastchester as a mature community. The primary aim of the document is to preserve and enhance the predominantly residential of the community, while concurrently strengthening the town's commercial areas.

## 1.2 PLANNING PROCESS

Prior to the development of this Plan, Eastchester was one of the last two communities in Westchester County to prepare a Master Plan or Comprehensive Plan (the two terms are generally synonymous). Elmsford, the other community is also currently in the process of developing a Comprehensive Plan.

In 1991, the Eastchester Planning Board recognized the importance of developing a Master Plan. A Master Plan Sub-Committee was established, and the foundation for the eventual preparation of the Plan was laid. These efforts continued until 1993, when the Master Plan Sub-Committee solicited professional planning support in preparing the Master Plan. In 1994, Cleary Consulting was retained to produce the Plan.

The public participation element of the Plan preparation process commenced in the spring of 1994 with a public "visioning session". A common theme shared by many residents was a distinct identification with their own separate

individual neighborhood, and not with the town as a whole. Consequently, planning for Eastchester as a community of neighborhoods became a fundamental underpinning of the Comprehensive Plan.

It must be emphasized that this Comprehensive Plan document is only one portion of an ongoing and continuous planning *process*. A steady stream of constantly changing influences affecting the town requires a certain vigilance in implementing the Comprehensive Plan. The Plan is not designed to be a static document, but rather a dynamic policy instrument that is periodically reviewed and revised to more perfectly embrace changing circumstances.

## 1.3 THE COMPREHENSIVE PLAN

The recently revised state law defines a comprehensive plan as: "the written and graphic materials identifying the goals, objectives, principles, and policies for the immediate and long-range protection, enhancement and growth of a municipality."

The Eastchester Comprehensive Plan has been designed to fully address these requirements while simultaneously meet the uniquely defined needs of the community.

The first section of the plan (Chapters 2-10) provides a detailed survey and analysis of the existing conditions of the community in the following areas:

- -Regional Context
- -Zoning & Land Use
- -Environment
- -Transportation
- -Housing & Population
- -Historical & Cultural Resources
- -Economy
- -Community Services
- -Parks, Recreation & Open Space

At the conclusion of each of these chapters, a series of policies (goals) are established. These policies reflect

The land use map is a graphic representation of the town's vision important planning concepts.

The second element of the plan concentrates on the strongly defined neighborhood character of the community. This portion addresses each of the 19 residential neighborhoods, identifies the assets of each, and then goes on to provide a series of planning goals.

The final major element of the Comprehensive Plan illustrates possible ways by which the policies and goals defined within the plan can be implemented. This section not only defines what must be done to accomplish each task, but who is responsible for undertaking the task, its priority, timing, start-up cost and operational costs.

A primary component of the final element is the land use plan as defined on the land use map. This map graphically represents the anticipated future land use of the community. This is where the community's *vision* is established.
