A fully enclosed structure for sale of goods at retail, or performance of customary personal services, but no fabrication, manufacturing, converting, altering, finishing or assembly except incidental to such retail sale, and not offensive, obnoxious or detrimental to the neighborhood by reason of vibration, dust, smoke, fumes, noise or odor shall be permitted. 2. Open Retail Business O.R.B.	1. A one-family dwelling as permitted and regulated in the R5 District. 2. Any principal use as permitted and regulated in the M700 District, except that in an O.R.B. District front and rear yards shall not be less than 50 feet each and height shall not exceed 3 stories or 35 feet, whichever is less. 3. A fully enclosed structure for sale of goods at retail or performance of customary personal service or services, as permitted and regulated in the D.S.C. District. 4. Business, banking or professional office or studio. 5. Theater, motion picture theater.	1. Any accessory use permitted in an R5 or D.S.C. District, provided it is wholly within the walls of the principal building. 2. Signs and offstreet parking and loading space subject to limitations stated in D.S.C. 3. Accessory to a motor vehicle sales agency as the principal permitted use, a garage for the storage and servicing of motor vehicles provided it be within the principal building.	1. Retail Business R.B.	6. The operation or conducting hereafter the business of a hand laundry, laundromat or laundrette, dry cleaning establishment, job printing, coin operated or otherwise operated, providing at least one employee is in continuous attendance on premises during the hours said business is open and providing dry cleaning machinery or equipment shall be prohibited in Residential or Multifamily Dwellings in such business districts. 7. Separate dwelling space above any authorized use, if separated therefrom by unpierced fire walls and ceilings, and provided with a separate entrance for each 3000 square feet of lot area. 8. Mortuary or funeral homes, except in multifamily dwellings or in mixed occupancy buildings. 9. Type II or Type III Food Service Establishment (if 1800 gross square feet or less)		
General Business G.B.	1. Any principal use, except restaurant or cafeteria, permitted and regulated in the R.B. District, except that maximum height shall be three stories or 35 feet, whichever is less 2. Motor vehicle sales agency, provided all cars are stored within a fully enclosed building. 3. Gas station. 4. Wholesale business, including storage of building materials, cold storage plant, or ice plant, but only within a completely enclosed building. 5. Greenhouse and the raising and selling of nursery products except same shall not be offensive, obnoxious or detrimental to the neighborhood by reason of dust, smoke, noise or odor.	1. Any accessory use permitted and regulated in an R.B. District and subject to the same conditions.	1. Same as 1, 2, 3, 4, 5, 6, 7, 9, 10, 11 in D.S.C. 2. Veterinary Hospital 3.
