BLOCK PARTY REQUIREMENTS

- Signed Petition delivered/emailed/faxed to the Police Department indicating approval of the majority of the neighbors on the street. This petition should be received by the PD at least 10 days prior.
- Removable barricades are to be placed at the ends of each roadway
- Barricades to be placed & removed by organizer(s)-no later than dusk
- Designate someone to move barricades in the event of an emergency
- No Inflatable devices in roadway, ie: jumping castles, etc
- No games requiring mounted fixtures that may obstruct roadway
- Keep all Fire Hydrants Clear – at least 15' on each side
- Grills & stoves are to be kept to the extreme side of the roadway
- Fire Extinguishers available near-by all grills and stoves
- No private driveways or walkways are to be blocked
- No live music or bands and no loud amplification (NO DJS)
- No admission charge of fees may be charged
- No gambling or games of chance
- All garbage to be placed in garbage bags at curb
- All recyclables to be placed in proper containers
- No flyers or ads to be attached to trees or telephone poles
- All Block Parties to end at dusk/dark
- At least two emergency contacts must be provided to the PD
- Block party application to be completed and submitted to the PD

- All block parties are subject to the approval of the Police Department and such approval may be revoked at any time, including terminating and ongoing party, due to violation of any of the above terms.
