**2021 – 2022  
REQUEST FOR 2AM – 6AM PARKING EXEMPTION**

In accordance with The Town of Eastchester's Vehicle & Traffic Law Section 3-15, the parking of vehicles is prohibited on all streets within the incorporated area of the Town of Eastchester between the hours of 2AM and 6AM from December 1<sup>st</sup> thru March 15<sup>th</sup> except for certain streets, parts of streets, residents that have proven a hardship case (no driveway/steep incline) or for handicapped reasons.

**Simply owning too many cars for your driveway and not wanting to "shuffle" cars is NOT a hardship case and will NOT be considered for an exemption from the law.**

If you feel you have a special hardship then please complete this form and return it either in person, by mail, fax (914) 222-6261 or email as soon as possible to ([PDtraffic@eastchester.org](mailto:PDtraffic@eastchester.org)). If approved, your exempt sticker will be sent via mail. **Stickers MUST be affixed to the driver's side rear window of your vehicle.**

Overnight guests, holiday guests, or college students home for a short time do **NOT** need a permit and may be exempted by calling each night to the police desk parking mailbox: 961-3464 (Option #2).

**By submitting this application and signing below, the vehicle owner acknowledges that they are responsible to abide by the following parking rules and regulations:**

- 1) A MAXIMUM OF ONE (1) PERMIT ONLY WILL BE ISSUED PER HOUSEHOLD.**
- 2) NO EXEMPTIONS WILL BE TAKEN DURING FORECASTED SNOWFALLS, INCLEMENT WEATHER, OR POTENTIALLY HAZARDOUS PRECIPITATION THAT REQUIRES THE HIGHWAY DEPARTMENT TO CLEAR, SALT, OR SAND THE ROADWAY.**

**ALL CARS WITH OR WITHOUT A PERMIT MUST BE OFF THE STREET.**

- 3) NO NOTIFICATIONS TO REMOVE THE VEHICLES FROM THE ROAD WILL BE MADE. IT IS THE VEHICLE OWNERS RESPONSIBILITY TO MONITOR THE WEATHER CONDITIONS AND REMOVE THE VEHICLE FROM THE ROADWAY IF NECESSARY.**
- 4) A 2AM-6AM EXEMPTION DOES NOT EXEMPT YOU FROM OUR 72 HOUR RULE NOR DOES IT PERMIT YOU TO PARK IN VIOLATION OF POSTED SIGNS/HYDRANTS, ETC**

Should your exemption be granted, keep in mind it would be **ONLY** for December 1, 2020 thru March 15, 2021 and not annually. **All exemptions are vehicle specific and not transferrable.** Make sure to provide your email address for future speedy communications. Substitute vehicles **MUST** be called in to the police desk parking mailbox as above or they will subject to a summons.
