The meeting was called to order by Mayor John Joyce at 7:30pm.

Citizens' Comments:

Kimberly Kleeves: Ms. Kleeves stated that there has been no resolution regarding the matter of an outstanding high-water bill. She wrote a letter to council and was told the issue would be addressed at this meeting but does not see it on the agenda. She has a meeting scheduled tomorrow to get her meter checked and wondered why this was not done immediately after the matter was brought to the city's attention.

J. Request to accept Water Meter Replacement Proposal from SLC Meter, LLC. Mr. Wilson advised council that he, Ms. Dvoracek and Lead Water Operator Patrick Muczynski had met with the two water meter finalists following their presentations at the October 19, 2020 council meeting. They went over each proposal point by point with both finalists and all agree that the SLC proposal is superior. They also reached out to municipalities that are currently working with SLC and received very favorable recommendations.

Motion by Mr. Elliott to accept the Water Meter Proposal from SLC Meters, LLC. Support by Mr. Carlson. Motion passed on a roll call vote; all were in favor.

K. Request to accept Utility Rate Study Proposal from Baker and Tilly

Ms. Dvoracek believes that the City is favorably positioned to move forward with this study and believes that it is a critical component of the Capital Improvement Plan. Mayor Joyce pointed out that this issue has been under discussion for a long time. Mr. Hildebrand is confident that council has done their due diligence.

Motion by Mr. Hildebrand to move ahead with the Utility Rate Study Proposal presented by Baker & Tilly. Support by Ms. Szeliga. Motion passed with a roll call vote; all were in favor.

L. Resolution 2020-20 Approving Policies and Procedures for Virtual and Hybrid Meetings per Public Act 228

Ms. Dvoracek advised council that due to the recent Supreme Court ruling regarding Governor Whitmer's emergency powers, it is necessary to update the city policy regarding virtual meetings. Mark Watkins, County Emergency Manager, is recommending that all bodies meet virtually and has ordered all businesses to have employees work remotely whenever possible. Motion by Mayor Joyce to adopt Resolution 2020-20. Support by Ms. Szeliga. Motion passed with a roll call vote; all were in favor.
