### **Unfinished Business**

D. Request for Traffic Study Engineering Services – School Zone Safety Review

Mr. Wilson reported having several in depth conversations with an engineer who specializes in the traffic studies and his recommendation was to meet with school officials to seek solutions before committing to a traffic study. Accordingly, Mr. Wilson and Chief Beam met with school superintendent, middle school principal, and the school transportation supervisor. They

suggested several changes in school drop off and pick up procedures, as well as measures the City could take to improve awareness of the school zone at the middle school.

Motion by Mr. Carlson to approve the measures as proposed by Mr. Wilson but to upgrade to thermoplastic paint for the street crossings, not to exceed \$8,000. Support by Mr. Elliott.

### **Budget Amendments**

Both apply to work done at the airport and are a matter of moving funds from one account to the other to follow best practices and avoid having line items with a negative balance.

Motion by Ms. Szeliga to approve the budget amendments in the amount of \$3300. as presented. Support by Mr. Carlson.

F. 2020 Tax Foreclosures from Osceola County Treasurer (will email Friday 7/24/2020)

There are three residential properties in Evart under foreclosure by Osceola County. Two have buildings that will need to be demolished. Ms. Dvoracek recommends not exercising the City's option to purchase at the first auction. She has requested that the County Treasurer put a clause on these sales requiring that if purchased, the buildings must be demolished within 30 days. If the properties do not sell, council can bid at the second auction.

Motion by Mayor Joyce to authorize Ms. Dvoracek to refuse the first option to bid on the three properties with the understanding that if the properties do sell at auction, there will be a clause attached requiring demolition of the buildings within 30 days. Support by Mr. Hildebrand.

G. Renewal of Downtown Development Authority Board Members – Bengry and Cataldo

Ms. Dvoracek and council members spoke highly of Mr. Bengry and Ms. Cataldo and were appreciative of their efforts and commitment to the DDA Board.

Motion by Mr. Elliott to approve the reappointment of Mr. Alan Bengry and Ms. Molly Cataldo to the Downtown Development Authority Board of Directors for four-year terms. Support by Hildebrand.

# H. Republic Services Contract with Amendment

Ms. Dvoracek asked council to approve a five-year contract extension with Republic Services which would include \$1.75 increase per household per month to move to a wheeled cart system. She believes this system would greatly reduce loose trash in town and would encourage residents to abide by the amounts each household can put out each week.

Mr. Carlson would like to see a citizen survey. Mr. Joyce pointed out that historically, survey responses have been too low to be effective. Mr. Hildebrand felt that the contract should be put out to bid. Ms. Szeliga and Mr. White both spoke in favor of carts.

Motion by Mr. Hildebrand to put Evart city waste services out for bid. Motion died for lack of a second.

Motion made by Mr. Carlson to approve a five-year extension with Republic Services and add the cart service. Support by Mr. Elliott.

I. Request from Emerson Geophysical, LLC to conduct seismic survey

After discussion, council felt this proposal carried more potential drawbacks for the city than benefits. The survey would be conducted in an area that holds some of the oldest city infrastructure, as well as a major sewer line.

Motion by Mr. Elliott to deny this request. Support by Mr. Carlson.
