#### **Irrigation Meter Reads Reminder**

With the summer season coming to a close, we wanted to remind you to please be sure to get your irrigation reads to City Hall as soon as possible. Per Ordinance 2019-05, "sewer credits shall only be issued for the current year. If a resident fails to provide a beginning of the season irrigation read, for the current year, a sewer credit will not be given."

#### Trash Pickup Update: New Carts!

The City of Evart and Republic Services are excited to announce residents will be receiving a new 96-gallon cart to be used for weekly trash pick up. This cart will replace any trash receptacles currently being used. Residents will still be able to place one large bulk item each week in addition to this new large cart. ## Spotlight on City Council: Councilman Dan Elliott




What is your favorite thing about our city?

Evart is an unusual small northern Michigan city. Located within little more than an hour drive, it has access to major cities, cultural, recreational, and shopping centers. However, one need not travel outside the city to meet immediate needs since Evart has ample quantities of the attractions present in these much larger cities. While Covid-19 has significantly affected our area these past few months, Evart still has immense recreational

opportunities available through its nearby woods, waters, parks and trailways. Although much reduced this spring and summer, even some cultural programming has continued. The community offers high quality public services through its many local governmental agencies. Finally, the people of Evart remain welcoming to those visiting and to those who chose to work and reside in our community.

#### What is CCRA?

All businesses within City limits and some City residents will have recieved information from CCRA Professional Services, LLC. This is a company contracted by the City to conduct a Cross Connection Control Inspection. This is designed to assess the risk of cross contamination in the event of a backflow incident. This inspection helps to keep our drinking water safe from contamination and is mandatory for those contacted by CCRA. Let's work together to keep our sidewalks and streets clean and safe. It is the residents' responsibility to mow the right of way - the strip of grass between sidewalk and street.
