FERRY COUNTY NON-POTABLE WATER STATEMENT

Section 63 of the Washington State Growth Management Act requires local Building Permit offices to require the applicant to show proof of potable water before a residential building permit can be issued. The Ferry County Commissioners and Planning Commission have amended the act and require applicants that will use a dug well (wells less than 20 feet deep) or those who choose to haul water to file a Non-Potable Water Statement with the Ferry County Auditor. The Washington State Department of Health does not consider dug wells or hauled water to be an adequate source of potable water due to the fact that dug wells are prone to surface contamination and hauled water is too difficult to verify the source. This statement will be recorded on the property title so any future owners will know that the water source is not approved by the State. The Ferry County Building Department strongly suggest that the water source be tested for lead, arsenic, nitrates and coliform and that the test results also be filed with the Ferry County Auditor. If the test results are filed with the Auditor it will show any prospective future buyers that even though the water source does not meet the State standards, it has been tested and meets the minimum requirements of Ferry County.

A Certificate of Occupancy will not be issued until a copy of this Statement is returned to the Building Department. The copy must be stamped and recorded with the Ferry County Auditor.

Suggestions: (Advisory Only)

Do not locate dug wells in areas where surface water may pond or flow around the well. A radius of 100 feet around your well should be under your ownership to prevent contamination from neighboring property.
