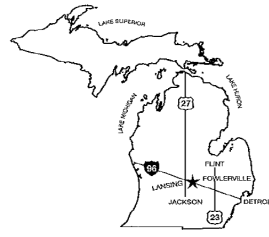

The Village of Fowlerville does not actually make the water connections to and from the building, only inspects these new connections before water is turned on. THIS FORM MUST BE RETURNED TO THIS OFFICE WITH AS-BUILT DRAWINGS INDICATING LINE LOCATIONS AND MEASUREMENTS. INSPECTIONS OF THESE LINES MUST BE MADE BEFORE LINES ARE COVERED. THE TYPE OF MATERIAL USED MUST BE SPECIFIED AND CONSTRUCTION MUST ADHERE TO VILLAGE STANDARDS. THE VILLAGE OF FOWLerville OFFICE REQUIRES 48 HOUR NOTICE FOR ALL INSPECTIONS/REINSPECTIONS AND/OR TURN-ONS. THE VILLAGE WILL NOT TURN ON ANY SERVICES UNTIL ALL OF THE PROPER DOCUMENTATION IS RECEIVED AND TURN-ON WILL ONLY BE COMPLETED WHEN ACCOMPANIED BY THE CONSTRUCTOR. ALL FEES MUST BE PAID BEFORE ANY SERVICE IS COMMENCED. EMERGENCY SHUT-OFFS/TURN-ONS WILL BE DONE AS SOON AS POSSIBLE ONCE NOTICE IS GIVEN.
