RESOLUTION ESTABLISHING VILLAGE WATER SYSTEM RATES CHARGES AND FEES

WHEREAS, the Village of Fowlerville Water Supply, Distribution and Use Ordinance, being Ordinance 233, as amended, directs Council to periodically review its Water System charges, make adjustments deemed necessary for the operation, maintenance, replacement and improvement of the System (Fowlerville Village Code Section 82-686); and

WHEREAS, the Council deems the following rates, charges and fees are necessary for the operation, maintenance, replacement and improvement of the Village Water System.

NOW, THEREFORE, BE IT RESOLVED:

That the following Rates, Charges and Fees are hereby established for the Village of Fowlerville Water System:

1. **Water Use Charges.**

A. **Residential Flat Water Rate:**

Each Residential Water User shall pay a Residential Flat Water Rate per quarter beginning fiscal years 2018/2019, 2019/2020, and 2020/2021, which are attached hereto as Exhibit A.

B. **Meter Minimum Charge (up to 21,000 gallons):**

Each Metered Minimum Charge User (up to 21,000 gallons of metered water) shall pay a Meter Charge per quarter for each metered dwelling unit beginning fiscal years 2018/2019, 2019/2020, and 2020/2021, which are attached hereto as Exhibit A.

C. **Metered Charge (over 21,000 gallons):**

Each Metered User shall pay a rate per 1,000 gallons of metered water over 21,000 gallons used per quarter, beginning fiscal years 2018/2019, 2019/2020, and 2020/2021, which are attached hereto as Exhibit A.

D. **Water Improvement Charge:**

In addition to any Metered Charges and Residential Rates a Water Improvement Charge shall be assessed at a rate per quarter for each User, including each dwelling unit for Multiple Residential Users and Mobile Home Parks beginning fiscal years 2018/2019, 2019/2020, and 2020/2021, which are attached hereto as Exhibit A.

BE IT FURTHER RESOLVED that it is the intent of Council that if any portion of this Resolution should be found invalid for any reason, such a holding shall not be construed as affecting the validity of the remaining portions of this Resolution.

BE IT FURTHER RESOLVED that this Resolution shall supersede all prior Resolutions setting Water Use Charges, to the extent necessary to give this Resolution full force and effect.

BE IT FURTHER RESOLVED that the changes in Water Service Charges set forth in this Resolution shall be effective for all Charges billed from and after **July 1, 2018.**

**RESOLUTION ESTABLISHING VILLAGE SANITARY SEWER SYSTEM
RATES, CHARGES AND FEES**

WHEREAS, the Village of Fowlerville Sanitary Sewer Disposal System Use Ordinance, being Ordinance 214, as amended, directs Council to periodically review its Sanitary Sewer charges, make adjustments deemed necessary for the operation, maintenance, replacement and improvement of the System (Fowlerville Village Code Section 82-723); and

WHEREAS, the Council deems the following rates, and charges are necessary for the operation, maintenance, replacement and improvement of the Village Sanitary Sewer Disposal System.

NOW, THEREFORE, BE IT RESOLVED:

That the following Rates, Charges and Fees are hereby established for the Village of Fowlerville Sanitary Sewer Disposal System:

1. Sewer Use Charges.

A. **Residential Flat Sewer Rate:**

Each Residential Sewer User shall pay a Residential Flat Sewer Rate per quarter beginning fiscal years 2018/2019, 2019/2020, and 2020/2021, which are attached hereto as Exhibit A.

B. **Meter Minimum Charge (up to 15,000 gallons):**

Each Metered Minimum Charge User (up to 15,000 gallons of metered water) shall pay a Meter Charge per quarter for each metered dwelling unit beginning fiscal years 2018/2019, 2019/2020 and 2020/2021, which are attached hereto as Exhibit A.

C. **Metered Charge (Over 15,000 gallons):**

Each Metered User shall pay a rate per 1,000 gallons of metered water over 15,000 gallons used per quarter, beginning fiscal years 2018/2019, 2019/2020 and 2020/2021, which are attached hereto as Exhibit A.

D. **Sewer Improvement Charge:**

In addition to any Metered and Residential Rates a Sewer Improvement Charge shall be assess at a rate per quarter for each User, including dwelling unit for Multiple Residential Users and Mobile Home Parks, beginning fiscal years 2018/2019, 2019/2020 and 2020/2021, which are attached hereto as Exhibit A.

BE IT FURTHER RESOLVED that it is the intent of Council that if any portion of this Resolution should be found invalid for any reason, such a holding shall not be construed as affecting the validity of the remaining portions of this Resolution.

BE IT FURTHER RESOLVED that this Resolution shall supersede all prior Resolutions setting Sanitary Sewer Service Charges, to the extent necessary to give this Resolution full force and effect.

BE IT FURTHER RESOLVED that the changes in Sewer Service Charges set forth in this Resolution shall be effective for all Charges billed from and after **July 1, 2018**.


