## **MINUTES OF THE REGULAR BOARD MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES TUESDAY, AUGUST 16, 2022**

### **CALL TO ORDER AND ROLL CALL**

Lord, Paige, 313 Old Hunt Rd – Paige stated that the Cary-Grove food pantry is looking for donations and that food inventory is getting low. Food donations are accepted during normal Pantry Hours: Tuesday and Thursday from 4:00 to 6:00 PM and on the 1st, 2nd and 3rd Saturday of the month from 9:00 to 11:00 AM. Paige also reported that volunteer services are needed at Feed my Starving Children located in Libertyville and Schaumburg, where meals are being packed for children of Ukraine.
