MINUTES OF THE REGULAR BOARD MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES THURSDAY, JUNE 6, 2019

CALL TO ORDER AND ROLL CALL

Village President Nunamaker called the meeting to order at 6:30 p.m. in the Municipal Center. Present at roll call were Trustees Anderson, Curtiss, Fleischmann, Migdal and Wall. Also present were Administrator Soderholm, Assistant to the Village Administrator Bechler, Chief Waitrovich and Clerk Majkrzak. Trustee Schladt came in after roll call.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

PUBLIC COMMENT

Jim Buster, 108 Crescent – he asked the Board if they would consider adding an additional golf cart crossing at Foxmoor and Route 14. He has spoken to the owner of Stone Hill Shopping Center and they support the idea. President Nunamaker explained the process to update the Ordinance. Mr. Buster is also concerned that there are some golf carts that do not have all the required equipment and he feels that golf carts should be inspected before the annual vehicle sticker is issued. Mr. Buster also suggested adding a horn as part of the required equipment.

Cheryl Ericson, 110 S. River Rd – she asked the Board about the current fence regulations. She would like to install a solid fence but it isn't allowed and the fence that she is looking at doesn't quite meet the 25% opening between the boards. She also stated that she drove around town and has noticed some solid fences. Discussion was held. President Nunamaker explained that the Board could review the Zoning Code and look at the types of fences currently being offered.

5. APPROVAL: ORDINANCE 2019-10, BOARD MEETING SCHEDULE


