MINUTES OF THE REGULAR BOARD MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES TUESDAY, APRIL 21, 2020

VILLAGE PRESIDENT AND TRUSTEE REPORTS

President Nunamaker provided an update on information related to COVID-19 and that there should be fourteen days of consistent decline in cases prior to lifting a "shelter in place."

Trustee Migdal stated that the Special Events Committee is looking for some guidance on the fireworks event pertaining to potential postponement or cancellation. It was the general consensus at this time to postpone the fireworks event until September and re-evaluate at a later date.

3. APPROVAL: ORDINANCE 2020-03, ADOPTING FY 2020/21 BUDGET


