MINUTES OF REGULAR SESSION OF THE CITY OF FRANKLIN CITY COMMISSION

January 14, 2019

City Hall 117 West Cedar Street Franklin, Kentucky

The Franklin, Kentucky City Commission met in Regular Session at 12:00 Noon, Monday, **January 14, 2019**, in the City Hall meeting room located at 117 West Cedar Street, Franklin, Kentucky.

Mayor Dixon called the meeting to order at 12:00 Noon, and Dr. John Whitaker of the Franklin First Baptist Church offered the opening prayer.

APPROVAL OF MINUTES

Motion was made by Commissioner Powell and seconded by Commissioner Stewart to approve the minutes as presented of the December 10, 2018, and December 17, 2018, special called meetings of the Franklin City Commission.

Voting aye: All. Motion carried unanimously.

RECOGNITION

Chief Roger Solomon introduced the most recently hired officers, Troy Lamastus and Michael Carder. City Attorney Scott Crabtree administered the oath of office for these incoming officers.

City Manager Kenton Powell introduced U.S. Army Sergeant Joshua Brandon Bingham from the Bowling Green Recruiting Center. Sgt. Bingham requested to address the Commission regarding his desire for community involvement and possible recruitment in Simpson County. Sgt. Bingham commended the quality of our school system, community events and citizen involvement.

COMMUNITY SERVICES

Community Development Director Tammie Carey provided an update regarding the Hoy Park Trail grant from the Kentucky Department for Local Government. The DLG awarded \$100,000.00 in grant funding for this project. Proposed developments include a walking trail, parking area, benches, trash cans and signage with historical information. Development is anticipated to begin in late spring or early summer.

GENERAL GOVERNMENT

City Attorney Scott Crabtree asked for two sponsors for an ordinance authorizing the closure of a public way on Hildegard Avenue. This portion of Hildegard Avenue was platted several years ago but was never developed. The adjoining property owner, Donald Gore, has maintained the property as a portion of his lawn and requested the City transfer the undeveloped public way to him.

Commissioner Powell and Commissioner Bennett agreed to sponsor the ordinance, first reading of Ordinance No. 2019-001 took place later in this meeting.

City Manager Kenton Powell asked the Commission to consider approval of local board members appointments or re-appointments which expired on December 31, 2018.

Motion was made by Commissioner Stewart and seconded by Commissioner Powell to authorize the following appointments to expire as specified below. Elected official appointments are for the term of office and other member appointments are for the terms indicated in the organizations bylaws.

Commissioner Williams asked for clarification of his appointment to the F-S Parks Board. Commissioner Williams will be the City elected official representative on the F-S Parks Board and Lisa Bashant was appointed to fill his existing unexpired term on the Board.

City Manager Kenton Powell asked the Commission to consider approval of a date and time for a special called joint City/County meeting. The proposed date and time is Thursday, January 31, 2019, at 12:00 Noon at Franklin City Hall.

Motion was made by Commissioner Bennett and seconded by Commissioner Powell to approve a special called joint City/County meeting on Thursday, January 31, 2019, at 12:00 Noon to be held at Franklin City Hall.

City Manager Kenton Powell asked the Commission to consider approving the extension of the City's Independent Contractor Agreement with Carter Munday. This extension will allow Mr. Munday to continue in his role as temporary office manager for Franklin-Simpson Planning & Zoning and will further allow ample time for the City and County to examine the future needs of the planning and zoning office.

Motion was made by Commissioner Powell and seconded by Commissioner Stewart to approve the extension of the City's Independent Contractor Agreement with Carter Munday beginning January 1, 2019 through June 30, 2019, and to further authorize the Mayor to sign the agreement on behalf of the City.

City Manager Kenton Powell asked the Commission to consider adopting Resolution No. A-2019 authorizing the appointment of Robert Palmer, Director of the Simpson County Office of Emergency Management, as the Application Agent for FEMA/Emergency Management for the City of Franklin.

Motion was made by Commissioner Bennett and seconded by Commissioner Stewart and was unanimously approved to adopt City of Franklin Resolution No. A-2019 to appoint Robert Palmer as the Application Agent for the City of Franklin for FEMA/Emergency Management disaster assistant programs and to authorize the Mayor to sign the Appointment of Local Emergency Management Director required by the State.

SUBJECT: W. Madison Street Property Cleanup

The City began researching cleanup/grinding options for the property located on W. Madison Street earlier this month. After discussion with the Department Heads and many calls to various factories, mulch companies, etc. the best option seems to be contracting the grinding and hauling of the pallets at the location. This option is the most time efficient and cost effective considering the scope of the work. This option will also eliminate the need for a capital purchase of equipment to handle the pallets. While a few industries have expressed some interest in small quantities of pallets, it would not be sufficient to make significant progress on the property cleanup. I would like to recommend giving those parties interested in picking up some pallets an opportunity to do so up until February 18, 2019 (3 weeks) prior to beginning the grinding and hauling operation. Several calls were made to request quotes on the grinding and hauling of the pallets with the following results:

ORDINANCE NO. 2019 - 002

AN ORDINANCE TO CLOSE THE PUBLIC WAY KNOWN AS THE 0.24 ACRE
TRACT OF LAND ON WEST MADISON STREET, BEING A 20-FOOT WIDE PUBLIC ALLEY
WHICH RUNS BETWEEN TRACT I AND TRACT II OF THE PROPERTY CONVEYED TO THE
CITY OF FRANKLIN IN COMMISSIONER'S DEED BOOK 17, PAGE 171,
SIMPSON COUNTY CLERK'S OFFICE

WHEREAS, at the request of the City of Franklin, Kentucky, it has been determined that the 0.24 acre tract of land on West Madison Street, being a 20-foot wide public alley which runs between Tract I and Tract II of the property conveyed to the City of Franklin in Commissioner's Deed Book 17, Page 171, Simpson County Clerk's Office, will serve a more useful public purpose if the herein described portion is closed and no longer used as a public way; and,

WHEREAS, the Board of Commissioners of the City of Franklin has identified the property owner in or abutting the portion of the property to be closed to be the City of Franklin, Kentucky; and,

WHEREAS, pursuant to KRS 82.405(2) (b) and (c), a written notice of the proposed closing was given to the property owner in or abutting that portion of the public way that is described in Exhibit A, and the property owner in or abutting that portion of the property has agreed to the closing of the public way, with said consent being attached hereto as Exhibit B; and,

WHEREAS, the Board of Commissioners of the City of Franklin has determined that it is in the best interest of the City to close the public way which is described more specifically in the attached Exhibit A, and to authorize the City Attorney for the City of Franklin to take any and all actions necessary to convey a portion of the public way to be closed to the City of Franklin, Kentucky; and,

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Franklin, Kentucky, as follows:

- 1. The preambles to this Ordinance are true and correct and incorporated herein by reference.
- 2. The 0.24 acre portion of the public way on West Madison Street, being a 20-foot wide public alley which runs between Tract I and Tract II of the property conveyed to the City of Franklin in Commissioner's Deed Book 17, Page 171, Simpson County Clerk's Office, described in Exhibit A, is hereby accepted by the City as a public way, as having been opened to the unrestricted use of the general public for more than five (5) consecutive years pursuant to KRS 82.400 and, further, said portion of the public way shall be hereinafter closed as a public way, street, and/or thoroughfare, as represented by the plat prepared by Gary Lee Dunning, #3290 dated January 7, 2019.
- 3. The City Attorney is hereby directed to take any and all actions necessary, and/or all of his actions with respect to this ordinance are hereby ratified pursuant to this ordinance to close said public way and to convey a portion of the public way, more particularly described in the attached Exhibit A, to the City of Franklin, Kentucky.
- 4. The Board of Commissioners authorizes and directs the Mayor to sign any and all documents necessary to effectuate the intent of this ordinance.

If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holdings shall not affect the validity of the remaining portions of Ordinance.

All ordinances or parts of ordinances in conflict herewith, are, to the extent of such conflict, hereby repealed.

Attached for your review and approval is the proposed agreement with Kentucky League of Cities for recertification for the Certified City of Ethics program. The recertification training is scheduled for Monday, February 25, 2019 at 9:30 a.m.

Proposed Action: Request a motion to authorize the Mayor to sign the agreement with Kentucky League of Cities for recertification of the Certified City of Ethics program and to schedule the training for Monday, February 25, 2019 at 9:30 a.m.

Kentucky League of Cities

Proposal for Recertification under Certified City of Ethics Program

Recertification under the Kentucky League of Cities (KLC) program is a way to continue to recognize the efforts of cities and city officials that have adopted principles and procedures that offer guidance on ethical issues, along with a mechanism to resolve complaints at the local level. In addition, maintenance of this program increases public trust and confidence in city governments and their services, through the training and recognition that this program promotes. The Certified City of Ethics Program **requires recertification every four years** to maintain the designation. KLC does not act as an enforcement or regulating agency. It is the city's local enforcement board that determines the acceptable level of ethical conduct of those elected to and retained in office and employed by the city.

TO MAINTAIN A "CERTIFIED CITY OF ETHICS" DESIGNATION, A CITY MUST TAKE THE FOLLOWING STEPS:

Step 1) Statutory Compliance

If changes have been made to the code of ethics ordinance since the last certification, the latest ordinance must be emailed or mailed to the KLC Municipal Law and Training Department to verify that all requirements in KRS 65.003 have been met.

KLC will review any changes made to the code of ethics ordinance since the date of initial certification, to be ensure that the city meets the minimum standards set out in KRS 65.003.

City officials, along with their city attorney, can consult KLC's Sample Ethics Ordinance when considering provisions to include when amending the code of ethics.

If the city ethics ordinance is found to be deficient, the city will need to amend the ordinance to bring it into compliance with the statute.

Step 2) Contract Execution

Step 3) Training on City Ethics Ordinance

Once the ordinance has been reviewed and is found to meet the requirements of KRS 65.003, all elected city officials (and the Ethics Board/Commission) shall participate in a training on their specific city code of ethics conducted by KLC or a trainer mutually agreed upon by the city and KLC.

The training shall take place at an open meeting of the city legislative body. City officials will be eligible for ethics training credit.

Any employees, boards and commissions covered under the city code of ethics may also be trained separately at the additional rate of \$150.00 per session.

The training(s) will occur as follows:

- o Date(s): February 25, 2019
- o Time(s): 9:30 a.m. central time
- o Location(s): 117 West Cedar Street, Franklin, Kentucky 42135
- o The City will furnish presentation equipment including a laptop computer and projector. The City will make available a screen or a blank wall that can be used for projection of materials.
- o KLC will provide training materials to City by February 21, 2019.
- o The City will provide handouts for the training.

Step 4) Recertification

Once it is determined that the ordinance and resolution meet the established requirements and the city has received the required training, the city will maintain its designation as a "Certified City of Ethics" for another four (4) year period.

Each city that maintains its designation as a Certified City of Ethics will receive an updated framed certificate and a logo which can be incorporated into city stationery, road signs and other materials at the city's discretion for an additional four (4) years. In addition, KLC will send press releases to the local media notifying them that the city has maintained this designation, as well as recognition in KLC publications and events.

Step 5) Cost of the Program

The city agrees to pay KLC two hundred fifty dollars (\$250.00) due and payable before work begins. The fee includes the review time to make certain that any updated ordinance complies with KRS 65.003, preparation for training and the actual training. Additional costs associated with this program will be mileage from the KLC office to and

from the training location, any per diem or hotel if required, and any additional employee and/or board training sessions at one hundred and fifty dollars (\$150.00) per session. The need to spend the night will be determined on a case-by-case basis by KLC. All additional costs will be billed to the city at the completion of the program.

In the event more than one city can be trained within one travel period, the additional travel costs will be divided between the two cities.

Once training is complete, KLC will invoice the city for the remaining expenses to be paid within thirty (30) days from the date of the invoice.

Attached is a quote we have received from Accela, our Utility Billing Software.

The City began accepting credit card payments in 2014. Since then, this form of payment has become increasingly more popular with our customers. Particularly over the phone. Our Customer Service Representatives can take from 20 to 40 utility billing payments over the phone each day.

This is a service we want to continue to provide to our customers as another convenient alternative form of paying their bill. However, over the years, new Payment Card Security Standards (PCI Compliance Requirements) have been adopted that mandate various security compliance measures in order to protect customer identity and credit card information.

As a result, we have been researching ways to continue offering this service while maintaining compliance with the PCI Compliance requirements. One way is to implement an IVR Payment System (Interactive Voice Response payment system.) This would be an automated payment system via the telephone. This option will be integrated with our utility billing payment system and payments will be reflected on the customer accounts instantly.

There are costs to this service, however. These costs are noted in the attached quote. Currently we require customers paying via credit card to pay the merchant fee/convenience fee. This fee is assessed at a level that will allow us to break even on these costs — it is not intended to be a revenue making measure. If this IVR Process is implemented then this fee will be reviewed with respect to over the phone payments and likely increased slightly to cover the \$1.00 per transaction cost.

I would like to further discuss this service and answer any questions the Commission may have. In the end, if everyone is in favor of this service, I'd like to seek approval to enter into this service contract.

Proposed Motion: Approve implementation of this service, increase convenience fee if necessary to cover operating costs and per transaction fees, and authorize the Mayor to sign any and all documents related to this service.

ORDINANCE NO. 2019 - 001

AN ORDINANCE TO CLOSE THE PUBLIC WAY KNOWN AS THE 0.072 ACRE TRACT OF LAND BEING THE WESTERNMOST PORTION OF HILDEGARD AVENUE THAT HAS NOT BEEN PAVED OR SURFACED, LOCATED NEAR THE SOUTHWEST CORNER OF THE AREA KNOWN AS SENG SUBDIVISION. JUST WEST OF THE INTERSECTION OF HILDEGARD AVENUE AND WESTERN DRIVE

WHEREAS, at the request of Donald Gore and wife, Marilyn Gore, it has been determined that the 0.072 acre tract of land being the westernmost portion of Hildegard Avenue that has not been paved or surfaced, located near the southwest corner of the area known as Seng Subdivision, just west of the intersection of Hildegard Avenue and Western Drive will serve a more useful public purpose if the herein described portion is closed and no longer used as a public way; and,

WHEREAS, the Board of Commissioners of the City of Franklin has identified the property owners in or abutting the portion of the property to be closed to be Donald Gore and wife, Marilyn Gore, Anna Keen, unmarried, and Nancy Moseley, unmarried; and,

WHEREAS, pursuant to KRS 82.405(2) (b) and (c), written notices of the proposed closing were given to the property owners in or abutting that portion of the public way that is described in Exhibit A, and the property owners in or abutting that portion of the property have agreed to the closing of the public way, with said consents being attached collectively hereto as Exhibit B; and,

WHEREAS, the Board of Commissioners of the City of Franklin has determined that it is in the best interest of the City to close the public way which is described more specifically in the attached Exhibit A, and to authorize the City Attorney for the City of Franklin to take any and all actions necessary to convey a portion of the public way to be closed to Donald Gore and wife, Marilyn Gore; and,

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the City of Franklin, Kentucky, as follows:

- 1. The preambles to this Ordinance are true and correct and incorporated herein by reference.
- 2. The portion of the public way commonly known as the 0.072 acre tract of land being the westernmost portion of Hildegard Avenue that has not been paved or surfaced, located near the southwest corner of the area known as Seng Subdivision, just west of the intersection of Hildegard Avenue and Western Drive, described in Exhibit A, is hereby accepted by the City as a public way, as having been opened to the unrestricted use of the general public for more than five (5) consecutive years pursuant to KRS 82.400 and, further, said portion of the public way shall be hereinafter closed as a public way, street, and/or thoroughfare, and shall no longer be maintained by the City of Franklin, Kentucky; provided that the City is allowed to retain any easements, conditions or restrictions, written or unwritten, that previously applies to this property, and they shall remain in effect and apply to this property as represented by the plat prepared by Robert G. May, LPLS #2142 dated December 5, 2018.
- The City Attorney is hereby directed to take any and all actions necessary, and/or all of his actions with respect to this ordinance are hereby ratified pursuant to this ordinance to close said public way and to convey a portion of the public way, more particularly described in the attached Exhibit A, to Donald Gore and wife, Marilyn Gore.
- The Board of Commissioners authorizes and directs the Mayor to sign any and all documents necessary to effectuate the intent of this ordinance.

If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holdings shall not affect the validity of the remaining portions of Ordinance.

All ordinances or parts of ordinances in conflict herewith, are, to the extent of such conflict, hereby repealed.
