Tracy Fuller (YMCA), Stacy Lemay (GPS) & Cathy Wolf (YMCA) joined the meeting.

Tracy Fuller spoke about the YMCA legacy (165 years) 32 licensed sites between MA & NH. She spoke about before and after school care at Penn Brook and about the programming for the extended day program. She spoke about curriculum, arts, literacy, diversity & learning and the values involved in the programming. The Y welcomes all. They have a partnership with McLean Hospital. She discussed safety (praesidium accredited) & about licensing. Tracy Fuller talked about pricing which includes scholarships and waivers. Tracy explained that every family registered will receive a free family YMCA membership from Sept-May. Some offerings include swim lessons, fitness, childcare & priority summer camp registration. Tracy spoke about the partnership with Georgetown Public Schools. The YMCA will be trained in GPS code of conduct. The YMCA will provide weekly newsletters. Tracy explained that surveys will go out to parents. She spoke about quality assessments and positive feedback from families.

She spoke about camps & summer programming and planning for 2026 for Georgetown families based on the need.

Dr. Margo Ferrick spoke about the process of partnering with the YMCA. She spoke about Stacy LeMay being a big part of this partnership. Dr. Ferrick mentioned that some of the Georgetown staff will remain working in the Extended Day Program. Stacy LeMay is looking forward to continuing her work with the students of Georgetown.

Tracy Fuller spoke about financial assistance. Any family making under \$80K will qualify for assistance. Financial assistance is completely anonymous. The YMCA is planning for an open house for families. At this time there are 60 families in Georgetown interested in the program. There is an Interest Form on the [website](#). There will be a bus that goes from GMHS to Penn Brook for any 6th grade students who want to attend Extended Day.

The School Committee thanked Tracy Fuller, Cathay Wolf and Stacy Lemay for coming.

Kurt Slevoski, WVT School Committee Representative & Maureen Lynch, WVT Superintendent joined the meeting to provide an update from WVT.

Kurt Slevoski spoke about student enrollment. This information is provided in the presentation link. Maureen Lynch spoke about some programs being put aside due to lack of enrollment in the shops (Design & Visual, Early Education & Care and Construction Craft Labor. Maureen Lynch mentioned that WVT will have a sign-in day for graduates moving on to work with their co-ops after graduation. Students in Grade 11 are allowed to work co-op. WVT's next student representative for next year is a Georgetown resident.

Dr. Margo Ferrick explained that the district has restructured the assistant director position and has hired 2 Assistant Director positions. Chelsea Chadderdon & Sarah Colby. Sarah Colby has been working as a consultant for the district. Chelsea is coming from a neighboring district and has been doing some work with the current director, Patti White-Lambright on the special education audit.

Michael Hinchliffe thanked Patti White Lambright for coming back into the district and helping out this year.

Katelin Kennedy, Sarah Colby & Chelsea Chadderson joined the committee to discuss the program review. Katelin spoke about creating a special education procedure manual for staff and an online version for parents. Katelin spoke about the consultants that worked with the district. She spoke about teachers now doing their own annual evaluations. This was part of the new teacher contract. Katelin spoke about the new screening process. She spoke about new structures and timelines and about partnering with other districts. Docusign has now been implemented for consents and IEP's. Katelin spoke about the progress reports now being available in Aspen. She spoke about surveys being sent after IEP meeting to get feedback.

Joe Maribito stated that Katelin and her team are a well oiled machine.

Margo spoke about piloting for ESY with another district. Districts in the North Shore are all on the same page with sharing programs & students.

Katelin Kennedy spoke about the progress made this year since the audit, however knows there is still more to do.
