
Police Chief marks 40 years of service to city

Fresh out of the U.S. Army in January 1969, young Richard Black started a new career in public service by joining the Glendale Police Department as a police officer.

Forty years later, as the chief of that department, he was honored by the Glendale Board of Aldermen with a resolution recognizing his 40 years of service to the community.

"Chief Richard Black has distinguished himself in the law enforcement community as a highly dedicated leader committed to the highest ideals of professional law enforcement with a passion for the principles of community policing and a high level of personalized customer service that have become hallmarks of the Glendale Police Department," the resolution states.

During Chief Black's career, he has furthered the department's use of advanced technology, helped protect children

from internet predators and served both the citizen and law enforcement communities in countless ways.

Kirkham Avenue project update

Following numerous months of preplanning and grant preparation by the City of Glendale and followed by a thorough and highly competitive approval process by East-West Gateway, the City is now poised to embark upon a major capital improvement project similar in scope and magnitude to the Sappington Road Project recently completed.

The Kirkham Avenue Project will provide much-needed

road surface improvements, strengthen traffic and pedestrian safety, improve stormwater drainage, increase lighting and significantly improve the overall appearance of the corridor.

The Board of Aldermen on Dec. 1 authorized the execution of an Urban Program Agreement between the City and the Missouri Highways and Transportation Commission for the reconstruction of Kirkham Avenue from Sappington Road to the eastern city limit. This agreement enables the City to receive up to \$1,958,326 in federal funds, representing 80 percent of the cost of the project.

The Kirkham Avenue project will include a new road surface, new curbs, gutters and ADA-compliant sidewalks as well as stamped colored concrete at key intersections and decorative streetlights. In addi-

City of Glendale successful in getting grant dollars

During these tough economic times, one of the ways the City of Glendale can bring added value to the community at little to no cost to the taxpayer is through the strategic pursuit of grant dollars.

Over the past 12 months, the City of Glendale has been successful in procuring approximately \$2.5 million in grant funding. These grants include the following:

*A federal grant for the reconstruction of Kirkham Road from Sappington Road to the east City limit: \$1,958,326.

*Department of Homeland Security grant to purchase 14 sets of turnout gear and protective clothing, 12 self-contained breathing apparatus, 17 digital portable radios and fire prevention props: \$197,000.

*A second Homeland Security grant to purchase rescue equipment (Jaws of Life), fire hose and nozzles: \$37,050.

*Internet Crimes Against Children grant that funds all the activities of the Missouri

Internet Crimes Against Children Taskforce led by Lt. Joe Laramie: \$229,246.

*St. Louis/Jefferson Solid Waste Management recycling grant to purchase recycling containers: \$35,000.

*Local Law Enforcement grant to purchase three in-car cameras to record all traffic stops: \$9,000.

*Click-it-or-Ticket grant to increase seat belt usage: \$1,003.

*Highway Safety Division grant to reduce traffic accidents through increased enforcement of hazardous moving violations: \$2,100.

In addition, the City of Glendale is pursuing federal funding under the Federal Government Stimulus Package for improvements to 15 city streets, a joint project with Rock Hill for improvements to Bismark Avenue and facility improvements to the City Hall complex with special emphasis on our public safety facilities.

Municipal election set for April 7

In the municipal election on April 7, Glendale voters will decide whether to reelect the mayor and three aldermen.

The only contested race is in Ward II, where voters will choose between incumbent John Benz and newcomers Sally Cook and Mike Wilcox for a two-year term. Benz is serving his third term.

Mayor Richard Magee is running unopposed for re-election to his third two-year term. Incumbents Kay Sullivan in Ward I and Deb Voss in Ward III also are running unopposed. Sullivan has served since April 1987 and Voss has served since December 2002.

Strong financial fundamentals guide Glendale through recession

The current recession has negatively affected many state and local governments across the country, resulting in sharp revenue declines, employee layoffs, service reductions and other cuts that have an impact on the quality of life of residents at a time when they are most vulnerable.

We are proud to report to our residents that the City of Glendale's financial position remains extremely strong despite all of the negative forces affecting the economy.

The City continues to carry a more than adequate cash balance to meet its cash flow needs and provide cash reserves for unanticipated expenditures. This healthy cash balance is the result of conservative fiscal practices the City of Glendale has institutionalized over the years through maintaining tight controls over spending, minimizing the amount of long-term debt, and monitoring revenue performance closely and making mid-year adjustments when necessary.

The City also is taking advantage of grant dollars to strengthen the City's infrastructure and services. Over the past 12 months, the City has taken in \$2.5 million in grant revenue. The City also is committed to keeping its financial position strong by looking at new ways to control costs. Over the past six months, the City created a Mayor's Taskforce on Organizational Efficiency to generate ideas and strategies to improve efficiency and reduce the cost of local government.

This strategy of protecting the City's cash balance, pursuing

grants and using the collective talents of our employees to reduce costs is Glendale's winning combination to maintain and improve upon our value-added municipal services during these difficult economic times.

Employee task force generates cost-savings ideas for City government

A Glendale employee task force has energy costs; progress toward accepting been studying ways the city can save money and increase organizational efficiency as well as revenues.

Mayor Richard Magee requested establishment of the task force, which was formed last August and presented its first report to the mayor Sept. 29. The committee includes at least one employee from each of the City's five departments: Administration, Police, Dispatch, Fire and Public Works.

"In a relatively short period of time, this task force has generated numerous cost-savings ideas that have saved the City several thousands of dollars," said City Administrator Frank Myers.

Some savings efforts discussed or already under way include reducing gasoline costs; using in-house staff to maintain the city vehicle fleet; internal efforts to reduce

credit card payments at City Hall; progress toward more efficiently applying salt to city streets; and steps to implement an employee wellness program.

Suggestions for revenue enhancement include: more aggressively pursuing grants for large purchases; increasing fees for escrow and permits for new construction

projects; pursuing a phone company to build and pay rent on a cell phone tower on excess land at Public Works property; and increasing fees for pet tags and retrieval of animals picked up by the Police Department.

At the task force's request, the administration has placed an employee suggestion box in City Hall for cost-savings ideas.

E-billing now available for trash pickup services

The City of Glendale will begin this spring offering residents the option of electronic billing for their trash pickup services.

Finance Officer Dan Lawrence hopes to get the new system up and running as early as April 1.

Residents who sign up for the program will receive quarterly bills by e-mail in January, April, July and October, as on the current schedule.

Police make arrest in home invasions case

Glendale police and other law enforcement agencies acted quickly to solve two home invasion cases that occurred within the first week of January.

Spain Dominick Bady, 24, of St. Louis was charged Jan. 13 with five counts of first-degree robbery, one count of attempted robbery and two counts of first-degree burglary in connection with two Glendale home invasions, the robbery of a Hacienda Restaurant manager, the robbery of Boulevard Bank in Rock Hill and an armed robbery at an ATM in Sunset Hills.

"Our residents will sleep better knowing this dangerous person is behind bars and won't have the opportunity to strike again," said Police Chief Richard Black.

The Glendale robberies occurred on the afternoons of Jan. 2 and 5, when a man forced his way into two separate homes, holding the residents at gunpoint and taking jewelry, cash and a cell phone. The restaurant manager was held up at gunpoint at 10:50 p.m. Jan. 1 in the Hacienda parking lot, and a customer at the Sunset Hills ATM was robbed of jewelry on the evening of Jan. 2.

After a witness recognized the suspect during the bank robbery on Jan. 6, investigators closed in on the suspect. In coordination with the suspect's parole officer, investigators arranged a meeting at the parole office on Jan. 7, when Bady was

arrested. Formal charges were filed by the St. Louis County Prosecuting Attorney's office on Jan. 13.

The stolen jewelry was recovered from pawn shops.

Glendale police also acted quickly in keeping residents informed of developments by posting information, including a description of the suspect, on the city's website and by disseminating information through the news media.

Although this suspect has been apprehended, Glendale police remind residents to continue to practice the following crime prevention techniques to improve their overall security at home:

- •Keep windows and doors locked at all times
- •Do not answer the door without verifying the identity of the person on the outside.
- •Use a door viewer or nearby window to see who is on the other side.
- •Report suspicious activity, people, vehicles and phone calls to police immediately.
- •Suspicious activity can be anything out of the ordinary.

"We all have a sixth sense that tells us that something just isn't right," Chief Black said. "When that happens, call the police immediately."

Sergeant pegged for president of council

Glendale Detective Sgt. Randy Carrico was sworn in Jan. 21 as president of the Professional Investigators Council of Greater St. Louis for 2009.

The Council was established in 1957 to provide a private forum for members to exchange information on investigative techniques and experiences. More than fifty years later, this liaison between public, corporate and private investigators is even more important. With the advent of credit cards, computers and the Internet, criminal

activities are no longer a local occurrence but are now a worldwide problem.

Carrico had served as the membership chairman, secretary and vice-president of PIC before taking over as its 52nd president. Detective Carrico is a 36-year veteran of the Glendale Police Department. He started as a part-time dispatcher in 1972, became a police officer in 1976 and was promoted to sergeant in 1994. He has been a member of the Major Case Squad of Greater St. Louis since 1992.

Black was promoted to sergeant in September 1971 and to chief in April 1986. He graduated from the FBI National Academy in June 1987.

"He is best known by the rank and file within the Police Department for his constant attention to their well-being and professional development," the resolution states.

As chief, Black has obtained hundreds of thousands of dollars in grant funding to procure and implement technological advances and best practices in law enforcement. In addition, he was instrumental in allocating city resources and staff needed to create the Internet Crimes Against Children Task Force in Missouri, now nationally known for its efforts.

Black has held several leadership positions in law enforcement and community organizations, including serving as president of the Professional Investigators Council of Greater St. Louis and the Kirkwood Rotary Club. He also has actively participated in the Missouri Police Chiefs Association, the International Association of Chiefs of Police and the St. Louis Area Police Chiefs Association.

In his off-hours, he has spent 30 years officiating high school athletics, serving in the past as president of the St. Louis Officials Association. He received that group's prestigious Harold Booth Memorial Award for Excellence in Officiating in 1992. He also is active in his parish, Mary Queen of Peace Catholic Church.

Chief Black and his wife, Mary, have lived for 39 years in Glendale, where they raised three children and now enjoy visits with grandchildren. Last May, daughter Katy Horton donated a kidney to her father in a successful transplant at St. Louis University Hospital.

First CERT graduates ready for emergency and disaster response

Twenty-one citizens graduated on Nov. 1 from Glendale's inaugural Community Emergency Response Team (CERT) class with basic skills to assist in a disaster when emergency services are not immediately available.

Glendale residents accounted for 11 of the participants, while Warson Woods had eight and Ladue and St. Louis each had one participant.

The class learned such skills as how to turn off a gas meter, shut off electric to a building, use a portable fire extinguisher, apply basic first aid, determine if a building is safe to enter and perform light search and rescue for victims who may be trapped in a collapsed building. Participants also learned how to help people cope with emotional issues that arise during natural or manmade emergencies.

"With the training and practice and by working as a team, civilians are able to do the greatest good for the greatest number of victims after a disaster without becoming victims themselves," said Capt. Chuck Helle, CERT program coordinator.

The 20-hour course, held in five four-hour segments, included both lecture and hands-on training. Instructors included Fire Capt. Steve Siebert, Police Sgt. Bob Catlett, Firefighters Chad Wagner and Curtis Van Gaasbeek and Crestwood's Assistant Fire Chief Mark Menning.

The course concluded with an awards ceremony at which Glendale Mayor Richard Magee and War-

son Woods Mayor E. William Bergfeld Jr. presented certificates to the graduates. All participants received a manual and a backpack containing personal protection gear and other equipment.

Recycling now goes into single stream

Attention all Glendale recyclers: The days of sorting are over. Residents may now drop all their recyclable material into the Allied Waste-issued recycling bin on recycling day.

Allied Waste now uses the "single stream" method of recycling collection. Through this method, plastic, glass, aluminum, steel and paper may be commingled in the bin. Allied takes the materials to Resource Management, a recycling processor, which then sorts the items for processing.

Residents may now recycle: aluminum cans, trays and foil; milk and juice cartons; steel cans and tins, including aerosol cans; clear, brown and green glass bottles and jars; and plastic containers bearing the numbers 1 PET, 2 HDPE (clear and colored), 3 PVC, 4 LDPE, 5 PP and 7 (narrow neck) and well as plastic buckets, such as

kitty litter containers. The numbers can be found on the bottom of the containers within the triangle-like recycling symbol.

All containers must be rinsed clean.

Recyclers may also place in the bin items of paper fiber, including: newspa-

pers including all inserts (but not the plastic sleeve); unwaxed cardboard; brown paper bags; magazines, catalogs and telephone books; office, computer, notebook and gift wrap paper; chipboard such as cereal and cake

mix boxes; carrier stock cardboard, such as soda and beer carrying cases; mail, junk mail and envelopes (but no plastic cards, stick-on labels or unused stamps); and paperback books.

Glendale JazzFest to celebrate 10th year May 22

The Glendale JazzFest will celebrate its 10th year this Memorial Day weekend from 6 to 10 p.m. May 22 in the City Hall lower parking lot.

The free concert will feature music by the Terry Thompson Swing Alive Band and other local groups to be announced. KFUO-FM Radio's Don Wolff will emcee the event, which also will feature refreshments offered for sale by local restaurants.

JazzFest was first held in 2000 to offer Glendale residents a community event for early summer. Thompson, then a resident of Glendale, approached city officials about presenting a jazz festival.

"I thought it would be good for Glendale because it's a closely knit community," said Thompson, a jazz musician, arranger and composer of many commercial jingles, including the Frederic Roofing theme. "City Hall is within walking distance of a lot of young families."

The first concert attracted about 200 people, and last year's attendance was estimated at about 2,000. "It's quite a little success story," Thompson said.

JazzFest is presented by the Glendale Women's Club in association with the City of Glendale and is produced by Terry Thompson Productions. The event is underwritten by local business sponsors.

Sellers, renters need inspection and occupancy permit before move

Homeowners in Glendale are required to pass a housing inspection before selling or renting a home, and all new residents, whether buyers or renters, must get an occupancy permit before moving into a residence.

A seller must apply for an inspection any time prior to closing the sale on the home. The application is good for 90 days. A \$100 inspection fee must accompany the application, covering the initial inspection and one re-inspection. Inspections, which take about two hours, are performed between the hours of 8:30 a.m. and 2 p.m. Monday through Friday.

Inspections also must be performed on rental property before a new tenant moves in. Both renters and homeowners must obtain occupancy permits before moving into the premises. The permit will allow the city to begin refuse service to the home. There is no charge for the occupancy permit.

tion, the work will include minor improvements to the stormwater drainage system as necessary and minor roadway adjustments to correct sight-distance problems.

The City of Glendale will be responsible for 20 percent of the cost and for covering all billable costs until reimbursement is received from the federal government. The City has developed a funding strategy to raise over the next three years \$840,000 to cover its match and any unforeseen contingency costs. This funding strategy includes deferring the chip sealing of city streets in 2008, 2009, 2010 and 2011 at a savings of \$240,000. After 2011, the City will increase its funding of the chip sealing program to \$100,000 per year to make up for roads not receiving this treatment. The funding plan also includes annual contributions of \$90,000 a year each from the Capital Improvement Fund and the General Fund cash reserve for the next three years. The City also will apply its annual allocation of Community Development Block Grant funds for the next three years to cover matching costs associated with meeting ADA requirements. Once the project is completed, any unused local funds designated for this project will be returned to the General Fund cash reserve.

The project timeline calls for the City to execute an Engineering Service Contract by early fall of 2010 to develop preliminary and final construction plans, develop right-of-way plans, execute project easements and coordinate any utility relocations. After these plans are reviewed and approved by the Missouri Department of Transportation, the construction phase of the project would be bid in early 2013 with actual construction beginning by the spring of 2013. Once construction begins, the project is expected to take 12 months to complete.

City bestows annual employee service awards

The City of Glendale has honored Patrol Officer Chris Sarantakis with the Michael P. Pounds Municipal Employee of the Year Award for 2008 and designated two other employees for the Community Service Award.

"This award represents the best of the best," said Mayor Richard Magee in bestowing the Employee of the Year Award.

Officer Sarantakis has been a Glendale employee since April 1, 2003 and holds a bachelor's degree in criminal justice with a minor in computer information systems from the University of Central Missouri. He also graduated from the Eastern Missouri Police Academy. Sarantakis wrote and continuously updates the Police Department's Standard Operating Procedures Manual and serves as the evidence officer. He was one of the first officers to receive Crisis Intervention Training and has effectively used this training to assist Glendale families experiencing a crisis. During the past year, Sarantakis led the department in driving-while-intoxicated arrests and has distinguished himself in clearing identity theft cases.

The St. Louis Traffic Safety Council honored Sarantakis with its prestigious 2008 Officer of the Year Award. While off-duty, he volunteers for the Missouri Special Olympics.

"During his career with the City of Glendale, Officer Sarantakis has consistently displayed great enthusiasm and initiative in the performance of his duties and is considered by his superiors to be highly productive in all facets of police work," said Police Chief Richard Black.
