OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION NOVEMBER 5, 2012

A regular session of the Granite Falls City Council was called to order by Mayor David Smiglewski at 7:30 p.m., Monday, November 5th in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Bill Miller, Steve Schaub, Joe Fagnano and Scott Peterson. Council Member absent: Steve Nordaune. Staff present: City Manager Bill Lavin, Finance Director Michael Betker and City Clerk Joan Taylor. Also in attendance were City Engineer Berryman and Todd Hagen from Ehlers & Associates and Advocate Tribune News Editor Scott Tedrick.

MINUTES: M/S MILLER/SCHAUB TO APPROVE THE MINUTES OF THE OCTOBER 15TH REGULAR MEETING. Motion carried unanimously by those present.

BILLS: M/S MILLER/SCHAUB TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously by those present.

BONDS: Todd Hagen was in attendance to discuss with council reissuing of the \$8,120,000 General Obligation Temporary Water Revenue Bonds which were sold to assist in providing interim financing for construction of the Water Treatment Plant. The temporary issue matures on December 1, 2012; however, the general contractor will be requesting a time extension for final completion. Because of the time extension it has been recommended that the city reissue the temporary bonds. Following discussion Miller introduced a resolution and moved its adoption providing for the reissuance of the Temporary Water Revenue Bonds.

RESOLUTION NO. 12-136

Council Member Miller introduced the following resolution and moved its adoption:

Resolution Providing for the Sale of \$8,120,000 General Obligation Temporary Water Revenue Bonds, Series 2012B

- A. WHEREAS, the City Council of the City of Granite Falls, Minnesota, has heretofore determined that it is necessary and expedient to issue the City's \$8,120,000 General Obligation Temporary Water Revenue Bonds, Series 2012B (the "Bonds") to temporarily finance the construction of various improvements to the City's water system in anticipation of the receipt of the issuance of permanent obligations; and
- B. WHEREAS, the City has retained Ehlers & Associates, Inc., in Roseville, Minnesota ("Ehlers"), as its independent financial advisor for the Bonds and is therefore authorized to solicit proposals in accordance with Minnesota Statutes, Section 475.60, Subdivision 2(9);

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Granite Falls, Minnesota, as follows:

- 1. <u>Authorization; Findings</u>. The City Council hereby authorizes Ehlers to solicit proposals for the sale of the Bonds.
- 2. <u>Meeting; Proposal Opening</u>. The City Council shall meet at 7:30 p.m. on November 19, 2012, for the purpose of considering proposals for and awarding the sale of the Bonds.
- 3. <u>Official Statement</u>. In connection with said sale, the officers or employees of the City are hereby authorized to cooperate with Ehlers and participate in the preparation of an official statement for the Bonds and to execute and deliver it on behalf of the City upon its completion.

The motion for the adoption of the foregoing resolution was duly seconded by Council Member Fagnano and, after full discussion thereof and upon a vote being taken thereon, the following Council Members voted in favor thereof: Galow, Miller, Smiglewski, Schaub, Fagnano and Peterson.

- Approval of the Authority's Credit Enhancement Program Agreement.
 The Authority's Credit Enhancement Program Agreement (the "Agreement") is hereby approved, the same being before the City Council and made a part of this resolution by reference.
- Authorization to Sign Agreement and Related Forms. The Mayor and the City Manager are authorized to sign the Agreement on the City's behalf and to execute any other related forms prescribed by the Authority with respect to the Agreement.
- Agreement to Comply with Minnesota Statutes, Section 446A.086. The
 City is entering into the Agreement with the Authority pursuant to Minnesota
 Statutes, Section 446A.086 (the "Act") and the City hereby agrees to comply
 with and be bound by the provisions of the Act.
- 4. <u>Submission of the Agreement</u>. The Mayor and the City Manager are hereby authorized to submit, on the City's behalf, the Agreement to the Authority, together with the nonrefundable application fee in the amount of \$500.
