A regular session of the Granite Falls City Council was called to order by Mayor David Smiglewski at 7:30 p.m., Monday, July 15th, in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Sarina Otaibi, Steve Nordaune, Steve Schaub, Joe Fagnano and Scott Peterson. Staff present: Finance Director Michael Betker and City Clerk Joan Taylor. Also in attendance were Hospital Administrator George Gerlach, Terri Dinesen and members of the Granite Falls Historical Society and Advocate Tribune News Editor Scott Tedrick.

- MINUTES: M/S NORDAUNE/SCHAUB TO APPROVE THE MINUTES OF THE JULY 1ST REGULAR MEETING. Motion carried unanimously.
- BILLS: M/S GALOW/NORDAUNE TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously.
- MEANDER OPENING NIGHT: Ashley Hanson was in attendance to discuss with council the opening night kickoff of the Meander event scheduled for October 4th and to request a sponsorship donation from the city in the amount of \$2,500. Following discussion it was the consensus of council hold this matter over until the August 5th meeting.
- VOLSTEAD HOUSE: Terri Dinesen and members of the Granite Falls Historical Society were in attendance to request council authorization to submit a grant application to the Minnesota Historical Society Legacy Grant program to assist the city in the repair/replacement of the Volstead House foundation. Following discussion Nordaune introduced a resolution and moved its adoption authorizing the submittal of the grant application.

REPORT: The Airport Commission report was acknowledged at this time.

AIRPORT LAYOUT PLAN: Following discussion relative to the modifications suggested by the Office of Aeronautics to the hangar site plan M/S NORDAUNE/PETERSON TO APPROVE THE CHANGES TO THE AIRPORT LAYOUT PLAN AS FOLLOWS:

- 1. Grade and pave all of the apron and taxi lanes as shown on the revised hangar site plan with the exception of the taxi lane west of the site designated for private T-hangar development. Mr. Hay indicated that should future need arise for further development of this area the taxi lane could be extended at that time. Also by not installing this road at the present time there would be no impact on the existing trees.
- 2. Fagen, Inc. would complete site preparation for both the private hangars as well as the T-hangar area to MnDOT standards.
- Fagen, Inc. would also grade and provide a gravel base to an area designated for public parking south of the hangar site area. This area could then be used for public parking by those individuals constructing private T-hangars. Commission was again reminded that three individuals continue to be interested in constructing private hangars once the site prep has been completed.
- 4. Fagen, Inc. would propose to complete site preparation for a 5 unit T-hangar with the understanding that in the future based upon demand additional site preparation could be completed to accommodate the construction of a second public 5 unit T-hangar.

Motion carried unanimously.

REPORTS: The following reports were acknowledged at this time EDA Board, Finance Report, Fire Department, Hospital Board, Police Chief and Granite Falls Historical Society.

LIBRARY: It being in the best interest of the city, Schaub introduced the following resolution and moved its adoption waiving calling for quotes and accepting the quote received from Ryer Plumbing & Heating in the amount of \$4,505 to purchase and install a new air conditioning unit at the Library.
