OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION SEPTEMBER 16, 2013

A regular session of the Granite Falls City Council was called to order by Mayor David Smiglewski at 7:30 p.m., Monday, September 16th, in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Sarina Otaibi, Steve Nordaune, Steve Schaub, Joe Fagnano and Scott Peterson. Staff present: Finance Director Michael Betker and City Clerk Joan Taylor. Also in attendance was Advocate Tribune News Editor Scott Tedrick.

- MINUTES: M/S NORDAUNE/SCHAUB TO APPROVE THE MINUTES OF THE SEPTEMBER 3RD REGULAR MEETING. Motion carried unanimously.
- BILLS: M/S GALOW/NORDAUNE TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously.
- REPORTS: The following reports were acknowledged at this time Airport Commission, EDA Board, Hospital Board and Police Chief.
- FLOOD MITIGATION: Council was advised that work has begun on the secondary pumping station.
- WATER TREATMENT PLANT: Council was again reminded that Open House for the new Water Treatment Plant is scheduled for September 28th from 11:00 to 3:00. Council was also advised that the contractor continues to work on the final punch list.
- 2013 UTILITY/STREET IMPROVEMENTS: Council reviewed an update received from City Engineer Berryman relative to the 2013 Utility and Street Improvements noting that the concrete subcontractor was now in town pouring sidewalks and driveways.
- FARM LAND: Council reviewed correspondence received from Rich Jepson requesting a renewal of his Lease Agreement for the tillable acreage of the farm land only. Following discussion Galow introduced the following resolution and moved its adoption extending the Farm Lease Agreement between the city and Richard Jepson for the rental of 40 acres of tillable land for a three-year period beginning January 1, 2014 through December 31, 2016 in the amount of \$105.23 per acre for the farm land. For each successive year the contract remains in force the rate per acre for tillable land shall increase according to the Consumer Price Index.

RESOLUTION CALLING FOR BIDS FOR LEASE OF INDUSTRIAL PARK HAY LAND

WHEREAS, pursuant to Minnesota Pollution Control Agency requirements, biosolids from the Wastewater Treatment Plant are land applied on approximately 40 acres of city owned property located in the Industrial Park; and

WHEREAS, as MPCA requires that an established standing crop is planted in this area, a hay crop has been established on the 60 acres described as:

Lots 1, 2, & 4 of Block 3, approximately the easterly 450 feet of Lot 3, and all of Lots 4, 5 & 6 of Block 4, Granite Falls Industrial Park 1st Addition;

and the south approximate 20 acres of Lot 2, Block 2, Granite Falls Industrial Park 1st Addition.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, authorizing advertising for bids for lease of 60 acres of hay land located in the city's Industrial Park described above, with said bids to be received by 2:00 p.m. Thursday, October 3rd for council consideration at its October 7th regular meeting.
