OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION APRIL 7, 2014

A regular session of the Granite Falls City Council was called to order by Mayor David Smiglewski at 7:30 p.m., Monday, April 7th, in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Sarina Otaibi, Steve Nordaune, Steve Schaub, Joe Fagnano and Scott Peterson. Staff present: City Manager Bill Lavin, Finance Director Michael Betker and City Clerk Joan Taylor. Also in attendance were City Attorney Greg Holmstrom and Ambulance Director Gene Hughes. Also in attendance was Advocate Tribune News Editor Scott Tedrick.

- MINUTES: M/S GALOW/NORDAUNE TO APPROVE THE MINUTES OF THE MARCH 17TH REGULAR MEETING. Motion carried unanimously.
- BILLS: M/S NORDAUNE/SCHAUB TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously.
- REPORTS: The Building Inspector's report and the EDA Board report were acknowledged at this time.
- SPECIALTY SYSTEMS: Staff advised council that a tour of Specialty Systems has been scheduled for Thursday, April 10th at 4:00 p.m.
- AMBULANCE SERVICES: Ambulance Director Gene Hughes and City Attorney Holmstrom were in attendance to discuss a draft Ambulance Service Contract that if approved would allow the ambulance to charge a cost-per-section for those townships that are served by the ambulance service and the city would also be charged a yearly fee. Following discussion it was the consensus of council for Mr. Hughes to meet with the townships involved and come back to council for formal approval. With the funds raised Director Hughes indicated that a capital fund would be created and would be used to maintain the fleet of ambulances.
- BREW PUB/CRAFT BREWING: As a downtown commercial business has inquired as to the possibility of obtaining a license to brew his own wine/beer at his store and then sell it to the public, council discussed with City Attorney Holmstrom amending the downtown commercial zoning ordinance to allow for small brewery licenses. Council will have a draft ordinance for consideration at its April 21st meeting.
- REPORTS: The Fire Department, Kilowatt Community Center Board, Public Works and Utilities Commission reports were acknowledged at this time.
- LIQUOR LICENSE: M/S NORDAUNE/SCHAUB AUTHORIZING A TEMPORARY LIQUOR LICENSE TO THE LIONS CLUB TO SELL STRONG BEER AT WESTERN FEST. Motion carried unanimously.

VOLSTEAD HOUSE: Pursuant to Resolution No. 14-37 council requested proposals for professional design and construction management services to complete the foundation repairs to the Volstead House Museum. Only one proposal was received from LSEngineering in the amount of \$25,160. Following discussion Nordaune introduced a resolution and moved its adoption accepting the proposal received from LSEngineers in the amount of \$25,160 to provide design and construction management services for the Volstead House Museum foundation repairs. The difference in the proposal amount and the budgeted amount is \$4,660 which could come from 2014 General Fund designated reserves.

RESOLUTION NO. 14-50

RESOLUTION ACCEPTING PROPOSAL FOR PROFESSION DESIGN AND CONSTRUCTION SERVICES – VOLSTEAD HOUSE

WHEREAS, pursuant to Resolution No. 14-37 council called for proposals for professional design and construction management services to complete the foundation repairs to the Volstead House Museum; and

WHEREAS, one proposal was received from LSEngineers in the amount of \$25,160; and

WHEREAS, the total estimated budget for engineering services was \$20,500 leaving a difference of \$4,660 which could come from 2014 General Fund designated reserves.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, accepting the proposal from LSEngineers in the amount of \$25,160 for professional design and construction management service to complete the foundation repairs to the Volstead House Museum contingent upon review and approval by the Minnesota State Historical Society if required; and

BE IT FURTHER RESOLVED that the difference in budgeted amount and the accepted proposal shall be taken from designated reserves.

WHEREAS, the city highly values the contributions of volunteer firefighters and wishes to also provide similar survivor benefits to the families of firefighters who die <u>before</u> providing five (5) years of service; and

WHEREAS, the city understands that should this provision be approved and passed into law, it would not increase required contribution amounts.

PERSONNEL: Staff advised council that Allan Gisalson has now resigned as a transit driver and Brad Hall has been hired. Also Keith Koerlin has been offered and accepted the position of KCC maintenance custodian.

GAMBLING PERMIT: A gambling license application was acknowledged at this time for the Western Fest Committee to hold its annual raffle. This application was acknowledged with no waiting period.
