OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION JUNE 2, 2014

A regular session of the Granite Falls City Council was called to order by Mayor David Smiglewski at 7:30 p.m., Monday, June 2nd, in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Sarina Otaibi, Steve Nordaune, Steve Schaub, Joe Fagnano and Scott Peterson. Staff present: City Manager Bill Lavin, Finance Director Michael Betker and City Clerk Joan Taylor. Also in attendance were EDA Directors Dennis VanHoof and Justin Bentaas, City Engineer Dave Berryman, Tom Dye from Stantec, YME County Administrator Peggy Helgund, County Commission John Berends, Kevin Wald and Steve Daniels from Specialty Systems, Rebecca Kurtz from Ehlers & Associates, Benjamin Goede and Ashley, Dave and Karen Lee, and Advocate Tribune News Staff Writer Ethan Groothuis.

- MINUTES: M/S NORDAUNE/SCHAUB TO APPROVE THE MINUTES OF THE May 19th REGULAR MEETING. Motion carried unanimously.
- BILLS: M/S NORDAUNE/SCHAUB TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously.
- ORDINANCE: Council reviewed correspondence received from Benjamin Goede requesting the city amend its ordinance relative to allowing Vietnamese potbellied pigs as pets in city limits. Following discussion M/S GALOW/OTAIBI TO HAVE THE FIRST READING OF AN ORDINANCE OF THE CITY OF GRANITE FALLS, MINNESOTA, AMENDING CITY CODE CHAPTER 91 BY EXCLUDING VIETNAMESE POTBELLIED PIGS AS AN EXCLUDED ANIMAL IN THE CITY LIMITS. Motion carried unanimously.
- REPORT: The Building Inspector's report and the finance report were acknowledged at this time.
- PUBLIC HEARING: A duly advertised preliminary hearing for the proposed Property Tax Abatement for the Specialty Systems Project was called to order by Mayor Smiglewski at 7:45 p.m. with Keven Wald and Steve Daniels from Specialty Systems, Rebecca Kurtz from Ehlers & Associates, YMC Administrator Peggy Heglund, YMC Commissioner John Berends and EDA Directors Dennis VanHoof and Justin Bentaas in attendance. Rebecca Kurtz from Ehlers & Associates explained to council the process by which the city would be authorized to abate property taxes from a selected parcel on a temporary basis to facilitate the purchase and use of specialized equipment for the existing facility in Granite Falls. Following discussion, Mayor Smiglewski closed the hearing at 7:49 p.m.
- TAX ABATEMENT: Following the closing of the public hearing, Schaub introduced a resolution and moved its adoption approving the property tax abatement concerning Specialty Systems.

RESOLUTION NO. 14-86

RESOLUTION APPROVING PROPERTY TAX ABATEMENT FOR THE SPECIALTY SYSTEMS PROJECT

BE IT RESOLVED by the City Council (the "Council") of the City of Granite Falls, Minnesota (the "City"), as follows:

i) Recitals.

- (a) Specialty Systems (the "Company") has requested the City to abate the City's share of all property taxes to be generated for 10 years (specifically, with respect to the payable 2015 through payable 2024 property taxes) on Tax Parcel No. 34-033-3040 (the "Property") to be developed by the Company with the purchase of equipment (the "Project") located in the City. The abatement (the "Abatement") for the 1st year period is estimated to be \$11,541.90 with a present value of \$667,700.
- (b) On the date hereof, the Council held a public hearing on the question of the Abatement, and said hearing was preceded by at least 10 days but not more than 30 days prior published notice hereof.
- (c) The Abatement is authorized under *Minnesota Statutes*, Sections 469.1812 through 469.1815 (the "Abatement Law").
- ii) <u>Findings for the Abatement</u>. The City Council hereby makes the following findings:
 - (a) The Council expects the benefits to the City of the Abatement to at least equal the costs thereof.
 - (b) Granting the Abatement is in the public interest because it will increase or preserve the tax base of the City, help retain and expand commercial and industrial enterprise in the City, and provide employment opportunities in the City.
 - (c) The Council expects the public benefits described in (b) above to be derived from the Abatement.
 - (d) In any year, the total amount of property taxes abated by the City by this and other resolutions does not exceed the greater of ten percent (10%) of the current levy or \$200,000, whichever is greater.
- iii) <u>Terms of Abatement</u>. The Abatement is hereby approved. The terms of the abatement are as follows:
 - (a) The Abatement for the Property (PIN 34-033-6040 shall be for 10 years and shall apply to the taxes payable in the years 2015 through 2024 inclusive.

- (b) The Abatement shall be for 100% of the City's share of the ad valorem property taxes, excluding special debt levies and fiscal disparities, generated by the Property up to a maximum amount as established in a Development Agreement to be entered into between the parties.
- (c) The Abatement may not be modified or changed during the term set forth in (a) above, except with the prior written consent of the City.
- (d) The Abatement shall be subject to all the terms and limitations of the Abatement Law.
- (e) In order to be entitled to the Abatement, the Company shall not be in default within the City of any of its payment obligations respecting any taxes, assessments, utility charges or other governmental impositions.

PUBLIC HEARING/2014 STREET & UTILITY IMPROVEMENT PROGRAM: A duly advertised preliminary hearing for the proposed 2014 Street & Utility Improvement Program was called to order by Mayor Smiglewski at 8:00 p.m. with Dave and Karen Lee in attendance. City Engineer Berryman presented an overview of the proposed improvements. Following discussion concerning proposed improvements and the city's assessment policy and all those present afforded an opportunity to present their views and objections to the making of said improvements, the hearing was closed at 8:20 p.m.

Following discussion Nordaune introduced a resolution and moved its adoption ordering the 2014 Street & Utility Improvement Projects and directing the city engineer to prepare the final plans and specifications and call for bids.

RESOLUTION NO. 14-88

RESOLUTION ORDERING 2014 STREET & UTILITY IMPROVEMENTS
AND DIRECTING PREPARATION OF FINAL PLANS AND SPECIFICATIONS

WHEREAS, after due Notice of Public Hearing on the street and utility improvements for the City of Granite Falls, Minnesota, hearing on said improvements was duly held and the Council heard all persons desiring to be heard on the matter and fully considered the same; and

WHEREAS, at said hearing there was available a reasonable estimate of the amount to be assessed and a description of the methodology, in the form attached hereto as Exhibit A:

NOW THEREFORE, BE IT RESOLVED by the City Council of Granite Falls, Minnesota as follows:

- 1. Said improvements are necessary, cost-effective, and feasible as detailed in the feasibility report.
- 2. It is advisable, expedient and necessary that said improvements as described in the Notice of Hearing thereon be constructed, and the same are hereby ordered made.
- 3. The improvements described in said Notice of Hearing are hereby designated and shall be known as 2014 Street & Utility Improvements.
- 4. The consulting engineers, Rodeberg & Berryman, are hereby directed to prepare final plans and specifications for said improvements and call for bids.
- 5. The City Council declares its official intent to reimburse itself for the costs of the improvements from the proceeds of tax-exempt bonds.
- 6. The City Council shall let the contract for all or part of the work for said improvements or order all or part of the work done by day labor or otherwise as authorized by Minnesota Statutes, Section 429.041, Subd. 2 or Subd. 2a within one year of the date of this resolution ordering said improvements.

GRANITE FALLS, MINNESOTA 2014 UTILITY & STREET IMPROVEMENTS

PRELIMINARY PUBLIC HEARING 8:00 P.M., MONDAY, JUNE 2, 2014

Following is a listing of proposed improvements and estimated assessed costs in accordance with the City's adopted assessment policy.

The City's policy is generally as follows:

New Sanitary Sewer Construction - *1	80%	15 years
Sanitary Sewer Replacement - *1	60%	15 years

Grading & Base - *3	80%	8 years
Curb & Gutter	80%	8 years
Bituminous Surfacing - *3	40%	8 years

^{*1 -} Only one side of corner lots assessed. Overbuilds for trunk lines not assessed.

^{*2 -} Storm sewer construction is assessed based upon square footage of property within the drainage area. 60% of the square footage within the drainage area is actually assessed. Actual assessment is $0.80\ (0.6) = 0.48$ or 48%.

^{*3 -} Corner or double fronting lots are assessed for 75% of the frontage.

Any portion of all of the assessed costs may be paid within 30 days of the final hearing with no interest charged.

Any assessments not paid within 30 days will be added to the property taxes, payable over the above indicated times with interest. Interest rate would be the rate of the bond sale plus 1% per State Statutes.

PROPOSED IMPROVEMENT PROJECTS

Project 1 - I & I Reduction Projects

Project 1 is proposed to improve some of the infiltration and inflow issues within the City. Manhole flow monitoring completed by Stantec, Inc. seemed to indicate very high rates of infiltration on 5th Avenue, between 2nd Street and 3rd Street, as well as the lines to the north on 2nd Street and 3rd Street. TV inspections similarly show significant cracking, holes, blockage, debris, etc. in the pipe.

The I & I reduction projects consist of replacement of the sanitary sewer on 5th Avenue, from 2nd Street to 3rd Street, on 2nd Street from 5th Avenue north one block to the baseball field concession stand and on 3rd Street from 5th Avenue north two blocks to 4th Avenue. These projects will be identified as projects 1A, 1B and 1C respectfully, on the attached map.

Since the sewer and water appear to be in the same trench, the existing 4 inch watermain will have to be replaced at the same time with new 8 inch except on 2nd Street where there is no existing watermain. Storm sewer catch basin leads will have to be replaced where crossed as well.

Also, a very large hole in the sanitary sewer south of the American Legion will be repaired. This repair is identified as Project 1D on the attached map.

Project 2 - Jordan Drive Utility & Street Extension

Sanitary sewer, watermain, and storm sewer will have to be extended to serve the new Granite Manor Health Center site. Similarly, Jordan Drive will have to be extended easterly and south aligning with East Skyline Drive to provide access.

Proposed utility improvements would involve new 8 inch sanitary sewer, new 8 inch watermain, and new concrete storm sewer to provide drainage.

Proposed street improvements would involve complete new construction including excavation, geotextile fabric, aggregate base, new curb & gutter on both sides and plant-mixed bituminous. A 9 ton pavement design would be used on East Skyline Drive extended north from County Road 38 to the building site along which truck deliveries are anticipated. Jordan Drive would be a standard 5 ton pavement design. All streets would be 36 feet in width.
