OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION JANUARY 20, 2015

A regular session of the Granite Falls City Council was called to order by Mayor David Smiglewski at 7:30 p.m., Tuesday, January 20th, in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Sarina Otaibi, Steve Nordaune, Steve Schaub, Joe Fagnano and Scott Peterson. Staff present: City Manager Bill Lavin, Finance Director Michael Betker and City Clerk Joan Taylor. Also in attendance were Police Chief Struffert, Assistant Chief Beninga and Patrolman Brovold, Ambulance Director Gene Hughes, Electrical Superintendent Don Reznechek, Tom Cherveny, Cordelle Thomasma from Barr Engineering and Advocate Tribune News Reporter Scott Tedrick.

- MINUTES: M/S NORDAUNE/SCHAUB TO APPROVE THE MINUTES OF THE JANUARY 5th REGULAR MEETING. Motion carried unanimously.
- BILLS: M/S NORDAUNE/SCHAUB TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously.
- LIFE SAVING AWARDS: Ambulance Director Gene Hughes was in attendance to present lifesaving awards to Assistant Chief Joel Beninga and Patrolman Mitch Brovold.
- REPORTS: The following reports were acknowledged at this time EDA Board, Fire Department, Hospital Board, Police Chief, Planning Commission and Granite Falls Historical Society.
- DEER DEPREDATION: Council reviewed a report from Assistant Police Chief Beninga relative to the special permit archery hunt held within the city limits in 2014. Ten permits were issued and a total of two deer were harvested. Following discussion, it was the consensus of council to offer the archery deer hunt again in 2015.
- MNVCLP: M/S NORDAUNE/SCHAUB TO APPOINT CITY MANAGER LAVIN AS THE VOTING DELEGATE AND MAYOR SMIGLEWSKI AS AN ALTERNATE VOTING DELEGATE TO THE MINNESOTA VALLEY COOPERATIVE LIGHT & POWER ASSOCIATION. Motion carried unanimously.
- ELM STREET: Following discussion and upon the recommendation of Police Chief Struffert it was the consensus of council to place a yield sign on Hungry Hollow Boulevard where it enters Elm Street.
- PIONEERLAND LIBRARY BOARD: Council was advised of the need to appoint a member to the Pioneerland Library Board as Mr. Loewe has resigned.
- BOARDS & COMMISSIONS: Nicole Zempel's name was submitted for consideration for appointment to the Park Board. Following a vote of council, M/S

FAGNANO/GALOW TO RE-APPOINT DAVE NORDAUNE TO THE HOSPITAL BOARD. Motion carried unanimously.

WATER TREATMENT PLANT: Upon the recommendation of the city's consulting engineer, Nordaune introduced the following resolution and moved its adoption authorizing execution of Change Order No. 1 to the Water Treatment Plant Demolition Project.

RESOLUTION NO. 15-6

RESOLUTION AUTHORIZING EXECUTION OF CHANGE ORDER NO. 1 – WATER TREATMENT PLANT DEMOLITION

WHEREAS, pursuant to Resolution No. 14-149 council accepted the bid received from MAAC, Inc. in the amount of \$607,000 for demolition of the old Water Treatment Plant and site restoration; and

WHEREAS, due to issues encountered during construction it has been recommended that Change Order No. 1 be approved which includes the following:

- Footings needed to be placed two feet deeper than originally planned to achieve 4' of cover for frost protection; and
- Forming and pouring a short piece of wall to support the existing retaining wall near the area where it connects to the new retaining wall; and
- Additional footings and retaining wall height made necessary by utilizing the north wall of the clearwell;

for a total increase to the contract price with MAAC, Inc. in the amount of \$16,238.30.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, authorizing execution of Change Order No. 1 to the contract with MAAC, Inc. as stated above for an increase in the contract price of \$16,238.30.

WETLANDS MANAGEMENT: Council reviewed correspondence received from the DNR concerning the growth of cattails in Bullhead Slew on the south side of Trunk Highway 67. Following discussion it was the consensus of council for the city to apply for an Aquatic Plant Management Permit through the DNR which would allow the city to utilize a herbicide application to control and kill the cattails.

- MEMORIAL PARK: The Regional Development Commission suggested that a task force be formed to provide input in preparing the Memorial Park Master Plan. It was suggested that a representative from the Park Board, the Granite Falls Area Arts Council, GFRR, Granite Falls Historical Society, Chamber of Commerce, and CURE be among the groups to contract for possible representation on this task force.
- SANITARY SEWER LIFT STATION: Council reviewed an update relative to the Sanitary Sewer Lift Station Project.
- PEDESTRIAN BRIDGE: Council discussed correspondence received regarding the bond funds relative to the Pedestrian Bridge Rehabilitation Project.
- RIVER ICE CONDITIONS: Staff advised council that city staff has been monitoring ice conditions along the alleyway adjacent to Prentice Street. Council was advised that the river has dropped over 2 ½ feet over the last few days.
- WARNING SIRENS: Electrical Superintendent Don Reznechek was in attendance to discuss with council the problems that have been experienced with the warning sirens.

Council was advised that the signals sent from the Sheriff's Office have been reset and is now working, one of the sirens will need to be replaced and new batteries installed in others.

- CAPX 2020: Staff advised council that the Federal Energy Regulatory Commission has now formally approved CMMPA's right to recover revenue based on its ownership interest in the CAPX 2020 Project and now CMMPA can begin to distribute the revenue received to its membership. Since the city owns a share in the CAPX investment the city will now receive a monthly payment relative to the CAPX project from CMMPA.
- TURBINE REPLACEMENT PROJECT: Cordelle Thomasma from Barr Engineering was in attendance to discuss with council the delays in the Turbine Replacement Project.
