SANITARY SEWER LIFT STATION: Council reviewed an update relative to the Sanitary Sewer Lift Station Project.

PEDESTRIAN BRIDGE: Council also discussed an update relative to the Pedestrian Bridge Project. They also reviewed the draft language for legislation that may be included in a bonding bill that would extend the time period for spending state bonding dollars from June 30, 2105 until December 31, 2015.

VOLSTEAD HOUSE FOUNDATION REPAIRS: The plans and specifications for the repairs to the Volstead House foundation have been completed and sent to the State Historic Preservation Office for review and approval. Following discussion relative to the

planned start date of June 1st, it was the consensus of council to remove this language from the plans and specifications.

WARNING SIRENS: Staff advised council that all sirens are now functioning properly except the old siren off of County Road 5. Following review of a drawing showing the coverage of the working sirens, it was the consensus of council to obtain a cost estimate for replacement of the old siren to determine if that siren should be replaced.

LEVEE CERTIFICATION: Council reviewed the minutes of a meeting held on February 4th regarding the certification of the city's levee.

PERSONNEL: Upon the recommendation of the Wage & Salary Committee Nordaune introduced the following resolution and moved its adoption to increase the hourly wage of the part-time police officers from \$17.46 to \$18.90 to be comparable to Yellow Medicine County part-time wages.

RESOLUTION APPROVING SALARY ADJUSTMENTS FOR PART-TIME POLICE OFFICERS

WHEREAS, the Wage & Salary Committee has recommended an increase in the hourly wage for the part-time police officers from \$17.46 per hour to \$18.90 per hour.
