A regular session of the Granite Falls City Council was called to order by Mayor Dave Smiglewski at 7:30 p.m., Monday, July 6th, in the Council Chambers of City Hall. ACTIVE TRANSPORTATION PLAN: It was the consensus of council that the city would be interested in development of an Active Transportation Plan. The purpose of this plan is to provide strategic direction for policy and future investment decisions

regarding ADA compliant curb ramps, sidewalk and/or bike infrastructure policy considerations.

OPEN HOUSE: Staff reminded council of the Open House scheduled for July 7th from 4:00 to 6:00 p.m. at City Hall regarding the Highway 67 & 212 road project.

TURBINE REPLACEMENT PROJECT: Council reviewed an update relative to the Turbine Replacement Project. Following review and discussion regarding the report from Barr Engineering regarding repairs to generator #1, Galow introduced a resolution authorizing execution of a contract with L & S Electric, Inc. to complete the repairs necessary to generator #1 in an amount not to exceed \$123,000. Financing for these repairs will come from the Light Fund.

RESOLUTION NO. 15-98

RESOLUTION AUTHORIZING EXECUTION OF CONTRACT WITH L & S ELECTRIC, INC. - TURBINE REPAIRS

WHEREAS, a contract has been submitted by L & S Electric, Inc. in an amount not to exceed \$123,000 to complete repairs required to Generator #1.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, authorizing execution of a contract with L & S Electric, Inc. in an amount not to exceed \$123,000 to complete necessary repairs to Generator #1 at the Hydro Electric Plant.

WATER TREATMENT PLANT SITE RESTORATION: Council was advised of a scheduled meeting relative to the Water Treatment Plant Site Restoration Project which has been scheduled for Tuesday, July 7th.

SANITARY SEWER LIFT STATION: Council was updated relative to the Sanitary Sewer Lift Station Project. Resurfacing of the skate park was discussed.

- PEDESTRIAN BRIDGE: An update regarding the progress on the Pedestrian Bridge was reviewed by council.
- RIFFLE HABITAT IMPROVEMENTS: Council reviewed correspondence received from the DNR regarding its re-arranging of the existing rock just below the 212 bridge making the site a better fish habitat and safer for canoers.
- MEMORIAL PARK: Staff advised council that the tour taken by the Greater Minnesota Parks and Trails Advisory Committee of Memorial Park went very well.
- WASTEWATER TREATMENT PLANT: As the Facilities Plan will need to be amended and a Backup Biosolids Plan will need to be completed, Fagnano introduced the following resolution and moved its adoption amending the engineering contract with Rodeberg & Berryman/Stantec in the amount of \$10,500 to cover the addition engineering fees.

RESOLUTION NO. 15-99

RESOLUTION AMENDING ENGINEERING CONTRACT – PHASE 1 WASTEWATER TREATMENT PLANT REPAIRS

WHEREAS, pursuant to Resolution No. 14-89 council authorized execution of contract with Rodeberg & Berryman working with Stantec Consulting Services to complete the plans and specifications, geotechnical investigation (soil borings), preliminary testing, surveying and design work for Phase 1 improvements to the Wastewater Treatment Plant (reed beds), at an estimated costs of \$182,000; and

WHEREAS, pursuant to Resolution No. 14-147 council accepted the Recommended Scope for Phase 1 of the Wastewater Treatment Plant Improvements and an increase in the engineering fees to \$202,500.

WHEREAS, it has now become necessary to amend the Facilities Plan to remove the reed beds from Phone 1 Improvements and to complete the Backup Biosolids Plan all of which will result in additional engineering fees of \$10,500.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, amending the engineering agreement to include the amendment to the Facilities Plan and completion of the Backup Biosolids Plan at a cost not to exceed \$10,500 for a total engineer fee for Phase 1 improvements of \$213,000.
