# OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION AUGUST 3, 2015

A regular session of the Granite Falls City Council was called to order by Mayor Dave Smiglewski at 7:30 p.m., Monday, August 3<sup>rd</sup>, in the Council Chambers of City Hall. - MINUTES: M/S GALOW/NORDAUNE TO APPROVE THE MINUTES OF THE JULY 20<sup>TH</sup> REGULAR MEETING. Motion carried unanimously.
- BILLS: M/S NORDAUNE/SCHAUB TO APPROVE BILLS PRESENTED FOR PAYMENT. Motion carried unanimously.
- CGMC: Marty Seifert, Lobbyist for the Coalition of Greater Minnesota Cities was in attendance to report on the 2015 Legislative Session.
- REPORTS: The following reports were acknowledged at this time Building Inspector, Finance, Fire Department, Kilowatt Community Center Board, Public Works and Utilities Commission.
- UTILITIES COMMISSION: Council discussed consideration of a future sewer rate increase.
