

OFFICIAL CITY COUNCIL PROCEEDINGS  
REGULAR SESSION  
JANUARY 21, 2020

A regular session of the Granite Falls City Council was called to order by Mayor Smiglewski at 7:00 p.m., Tuesday, January 21<sup>st</sup> in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Sharon PaziZea, Steve Nordaune, Brad Peterson, Joe Fagnano and Scott Peterson. Staff present: City Manager Crystal Johnson, Finance Director Neal Carstensen and City Clerk Joan Taylor. Also, in attendance were EDA Director Cathy Anderson, Ron Skjefte and Advocate Tribune News Reporter Jess Gorman.

CONSENT AGENDA: M/S/P GALOW/NORDAUNE TO APPROVE THE CONSENT AGENDA AS FOLLOWS: Minutes, Bills, Building Inspector's Report, Finance Report, Police Chief's Report and Meetings & Events.

REPORT: The EDA Board report was acknowledged at this time. Council then discussed a loan from the 811 Revolving Loan Fund. Following discussion Nordaune introduced a resolution and moved its adoption approving a loan to Falls Boutique in the amount of \$10,000 at 3% interest for 7 years.

RESOLUTION NO. 20-7

RESOLUTION APPROVING LOAN FROM  
811 REVOLVING LOAN FUND TO FALLS BOUTIQUE

WHEREAS, Falls Boutique has applied to the EDA for a loan from the 811 Revolving Loan Fund in the amount of \$10,000 to; and

WHEREAS, the Economic Development Authority at its January 13<sup>th</sup> meeting recommended council approve a loan from the 811 Revolving Loan Fund in the amount of \$10,000 at an interest rate of 3% payable over a term of seven years contingent.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA approving a loan from the 811 Revolving Loan Fund in the amount of \$10,000 to Falls Boutique at an interest rate of 3% payable over 7years contingent.

ORDINANCE: M/S NORDAUNE/PAZI ZEA TO HAVE THE SECOND READING AND SUBSEQUENT ADOPTION OF AN ORDINANCE AMENDING TITLE IX: BY ADOPTING CHAPTER 97.

ORDINANCE NO. 199, 2<sup>ND</sup> SERIES

AN ORDINANCE OF THE CITY OF GRANITE FALLS, MINNESOTA, AMENDING TITLE IX: GENERAL REGULATIONS, BY ADOPTING CHAPTER 97, BEEKEEPING

The City of Granite Falls does ordain as follows:

Section 1:

City Code Chapter 97, Beekeeping, is hereby adopted to read as follows:

- 97.01 Definitions. For purposes of this chapter the following definitions shall apply unless context clearly indicates or requires a difference meaning:
- A. "Apiary" means the assembly of one or more colonies of bees at any one location.
  - B. "Beekeeper" means a person who owns or has charge of one or more colonies of bees.
  - C. "Beekeeping Equipment" means anything used in the operation of an apiary, such as hive bodies, supers, frames, top and bottom boards and extractors.
  - D. "Colony" means an aggregate of bees consisting principally of workers, but when perfect having one queen and at times drones, brood, combs and honey.
  - E. "Hive" means the receptacle inhabited by a colony that is manufactured for that purpose.
  - F. "Honeybee" means all life stages of the common domestic honeybee, *apis mellifera* (African subspecies and Africanized hybrids are not allowed).
  - G. "Lot" means a contiguous parcel of land under common ownership.
- 97.02 Purpose. The purpose of this section is to establish certain requirements for beekeeping within the City.
- 97.03 Standards of Practice.

- A. Honey bee colonies shall be kept in hives with removable frames which must be kept in sound and usable conditions.
- B. Beekeepers.
  - 1. Must ensure that no wax comb or other material that might encourage robbing by other bees are left upon the grounds of the apiary lot. Such materials once removed from the site shall be handled and stored in sealed containers or placed within a building or other vermin-proof container.
  - 2. Shall maintain beekeeping equipment in good condition, including keeping the hives painted if they have been painted but are peeling or flaking and securing unused equipment from weather, potential theft, vandalism and occupancy by swarms.
- C. Bee colonies may be kept in the following residential zoning districts:
  - 1. Agricultural.
  - 2. R-1 low density residence.
  - 3. R-2 medium density residence.
  - 4. R-M multiple dwelling residence district.
  - 5. Commercial

Honey bee colonies may be kept on a two-family property if it is zoned R-2 and a resident owner of the property is the beekeeper.

#### 97.04 Hives.

- A. Are not permitted in a front yard or in a street side yard.
- B. Shall be located at least 25 feet from all interior property lines and 25 feet from an alley right of way.
- C. Shall be at least 25 feet from a principal building on an abutting lot.
- D. In each instance where a colony is kept less than 25 feet from a property line on the lot upon which the apiary is located, the beekeeper shall establish and maintain a flyway barrier 6 feet in height as follows:
  - 1. The flyway barrier must extend 10 feet in either direction from the hive along the property line.
  - 2. Barriers may be made of a wall, fence or dense vegetation. A combination of these things is permissible.
- E. A fence permit is required. Information on fencing permits can be obtained through the City clerk.

- F. Sale of honey and hive products from a beekeepers residence is permitted as a home business, subject to such rules and regulations as may be adopted from time to time by the city council and the following:
  - 1. The beekeeper must live on the lot except as may be otherwise approved by the planning commission.
  - 2. The honey and hive product are from hives owned by the property owner.

3. In any instance in which a colony exhibits unusually aggressive behavior it shall be the duty of the host to take appropriate action to address the behavior.

97.05 Colony Density. The following numbers of colonies are permitted:

- A. Lots less than 21,780 sq. ft. (2 acre): two colonies.
- B. Larger than 2 acre: four colonies.

97.06 Beekeeper Training. Prior to obtaining an initial permit a beekeeper must provide:

- A. A beekeeping course completion certificate or letter from an educational institution that offers a beekeeping course.
- B. Verification of equivalent experience for the honeybee keeping course.

97.07 Permit Required. Beekeeping may occur on any property in the city upon issuance of an annual permit to the beekeeper on that specific property which shall expire on December of each year. Permit fee is established by the city council. The permit must be submitted by the owner of the property.

A. A beekeeping permit will be issued if:

- 1. The requirements of this section have been met.
  - 2. Notices have been mailed to all property owners within 150 feet of the applicant's property line. This includes properties located outside of city limits when required.
  - 3. Upon approval of the planning commission, provided no action shall be taken by the planning commission until not less than 10 days have lapsed since the mailing of notices to all property owners within 150 feet of the applicants property line.
- B. If there are no objections received within 10 days of mailing the notices, then the permit application will be processed by city staff following review and approval by the planning commission.

C. Permits are non-transferable and do not run with the land.

D. By signing the permit, the beekeeper acknowledges that he or she shall defend and indemnify the city against any and all claims arising out of keeping the bees on the premises.

E. The city council shall establish shall establish the permit fee. For each subsequent permit there shall be no fee for the permit unless there are substantial changes to the apiary or there is a new beekeeper.

- F. If the standards of practice are not maintained subsequent to issuance of a beekeeping permit, the permit may be revoked by the city.
- G. Sales of honey or hive products from the home must be stated on the permit.

97.08 Penalty for Violation of Section. Any person who shall violate the provisions of this section shall be guilty of a misdemeanor.

Section 2. City Code Chapter 10, General Code Construction; General Penalty, Including Penalty Provisions, is hereby adopted in its entirety by reference as though verbatim herein.

Section 3. This ordinance to become effective from and after its passage and publication according to law.

Adopted by the City Council of the City of Granite Falls, Minnesota, this 21<sup>st</sup> day of January, 2020, by a unanimous vote of the Council of those present.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, establishing a beekeeping permit fee of \$25 annually.

MN RIVER BASIN WATER STORAGE BILL: Following discussion Nordaune introduced a resolution in support for managing water flows in the Minnesota River Basin through increased water storage and other strategies and practices.

RESOLUTION NO. 20-14

SUPPORT FOR MANAGING WATER FLOWS IN THE MINNESOTA RIVER BASIN THROUGH INCREASED WATER STORAGE AND OTHER STRATEGIES AND PRACTICES

WHEREAS, A fraction the natural water storage that once existed on the landscape in the form of prairie potholes, wet meadows and shallow lakes in the Minnesota River Basin has been converted to dry usage; and

WHEREAS, ever-increasing impervious surfaces in municipal areas together with existing and increased agricultural drainage coupled with significantly increased precipitation patterns is dramatically increasing water flows in all our streams, lakes and rivers; and

WHEREAS, fast-rising, high water levels in rivers and streams flood adjacent low-lying areas, erode stream banks, create backups on existing tile and ditch systems, and increase sediment transfer downstream; and

WHEREAS, many acres of farm fields are flooded each year, sometimes multiple times each year, by river and stream flooding thereby preventing planting or destroying growing crops; and

WHEREAS, storing water in upstream areas of the landscape will mitigate and slow the amount of water moving into rivers and streams and reduce flooding and erosion; and

WHEREAS, storing water in upstream areas of the landscape and other strategies such as improving soil health will mitigate and slow the amount of water moving into rivers and streams and reduce flooding and erosion; and

WHEREAS, the Minnesota River Congress, a citizen-led group focusing on the natural resources and economic health of the Minnesota River Basin, is spearheading an initiative to increase water storage on the landscape using recommendations from the Collaborative for Sediment Source Reduction (CSSR) study as well as the Management Options Simulation Model (MOSM) study recommendations in conjunction with the rich datasets available through state agency monitoring, assessment and conservation targeting (WRAPS, TMDLS, 1W1P) to support the case for the need for more water storage as a basis for its initiative; and

WHEREAS, the Minnesota River Congress is planning to introduce legislation at the state and federal levels to secure significant funding for surface water storage on the landscape in the Minnesota River Watershed.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF GRANITE FALLS, MINNESOTA, that the City supports the Minnesota River Congress in its efforts to increase water storage on the landscape and manage the flow of water in the Minnesota River Basin; and

BE IT FURTHER RESOLVED that the City supports the Minnesota River Congress in its efforts to secure state and federal funding targeted specifically to increase surface water storage in the Minnesota River Watershed.
