CITY OF GRANITE FALLS OFFICIAL CITY COUNCIL PROCEEDINGS REGULAR SESSION November 6, 2023

A regular session of the Granite Falls City Council was called to order by Mayor Steve Nordaune at 7:00 p.m., Monday, November 6, 2023 in the Council Chambers of City Hall. Council members present: DuWayne Galow, B. Peterson, Joe Fagnano and Scott Peterson. Council Absent: Sharon Pazi Zea. Staff present: City Manager Crystal Johnson, Finance Director Neal Carstensen and City Clerk Christine Kleven. Also in attendance: Keith Woods and Dan Barber.

- CONSENT AGENDA: M/S B. PETERSON/GALOW TO APPROVE THE CONSENT AGENDA WITH ADDITIONAL BILLS AS FOLLOWS: Minutes, Bills, Building Inspector's Report, Public Work's Report, Correspondence and Meetings & Events. Motion passed unanimously by those present.
- REPORTS: The Airport Commission, Utilities Commission and Liquor Committee reports were acknowledged at this time.
- T-HANGAR UTILITY SERVICE: In a special meeting regarding electricity usage in the new Thangar building, concerns were raised about the base meter fee imposed by Minnesota Valley REC for individual meters; expressing it was too high and could lead tenants to seek hangar space elsewhere. The Airport Commission proposed a solution: installing a single meter, billing the city, and charging a monthly electricity fee of \$15.00 for hangars and storage rooms, and \$25.00 for the Jet pod. After six months, fees will be reassessed to ensure full coverage of the electric bill; any excess payments received by the city will be applied to the hangar loan. By consensus council approved the recommended fees, forgoing separate meters, and reviewing costs after six months.
- LIQUOR COMMITTEE: Additional members are needed from the council. Staff will verify the number of council members allowed.
- APPOINTMENT: M/S B. PETERSON/S. PETERSON TO APPOINT GRANITE FALLS RESIDENT LYNN ULLRICH TO THE KCC BOARD. Motion Passed unanimously by those present.
- APPOINTMENT: An application of interest was presented for consideration from Stan Kompelien to join the Planning Commission.
