

OFFICIAL CITY COUNCIL PROCEEDINGS
REGULAR SESSION
November 15, 2021

A regular session of the Granite Falls City Council was called to order by Mayor Dave Smiglewski at 7:00 p.m., Monday, November 15, 2021 in the Council Chambers of City Hall. Council Members present: DuWayne Galow, Steve Nordaune, Brad Peterson, Joe Fagnano and Scott Peterson. Council member absent: Sharon Pazi Zea. Staff present: City Manager Crystal Johnson, Finance Director Neal Carstensen and City Clerk Christine Kleven. Also in attendance: Tim Knapper.

CONSENT AGENDA: M/S NORDAUNE/GALOW TO APPROVE THE CONSENT AGENDA AS FOLLOWS: Minutes, Bills, Finance Report, Police Chief's Report, Correspondence and Meetings & Events. Motion passed unanimously by those present.

SENIOR CENTER IMPROVEMENTS: Tim Knapper requested approval to renovate the space used as the Senior Center in the city owned Library building. They have their own funding and design plan. M/S NORDAUNE/B. PETERSON TO APPROVE THE PLAN TO RENOVATE THE SENIOR CENTER SITE IN THE LOWER LEVEL OF THE CITY OWNED LIBRARY BUILDING. Motion passed unanimously by those present.

REPORTS: Airport and Planning Commission reports were presented at this time.

AIRPORT LAND LEASE AGREEMENTS: The Airport Commission recommend increasing the 3-year land lease agreements to \$135 per acre. Nordaune introduced a resolution and moved its adoption accepting the proposed Airport Farmland Lease increase.
