**Public Involvement Strategy****Bev O'Dea**

- The PT will need to determine a Public Involvement strategy
- This strategy will be deployed in 2 phases
  - Early in the plan development-gauge the public's perception of Risk
  - Prior to adoption-to allow public comment on the draft plan
