COMMUNICATIONS:

SCHOOL SUPERINTENDENT AND SCHOOL COMMITTEE: Superintendent DeBarge and School Committee Chair Proietti reported the following:

- Review of the NESDEC (New England School Development Center) report of enrollment projections and facilities assessment.
- Resume discussion to redistrict the schools and place students into the appropriate elementary schools.

Councilors asked the following questions:

- School Committee and parent's groups would oversee the decisions regarding school redistricting and planning.
- Green River School's extensive modification and structure expenses.
- Plan for students from the Four Corners school to be relocated due to the reduction of classrooms.
- Additional kindergarten class at the Newton school decision made prior to the budget and allocation.

MAYOR, CITY OFFICERS AND EMPLOYEES: Mayor Roxann Wedegartner reported the following:

• Health Department received a \$300,000 dollar grant from the Department of Public Health. It was a multi-year grant spanning over three years for the ability of smaller surrounding communities to access quality health services.

Councilors asked the following questions:

- Effect this newly proposed zoning amendment on marijuana cultivation, if passed by the Council, would have on the approved facility located on Leyden Road.
- Update on the new City of Greenfield website.
- Grant received by Health Department to be used exclusively for the smaller surrounding communities or would the City of Greenfield also benefit from this funding.
- Any benefits Greenfield received from aiding and assisting smaller surrounding towns.
- Source of funding for officers on paid administrative leave after the Council voted to reduce the wages in the Police FY2023 budget.
- Update on expected layoffs of police officers due to the reduction in police salaries voted by the Council.
- IT department member physically present at next meeting to address technical difficulties with the Zoom remote access issues.
- Further elaboration on the grant the Health Department received and how the funding would be distributed towards assistance to the smaller surrounding communities.
- Review of a report from Generation Ratify on their gender pay equity study.

At 7:06 pm, the audio and video was restored on Zoom.

Exhibit A

(2) Signs in the Central Commercial District.

(a) One (1) sign for each establishment located on the ground floor in and along the frontage of a building. The sign(s) shall be affixed to the frontage wall of the building. If a building fronts on more than one (1) street, both frontage walls may be used for all such signs. The total combined area of such signs shall not exceed ten percent (10%) of the area of the building face upon which the signs are attached or a maximum of forty-five (45) square feet per sign, whichever is less. Individual signs shall be sized based on the building face area occupied by each establishment. Such signs shall include wall, projecting, marquee signs and awnings.

(3) Signs in the Limited Commercial, Office, and General Industry Districts.

(a) One (1) sign for each establishment in a building affixed to one (1) wall of a building. If a building fronts on more than one (1) street, only one (1) wall may be used for such signs. If a building fronts on more than one (1) street, both building faces may be used for all such signs. The total combined area of such signs shall not exceed ten percent (10%) of the area of the building faces upon which the signs are attached. or a maximum of The total signage on the building shall not exceed forty-five (45) square

feet per sign whichever is less. Such signs shall include wall, projecting, marquee signs and awnings.

(5) Signs in the General Commercial District.

(a) One (1) sign for each establishment in a building affixed to one (1) wall of a building. If a building fronts on more than one (1) street, only one (1) wall may be used for such signs. If a building fronts on more than one (1) street, both building faces may be used for all such signs. The total combined area of such signs shall not exceed ten percent (10%) of the area of the building faces upon which the signs are attached. or a maximum of The total signage on the building shall not exceed sixty-four (64) square feet, whichever is less. Such signs shall include wall, projecting, marquee signs and awnings.

C. General sign regulations.

(1) Wall signs may be painted on or attached to the wall of a building, shall be in the same plane as the wall, and shall not project from the wall by more than twelve (12) inches.

(2) Projecting signs shall not project more than three (3) feet from the face of the building, shall not project over a public street, and shall have a minimum clearance of eight (8) feet above the sidewalk and thirteen (13) feet above an alley, driveway, or private street. Projecting signs shall project from the wall at a ninety-degree angle. Projecting signs shall not extend vertically above the windowsill of the second story and shall not block the visibility of any other sign. Projecting signs over the public right-of-way require both a sign permit and license from the Greenfield Licensing Commission.

(5) Dynamic display signs also known as electronic message centers shall be prohibited. Dynamic display signs also known as electronic message centers -- means any sign designed for outdoor use that is capable of displaying an electronic signal, including, but not limited to, cathode-ray tubes (CRI), light-emitting diode (LED) displays, plasma displays, liquid-crystal displays (LCD), or other technologies used in commercially available televisions or computer monitors. Signs with this technology which are placed by a public agency for the purpose of directing or regulating pedestrian or vehicle movement use-are exempt from this chapter. Dynamic displays shall comply with the following:

(a) Minimum display time between display changes shall be 30 seconds. Transition time to next display shall be less than one second.

(b) Display boards shall not emit sound.

⁽c) The display must be turned off at 11:00 p.m. or at the close of business, whichever is later.

(d) Signs must have photocells that automatically dim in dark conditions in direct correlation to natural ambient light conditions. At no time shall the sign lights be greater than 0.3 footcandle above ambient light conditions.

(1213) Awnings are coverings either permanently attached to the building or which can be raised or retracted to a position against the building when not in use. Any lettering larger than six (6) inches in height or symbols exceeding four (4) square feet in area shall be included in the total area of signage allowed on the face of the building. The entire illuminated area of an awning shall be considered part of the sign area. Awnings projecting over the public right of way require a license from the Greenfield Licensing Commission.

(4718) Sandwich board signs are permitted directly in front of the place of business in the Central Commercial, and Limited Commercial, and General Commercial Districts only. All sandwich board signs in the public right of way must receive a license from the Greenfield Licensing Commission. A reproduction of such license shall be attached to the sign. All sandwich board signs on private property shall not exceed three (3) feet in height and two (2) feet in width. [Added by the Town Council on November 18, 2009]. The following standards shall apply to sandwich board signs:

- (a) No sandwich board sign shall be attached to, or leaned against, any street furniture, utility facility (including poles and boxes), street light or any other sign;
- (b) No sandwich board sign shall be placed in such a manner as to reduce the unobstructed path of travel on any sidewalk to less that forty-eight (48) inches wide, and if the existing unobstructed path of travel of a sidewalk is forty-eight (48) inches or less in width, no sign shall be placed on said sidewalk;
- (c) No sandwich board sign shall be placed within a curb cut or ramp right-of-way installed to provide improved access to a sidewalk for the disabled or block a path to and from the right-of-way;
- (d) Sandwich board signs may be displayed only during hours of operation.

DISCUSSION: Councilor Elmer reported the Economic Development Committee forwarded a unanimous positive recommendation. Rationale was provided for the proposed amendments. Other comments included:

- The proposed zoning changes did not affect residential, semi-residential and health districts.
- Concern of signs placed on sidewalks that could impede individuals who were handicapped.
- The lack of staff in the Building Inspector Department, who would be the enforcer of these by-laws, would create difficulty to provide enforcement towards code violations.

It was unanimously, 10 yes (2 Councilors were not available at time of vote) **VOTED:** TO APPROVE ORDER NO. FY 22-142.

MOTION: On a motion by Councilor Elmer, second by Councilor Desorgher, it was,

MOVED: THAT IT BE ORDERED THAT THE CITY COUNCIL OF GREENFIELD, PURSUANT TO THE PROVISIONS OF CHAPTER 94G, SECTION 3 OF THE M.G.L., IN ORDER TO IMPOSE REASONABLE SAFEGUARDS ON THE OPERATION OF OUTDOOR MARIJUANA CULTIVATIONS, AND TO RESTRICT THE LICENSED CULTIVATION, PROCESSING AND MANUFACTURING OF MARIJUANA, AMEND THE ZONING ORDINANCE, CHAPTER 200, AS FOLLOWS:

• Section 200-4.2 Rural Residential District (RC) section (C) Uses by special permit, is hereby amended by adding the following new section:

"(22) Marijuana cultivation limited to Tier 1 (5,000 square feet) pursuant to ~200-7.17"

• Section 200-7.17. Marijuana Establishments, is hereby further amended by adding at the end of section (B) 4 the following new language:

"A marijuana outdoor cultivation is limited to Tier 1 (5,000 square feet) per license. No Person or Entity Having Direct or Indirect Control shall be granted, or hold, more than three licenses in a particular class. The maximum outdoor canopy permissible under all licenses for a single parcel is 15,000 sq. ft."

- ~ 200-7.3 Temporary Moratorium on Outdoor Marijuana Cultivation Facilities
- A. <u>Purpose</u>

The City intends to adopt a temporary moratorium on the use of land and structures in the City for all Outdoor Marijuana Cultivation Facilities so as to allow the City sufficient time to engage in a planning process to address the effects of such structures and uses on residential neighborhoods and in the City as a whole; and to amend Section 200-7.17, Marijuana Establishments, of the Zoning Ordinance in a manner consistent with sound land use planning goals and objectives.

B. <u>Definition</u>

MARIJUANA CULTIVATOR – An entity licensed to cultivate, process, and package marijuana, to deliver marijuana to marijuana establishments, and to transfer marijuana to other marijuana establishments, but not to consumers. A Craft Marijuana Cooperative is a type of Marijuana Cultivator. [Definition Added by Town Council on June 20, 2018]

C. <u>Temporary Moratorium</u>

For the reasons set forth above and notwithstanding any other provision of the Zoning Ordinance to the contrary, the City hereby adopts a temporary moratorium on the use of land or structures for all outdoor marijuana cultivation facilities. The moratorium shall be in effect through June 30, 2023. During the moratorium period, the City shall undertake a planning process to address the potential impacts of marijuana cultivation facilities in the City, and shall consider amending Section 200-7.17, Marijuana Establishments, of the Zoning Ordinance to address the impact and operation of outdoor marijuana cultivation facilities on residential neighborhoods and the City as a whole.

DISCUSSION: Councilor Elmer reported the Economic Development Committee forwarded a unanimous negative recommendation. Other comments included:

- Determination was made that a moratorium would not be necessary and could cause all other permits to be stalled.
- Inquired if the Councilors could table this order indefinitely in the off chance it would be a necessary measure in the future.
- It was noted the opinion received by the City Attorney stated this was not a legal measure.

It was unanimously, **DEFEATED:** TO APPROVE ORDER NO. FY 22-162.

There was some confusion if the City Council organized following Biennial elections of every January. Recommendation from A & O Committee at April 13, 2022 meeting

- 565-1A Organizational Meeting: Councilors moved to have annual organizational meetings; however, the ROP states these meetings would be held after regular City elections, which was biannual (every 2 years.)
 - > Amend the language to reflect organizational meetings would be held **annually** (every year).
 - Suggestion to hold the organizational meeting at the end of December. The language could be changed to hold an organizational meeting in January without a specific day.

SECTION 8-8: OATH OF OFFICE OF MAYOR, COUNCILORS, AND SCHOOL COMMITTEE MEMBERS

(a) The Mayor-elect, Councilors-elect and School Committee members-elect shall, on the first business day of the new year, meet and be sworn to the faithful discharge of their duties. - 565-1C Election of Officers: The Treasurer had not been responsible for their budget for many years and had become the responsibility of the Clerk. In doing research, no other Cities in Massachusetts elect a Treasurer.
 - > The City Charter also removed the election of a Treasurer of the Council.
 - The Treasurer's position was not for the purpose of replacing the Vice President or President in a situation where neither of them was unavailable.

I am requesting funding in the amount of \$ 57,955.54 to repair and replace large overhead doors at the Transfer Station. The source of funding will come from repurposing three previous projects. The balances from these three accounts were voted from stabilization and reserve fund which makes the funds available from previous years.

Currently there are two doors that are in disrepair, one is locked in the down position and the other has been secured open. These large overhead doors are commercial grade and approximately 25 years old. Greetings, Councilors,

I am pleased to present this financial order to you along with the tabled order to fund the racial bias and operations audit of the Greenfield Police Department.

Task Force Financial Order

As noted on the Financial Order, this order asks for \$45,000 to be appropriated from General Stabilization for expenses incurred by the Community Task Force on Policing in Greenfield. It is my intention to have the task force financial order total at least \$75,000 as stated by the Council at its July 20 meeting. Per the Financial Order, once the task force structure is finalized and a stipend amount verified, a second financial order will be submitted to cover the stipend amounts.

I anticipate discussing further process and procedural aspects of the task force's scope of work with Councilor Bullock next month when our mutual schedules permit.

Audit Financial Order

Per the Financial Order submitted here, I am requesting that the tabled audit be amended down to

\$100,000.

The audit is important to Greenfield in order to bring more transparency to what are the operational weaknesses and strengths (budgeting, hiring/promoting, culture, accountability, etc.) and to what extent those operational aspects exhibit racial bias. I strongly believe that we cannot move forward fully from the jury finding in the Buchanan/Dodge case without accurate data about our PD rather than perceptions. Additionally, the audit needs to be conducted by an outside consultant with demonstrated skills and expertise in public safety department audits so that the audit is not perceived by citizens and the police department as skewed in any specific direction. As with any outside professional service that we procure, the City pays for expertise that we don't possess within the City's departments. In order to get the quality expertise that we would want for this important endeavor, we need to be able to have a realistic dollar figure for the Request For Proposal (RFP) that would attract a worthy client. The selection of a group to conduct the audit must be done under the 30-B procurement process. An RFP for the project will be posted as required under 30B. As is usually done in that process, a small committee of reviewers will be charged with reviewing the RFP responses, ranking them, and then choosing one under the laws governing how to make that choice. My current thoughts for a committee are: Susan White of the Public Safety Commission; Chair of Ways & Means; an additional member of the Council; a member of the public appointed by me; and Me. Of course, Council member appointments would be up to President Gilmour.
