1. DISCUSS AND ACT ON ORDINANCE NO. 245, AN ORDINANCE MAKING APPROPRIATIONS FOR SUPPORT OF THE CITY OF GREY FOREST, TEXAS AND ADOPTING THE ANNUAL BUDGET OF THE CITY OF GREY FOREST FOR THE 2020/2021 FISCAL YEAR BEGINNING ON OCTOBER 1, 2020 AND ENDING ON SEPTEMBER 30, 2021.

DISCUSS AND ACT ON ORDINANCE NO. 246, AN ORDINANCE ADOPTING THE TAX RATE OF \$0.088441 PER \$100 OF VALUE, WHICH IS EFFECTIVELY A 2.056% INCREASE IN THE TAX RATE, AND LEVYING AD VALOREM TAXES ON ALL PROPERTY SUBJECT TO TAXATION WITHIN THE CITY OF GREY FOREST, TEXAS FOR USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT FOR THE 2020/2021 FISCAL YEAR.
