**AN ORDINANCE CANCELLING THE  
MAY 1, 2021 MUNICIPAL ELECTION.**

**WHEREAS**, Miguel Cantu, City Secretary for the City of Grey Forest has certified that the following persons have filed as candidates for the expired terms of the following offices, to-wit:

**I.**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GREY FOREST, TEXAS** that the City Council for the City of Grey Forest hereby cancels the City of Grey Forest General Election scheduled to be held on May 1, 2021 in accordance with Section 2.053(a) of the Texas Election Code as the following candidates have been certified as unopposed. This cancellation takes effect immediately upon the passage and approval of this ordinance, and the following candidates are hereby elected as follows:

Council Member Place No. 1 – Kimberly A. Verity.  
Council Member Place No. 3 – Geri Eileen Poss  
Council Member Place No. 5 – Sean Paul Skaggs

A copy of this Ordinance will be posted on Election Day at each polling place that would have been used in the election.

**II.  
CUMULATIVE CLAUSE**

This Ordinance shall be cumulative of all provisions of the City of Grey Forest Code of Ordinances except where the provisions of this Ordinance are in direct conflict with the provisions of such Ordinance, in which event the conflicting provisions of such Ordinance are hereby repealed.

**III.  
SEVERABILITY**

That it is hereby declared to be the intent of the City Council of Grey Forest that the phrases, clauses, sentences, paragraphs, and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this Ordinance should be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs, or sections of the Ordinances, since the same would have been enacted by the City Council without incorporation in this ordinance of any such unconstitutional phrases, sentences, paragraphs, or sections.

**IV.  
PROPER NOTICE AND MEETING**

It is hereby officially found and determined that the meetings at which this Ordinance was approved and adopted was open to the public and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government.

**V.  
EFFECTIVE DATE**

This ordinance shall be effective upon passage and publication as required by state and local law.

**VI.**
