### Report Your Concern

Hello Guilford Selectmen's Office,

It has come to my attention, from neighbors Steve & Gretchen O'Connor (265 Old Whitfield St) , that there are ten duplicate letters of support that are currently listed on the town website, in connection with the special permit application (P & Z dept) for a wildlife rescue and rehab facility at 311 Old Whitfield Street.

I am sure these duplicate postings by the P & Z dept. are an accident but it is vital that it get corrected ASAP as it is inflating the supposed numbers of supporters: "over 50 letters of support" was quoted by the Guilford Courier in the June 17th cover page article.

Also, Steve and Gretchen reviewed all of the addresses of the supporting letters (if provided) and only 10 of them were submitted from Guilford residents. For eighteen of them, no addresses were provided and my understanding is that it is customary to require an address in order to file a public comment to preserve the integrity of the process.

Also, the way the letters are grouped together is helping to create a false impression of widespread community support. In hindsight, I wonder if the letters could have been filed by town residents vs. non-residents. Probably not practical to do so at the time they were coming in, but since they have to be reviewed to remove the duplicates, perhaps they can be organized that way now to; given the unusual circumstances related to this public hearing.

The reason for my concern is that there is a false narrative being perpetuated -- by the newspapers and notably the Guilford Courier that "community sentiment seems clearly tilted in DeMond's favor".

The letters of support clearly do not support this conclusion and I am very concerned that this false narrative which suggests widespread support for a wildlife rescue & rehab facility in Guilford, by Guilford residents, may impact decisions that are being made at the upcoming BOS meeting on July 6th and at the next public P&Z public hearing, scheduled for July 7th.

Please note that I have also filed a letter of concern to the P & Z dept. to request the removal of the duplicate letters ASAP and consider removing letters with no address.

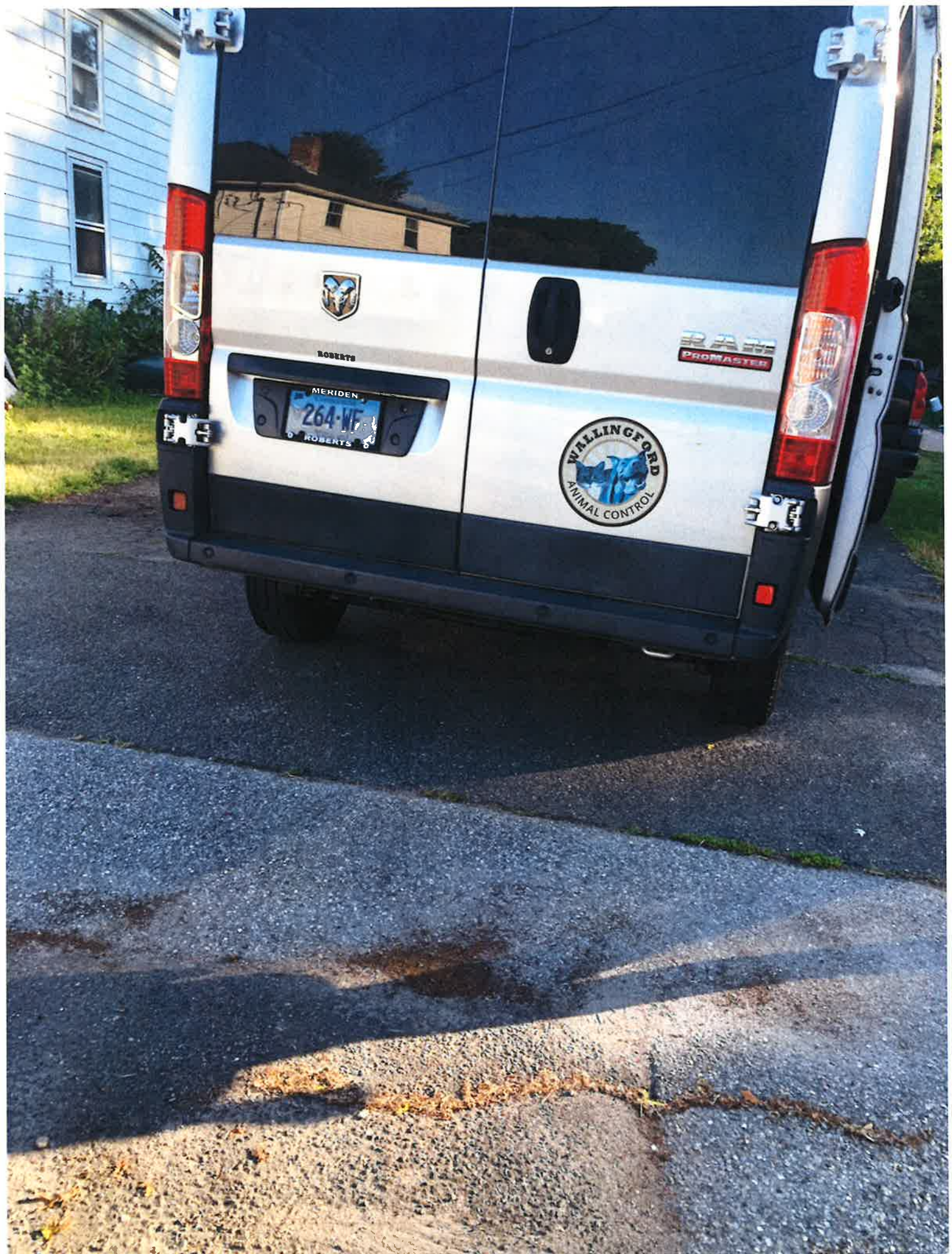

Dear Selectmen,

We live at 265 Old Whitfield Street and are unable to attend the Board of Selectman Meeting on 6 July and we have some concerns regarding the proposed changes to the existing Ordinance Chapter 131 Article III. In particular, we would appreciate clarity from the BoS regarding the following questions/concerns:

1) The revision to Section 131-7 decrees that the Director of Health is authorized to enforce the provisions of Article III, but there is no mechanism referenced for monitoring the compliance of licensed animal rehabilitators/facilities with the regulations.

a) Will there be such a mechanism established or will the Health Department only respond when formal complaints are made (the current process)? Without a regular monitoring process, what assurances do impacted neighbors have that any such facility will remain in compliance?

2) What sort of facility will be allowed? Since DEEP has no specific guidance regarding facility type, how does the town plan to certify that the actual facility will be of sufficient size and integrity to ensure the safety and health of the animals and the community at large? Has the town considered applying the same requirements as those in Zoning Code Chapter 273-22-F?

"All buildings, runs, pens or enclosures designed or intended for occupancy by animals shall be fully enclosed with walls, roof and windows and shall be ventilated by louvered or baffled openings or by mechanical ventilation equipment. All runs, pens or other enclosures designed or intended for occupancy by animals shall be surrounded by walls, solid fences, or earthen berms no less than 6 feet in height."

3) The revision to Section 131-6 describes the waste storage requirements, but minimal detail is provided. Has the BoS considered applying the same requirements as those necessary for a pet boarding facility (Zoning Code Chapter 273-22-F):

"All waste from animals shall be enclosed in enclosures designed to prevent escape of odor or access by insect or other pests. Containers shall be emptied regularly or otherwise disposed of so as to control odor or risks to the public health."

We are supportive of the work that licensed animal rehabilitators do; it is important work. However, the proposed ordinance (as currently written) does not provide assurance that adequate monitoring will be included. We thank you for your consideration of our concerns.

Eunice is the only constantly available rabies vector species rehabilitator in Southeastern Connecticut. The DEEP, CT EnCon Officers, and police and animal control units for Branford, Guilford, and North Branford rely on her heavily to assist with all types of animals, and she's always ready to assist, whether it's an animal she standardly rehabilitates or not. The citizens of Guilford, along with those all over the shoreline also turn to her for all of their questions regarding orphaned and injured wildlife.

Eunice had been a staple of the Guilford community for over a decade, before a new neighbor, knowing full well that wildlife rehabilitation occurred on the property, even going so far as to tell her he admired her work before willingly building his home next door, bided his time and obtained a position on the P&Z board to attempt to shut her down.

We are very short on RVS rehabbers in this state, as they must meet stringent requirements for special permits and jump through all kinds of hoops to get and maintain them. She has met these standards annually, as have her animal enclosures, meeting ongoing licensure requirements. State and local government have been aware of her operations for a decade. No one has ever complained about her rescue before. It isn't an "animal shelter" as the complaint states. It's an asset to your town, and makes leaps and strides towards giving nature something back, as we eliminate habitats and collide with more wildlife, literally and figuratively.

This means help for these animals would be nearly impossible without Eunice, and her rescue Little Rascals. The work she does is incredibly important and ensures that injured and orphaned raccoons, skunks, bats during normal times and opossums/any number of other wild animals that pass through or stay awhile, are returned to the wild, healthy and vaccinated if appropriate to help continue their species, and keep the nature in our area diverse. If we lose Eunice, we will be doing a horrific injustice to not only them, but also our community.

This legislature, meant to protect the public against a new, particularly dangerous strain of rabies in 1991, was enacted when Guilford had no RVS rehabber. A rehabilitator that releases vaccinated animals, keeps all citizens healthy. This outdated wording needs to be fixed, for all of us.

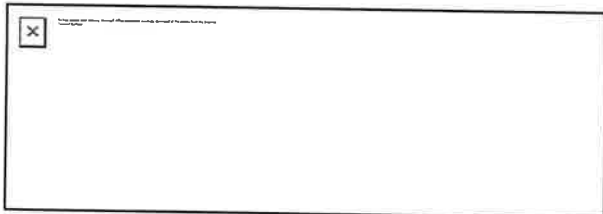
