## Meeting was called to order by Chairman Larkins at 7:05 pm.

- 1. Public Forum (Limited to 3 minutes) Deferred to later in the meeting
- 2. Approval of Minutes: a. February 20, 2020
- *Motion:* Commissioner Tim Sullivan made a motion to approve the February 20, 2020 meeting minutes as presented. Seconded by Commissioner Gene Bishop and unanimously approved.

## 3. **Report from the Public Works Director**

## A. Ongoing & Completed Projects:

- 1. Beaverhead rebuilt shoulder area that wash-out southwest of Overlook Dr., we added large boulder to support the shoulder and a mixed fill, then mulched the shoulder area
- 2. Briarwood Dr. check all the drainage areas for breaches and clogs. Started to make repairs to the catch basins
- Catch basin repair fixed one catch basin at #62 Half Mile Rd., and a catch basin on Joan Dr., #41
- 4. Started to sweep the roads in Town on February 14, 2020. The main roads to be done first
- 5. Guard rail repair continued
- 6. Transfer Station added a new gate at the recycle bin and fixed the sagging entrance gate with new hardware. We will add spring loaded caster wheels to help support the gate in the future
- 7. Vac All continued with better weather to remove leaves in the road gutters

#### 1. Public Forum

Ralph Casey distributed a Highway Vehicles list dated February 21, 2020 to the Commission Members as requested at the last meeting.

- GU55 a 2004 F350 is the next on the list to be replaced. Replace vehicle will be an F550. It is used on a plow route. The old truck should be used for trade-in value on the new truck purchase.
- Ralph recommended to the Commission that the following trucks be kept as spares:
  - i. GU90-1988 MACK RD685P (old GU45)
  - ii. GU46- 2006 MACK CV713 (old GU46)
  - iii. GU44- 1985 MACK R688T (old GU44)
- The GU29 truck has undergone refurbishment by the PW Mechanics and is beautiful.
- Ralph also recommended to the Commission that they purchase a Hook Lift truck.

• Ralph recommended that all Warsaw plows be recycled when trucks are replaced.

Commissioner Tim Sullivan questioned if there are any other vendors other than State Contract that could be looked at? Ralph named two; Truck & Body in Hartford and a company in Stratford; neither are on state contract.

      - 1) Truck with all season body. Approximate cost of \$137K
      - 2) Truck with a regular body and a slide in sander. Approximate cost of \$130K
      - Put a new cab and chassis on the existing dump body. Approximate cost \$129K

#### 9. Other Business

Chairman Mark Larkins was approached by Park & Rec to have Public Works donate site excavation to the Jacobs Beach Splash Pad project. There was discussion among the Commission regarding the necessity for the project. Public Works Director Tom Fillion stated that they would accommodate the request.

The Golf Course has received a \$10K donation to complete repaying of their parking lot. Tom Fillion stated that Public Works will do the prep work for the parking lot paying.

a. Brush & Leaf Ticket Update

Sally Berezowskyj updated the Commission on the status of raising the prices at the Brush and Leaf Disposal Site. For some reason, the rates for the Brush & Leaf site are included in an existing Town Ordinance. Although the BOS had approved the rate changes in their September 16, 2019 meeting, until the ordinance is modified it cannot be implemented. Town Engineer, Janice Plaziak is currently working on other changes to that same ordinance and there will be a meeting at 9:00 am in Town Hall South to discuss the proposed changes. Sally Berezowskyj asked the Commission for permission to represent the Commission at that meeting proposing that the rates be removed from the ordinance (the Waste Transfer Station rates are not in an ordinance) or at the very least make the rate changes as approved by the BOS on September 16, 2019. Chairman Mark Larkins will attend the meeting.
