Executive Summary

The University of New Hampshire Survey Center conducted a survey of Hartford community members about their opinion of the town and what the town's budgetary priorities should be in the future. In September, 2016 surveys were sent to all six-thousand six hundred and thirty (6,630) addresses and Post Office boxes in the Town of Hartford. A reminder postcard was sent out and additional surveys were available at different town locations and provided to residents at the polls on election day in order to boost participation. Nine hundred and thirty-one (931) residents and community members completed the survey (see Technical Report for a more detailed description of survey methods). The following figures display survey results, detailed tabular results can be found in Appendix A and Appendix B contains the open-ended responses and Appendix C contains the survey instrument.

Key Findings

- Among town services, Hartford community members are most likely to be very satisfied or satisfied with road
 maintenance during wintertime (83%), the solid waste transfer station (79%), and road maintenance during
 summertime (78%). Community members are least likely to be satisfied or very satisfied with Planning & Development
 (50%) and Health and Social Services (47%). However, 28% of respondents report not having used Planning &
 Development and 42% report the same about Health and Social Services, as well as 33% for EMS and 31% for the Fire
 Department.
- A majority or plurality of Hartford community members would like to see funding for each listed town service stay the same. Community members are most likely to want increased funding for road maintenance during summertime (29%), libraries (24%), road maintenance during wintertime (23%), and Health and Social Services (21%). Community members are most likely to want decreased funding for Administration (29%), Planning & Development (22%), and Parks & Recreation (18%).
- Hartford community members are divided on their preferred option for future town budgets. A slim plurality of community members (32%) would like the Town to somewhat reduce services (4%-6% tax increase). Slightly more than a quarter (28%) would prefer the town significantly reduce or eliminate services (0%-3% tax increase), while slightly under a quarter (23%) would prefer the town fully fund services (7%-10% tax increase).
- Among town initiatives, Hartford community members are most likely to favor the town increasing parking in White
 River Junction downtown (57%) and creating a town trail network (55%). Fifty-three percent of residents each want the
 town to increase bike lanes and to increase the amount of sidewalks, and 44% would like to restore Wright's Reservoir.
 While these initiatives are supported by around 50% of respondents, relatively few would favor these initiatives if they
 required higher property taxes.
- A slight majority (55%) of Hartford community members favor (27% strongly, 28% somewhat) complete curbside pickup in Hartford. Nearly a third of respondents (31%) oppose curbside pickup and 14% don't know or have no opinion.
- A slight plurality of Hartford community members (40%) would prefer that roads in Hartford be paved on schedule only when there are sufficient funds to do so while slightly more than a third (35%) would prefer that all roads in Hartford be paved on schedule regardless of the effect on other town programs. Nineteen percent want to convert some paved roads back to dirt roads and 7% don't know or have no opinion.
- Just under half of Hartford community members agree that they are pleased with the overall direction the town is taking (49%), that Town Government welcomes citizen involvement (47%), that the Town Government is run for the benefit of all of the people (44%), and that they receive good value for the taxes they pay (43%). A plurality of community members disagree that the Town is effective at attracting new businesses (38%) or new families (36%).
- Nearly two-thirds of Hartford community members (61%) report they always vote in Hartford town elections while 18% do so frequently. Only 9% of respondents say that they never vote in Hartford town elections. Very few respondents report they always or frequently attend Town Meeting events (17%), or serve on Town Boards or Committees (6%).
- Just over half (51%) of Hartford community members visit the Town of Hartford website once every 2-3 months or more often, while a quarter (26%) never visit the website. Twenty-four percent watch town meetings on Community Access (CATV) once every 2-3 months or more often, while six in ten (59%) never do so. Very few community members (12%) attend Hartford Board or Committee Meetings at least once every 2-3 months and 59% never attend.
- Forty-three percent of Hartford community members rate the Town of Hartford website as excellent (4%) or good (39%). A quarter (24%) rate the website as fair while 3% rate it is as poor and 30% were unsure.
- Thirty-seven percent of Hartford community members say that direct mailing is the best way for the Town of Hartford to inform them about what the town is doing. Slightly over a third (35%) would prefer communication via emails/listservs, 24% would choose the town website, and 17% say newspaper ads are the best way to inform them.

Demographics


Based upon estimates in the 2014 American Community Survey (ACS), respondents to this survey tended to be older and more educated than the population of Hartford as a whole, which is common for surveys of this type. The gender and income of respondents are similar to the ACS estimates of the town as a whole.

More than three quarters (78%) of respondents do not have children in their household, 93% live in Hartford full-time, half (50%) have lived in Hartford for more than 20 years, and more than two-thirds (70%) do not work in Hartford.



Town Services


Among town services, Hartford community members are most likely to be very satisfied or satisfied with road maintenance during wintertime (83%), the Solid Waste Transfer Station (79%), and road maintenance during summertime (78%). Community members are least likely to be satisfied or very satisfied with Planning & Development (50%) and Health and Social Services (47%). However, 28% of respondents report not having used Planning & Development and 42% report the same about Health and Social Services, as well as 33% for EMS and 31% for the Fire Department.

Figure 1a: Satisfaction with Town Services




- Hartford community members who are 44 or younger, those with children in their household, and those who rent their home are more likely than others to be satisfied or very satisfied with the Parks & Recreation Department.
- Hartford community members who live in the village of Quechee and those who are part-time residents are more
 likely than others to be satisfied or very satisfied with the libraries.
- Hartford community members aged 75 and older are more likely than others to be satisfied or very satisfied with Health and Social Services in Hartford.

Figure 1b: Satisfaction with Town Services - Responded "very satisfied" or "satisfied," by selected demographics




When excluding those who said they have not used a particular service, the large majority of Hartford community members are very satisfied or satisfied with all listed town services. They are most likely to say they are very satisfied or satisfied with the Fire Department (96%), EMS (96%), the Solid Waste Transfer Station (93%), and the Police Department (89%). Residents were least frequently satisfied or very satisfied with road maintenance during the summertime (78%) and Planning & Development (70%).

A majority or plurality of Hartford community members would like to see funding for each listed town service stay the same. Community members are most likely to want increased funding for road maintenance during summertime (29%), libraries (24%), road maintenance during wintertime (23%), and Health and Social Services (21%). Less than ten percent of respondents would like to see increased funding for Planning & Development (7%), the Solid Waste Transfer Station (6%), and Administration (3%). Community members are most likely to want decreased funding for Administration (29%), Planning & Development (22%), and Parks & Recreation (18%) and are least likely to want decreased funding for road maintenance during the wintertime (3%), road maintenance during the summertime (5%) and EMS (5%).


Figure 2a: Funding for Town Services



- Hartford community members aged 44 or younger and those who rent their home are more likely than others to say the budget for Parks & Recreation should increase.
- Hartford community members with a household income of \$150,000 or more are more likely than others to say the budget for Planning & Development should increase. Those without a college degree and those who own a business are more likely than others to say their budget should decrease.
- Hartford community members who rent their home are more likely than others to say the budget for road maintenance during the wintertime should increase.
- Hartford community members aged 44 or younger and those who rent their home are more likely than others to say the budget for Health and Social Services should increase.


Hartford community members are divided on their preferred option for future town budgets. A slim plurality (32%), would like the Town to somewhat reduce services, a plan that would result in a 4%-6% increase in taxes. Slightly more than a quarter (28%) of community members would prefer the town significantly reduce or eliminate services, resulting in a 0%-3% increase in taxes, while slightly under a quarter (23%) would prefer the town fully fund services, resulting in a 7%-10% increase in taxes. Seventeen percent don't know which option they would be most likely to support.

- Hartford community members aged 44 or younger, those who work in the village of Wilder, and those who rent their home are more likely than others to support fully funding town services. Those with a high school degree or less are less likely to support this plan.
- Hartford community members who own a business and those who live in the village of Quechee are more likely than others to prefer the town significantly reduce or eliminate services while those who work in the village of Wilder, those aged 44 or younger, and those who rent their home are less likely to support this plan.


Figure 3b: Which of the following options would you be most likely to support for future town budgets?



Town Initiatives


Among town initiatives, Hartford community members are most likely to favor the town increasing parking in White River Junction downtown (57%) and creating a town trail network (55%). Fifty-three percent of residents each want the town to increase bike lanes and to increase the amount of sidewalks, and 44% would like to restore Wright's Reservoir. While these initiatives are supported by around 50% of respondents, relatively few would favor these initiatives if they required higher property taxes.

Figure 4a: Please indicate if you favor or oppose the following potential projects in Hartford, and if you favor them, are you willing to pay higher property taxes for them?




- Hartford community members who work in the village of Wilder, those who own a business, those who work in White
 River Junction, and those aged 45 to 54 are more likely than others to support increasing parking in WRJ downtown.
 Those who live in the village of Quechee and those who live in the town of Hartford part-time are less likely to support
 this initiative.
- Hartford community members who have lived in Hartford for 10 years or less, those who have completed postgraduate work, those with a household income of \$150,000 or more, those aged 44 or younger, and those who work in White River Junction are more likely than others to support creating a town trail network. Those aged 75 and older and those without a college degree are less likely to support this initiative.
- Hartford community members with children in the household, those aged 54 or younger, those who have completed postgraduate work and those with a household income of \$100,000 or more are more likely than others to support increasing sidewalks. Those with a high school degree or less are less likely to support this initiative.
- Hartford community members who have completed postgraduate work, those who have lived in Hartford for 10 years or less, and those with a household income between \$100,000 and \$149,999 are more likely than others to support increasing bike lanes. Those without a college degree are less likely than others to support this initiative.
- There are no significant demographic differences among Hartford community members on restoring Wright's Reservoir.

A slight majority (55%) of Hartford community members favor (27% strongly, 28% somewhat) complete curbside pickup for town residents in Hartford. Nearly a third of respondents (31%) oppose complete curbside pickup and 14% don't know or have no opinion.


• There are no significant demographic differences among Hartford community members regarding a plan for complete curbside pickup.

When asked about additional projects the Town of Hartford could invest in, community members frequently cited completion of the proposed "pocket park" in the village of Quechee. Others mentioned infrastructure improvements as well as alterations and improvements to road networks in the town. Many also expressed a desire to avoid any additional projects in order to maintain or reduce the tax burden. See Appendix B for full open-ended responses.


A slight plurality of Hartford community members (40%) would prefer that roads in Hartford be paved on schedule only when there are sufficient funds to do so while slightly more than a third (35%) would rather that all roads in Hartford be paved on schedule regardless of the effect on other town programs. Nineteen percent want to convert some paved roads back to dirt roads and 7% don't know or have no opinion.

Figure 6a: Paving roads costs about \$150,000 per mile and lasts about 10 years. Hartford has nearly 100 miles of paved road. Even at a rate of \$1 million a year, road paving falls behind at a rate of about 3 miles per year. If you were on the Selectboard and had the decide, which of the following strategies would you be most likely to support?



- Hartford community members who live in Hartford part-time and those aged 75 and older are more likely than others to prefer that all roads in Hartford be paved on schedule. Those who live in the village of Hartford and those who work in White River Junction are less likely than others to prefer this plan.
- Hartford community members aged 54 and younger are more likely than others to prefer the Town convert some paved roads back to dirt roads. Those aged 75 and older are less likely than others to prefer this plan.


Figure 6b: If you were on the Selectboard and had the decide, which of the following strategies would you be most likely to support? By selected demographics


Just under half of Hartford community members agree that they are pleased with the overall direction the town is taking (49%), that Town Government welcomes citizen involvement (47%), that the Town Government is run for the benefit of all of the people (44%), and that they receive good value for the taxes they pay (43%). A plurality of community members disagree that the Town Government is effective at attracting new businesses (38%) or new families (36%).

 effective at attracting new families.


Figure 7b: Town Government Assessment by selected demographics



Town Involvement/Communication


Nearly two-thirds of Hartford community members (61%) report they always vote in Hartford town elections while 18% do so frequently. Only 9% of respondents say that they never vote in Hartford town elections. Very few respondents report they always or frequently attend Town Meeting events (17%), or serve on Town Boards or Committees (6%).

Figure 8a: How often do you do each of the following?




- Hartford community members who work in the village of Wilder are more likely than others to say they always or frequently vote in Hartford town elections. Those with a household income of \$150,000 or more, those who rent their home, and those who are aged 44 or younger are less likely to always or frequently vote.
- Hartford community members who own a business are more likely than others to say they always or frequently attend Town Meeting events.

Figure 8b: How often do you do each of the following? - By selected demographics




Just over half (51%) of Hartford community members visit the Town of Hartford website once every 2-3 months or more often, although only 18% use it at least a few times a month, while a quarter (26%) never visit the website. Twenty-four percent of community members watch town meetings on Community Access (CATV) once every 2-3 months or more often, while six in ten (59%) never do so. Very few community members attend Hartford Board or Committee Meetings, with only 12% doing so once every 2-3 months or more often and 59% never attending.

Figure 8c: How often do you do each of the following?




- Hartford community members aged 54 or younger those with a household income of \$100,000 or more, those who have been in Hartford for 10 years or less, and those with children in the household are more likely than others to visit the Town of Hartford Website at least once every 2-3 months. Those with a household income below \$50,000, those with a high school degree or less, and those aged 75 or older are less likely visit the town's website.
- Hartford community members with a high school degree or less are more likely than others to watch Town Meetings on Community Access (CATV) at least once every 2-3 months, while those aged 44 or younger are less likely to do so.

Figure 8d: How often do you do each of the following? - By selected demographics





Figure 9a: How would you rate the Town of Hartford website?




• Hartford community members aged 45 to 54, those who have lived in Hartford for 10 years or less, and those with children in the household are more likely than others to rate the Town of Hartford website as excellent or good. Those with a high school degree or less and those aged 75 and older are less likely to rate the website this highly and more likely to not have an opinion.

Figure 9b: How would you rate the Town of Hartford website? Responded "Excellent" or "Good" - By selected demographics




Thirty-seven percent of Hartford community members say that direct mailing is the best way for the Town of Hartford to inform them about what they are doing. Slightly over a third (35%) would prefer communication via emails/listservs, 24% would choose the town website, and 17% say newspaper ads are the best way to inform them about what the town is doing. Fewer respondents cited social media (13%), CATV (5%), radio ads (5%) or TV ads (2%).

- Hartford community members with a household income of less than \$50,000 and those with a high school degree or less are more likely than others to prefer the Town of Hartford inform them via direct mailing. Those aged 45 to 54 and those with a household income of more than \$150,000 are less likely to prefer this method.
- Hartford community members aged 45 to 54, those with a household income of \$100,000 or more, those who have
 completed postgraduate work, those who have lived in Hartford for 10 years or less and those with children in their
 household are more likely than others to prefer the Town of Hartford inform them via emails/listservs. Those with
 some college/technical school education or less and those aged 75 or older are less likely to prefer this method.
- Hartford community members with a household income of \$150,000 or more are more likely than others to prefer the Town of Hartford inform them via the town website. Those with a household income below \$50,000 and those aged 75 and older are less likely to prefer this method.
- Hartford community members aged 75 and older are more likely than others to prefer the Town of Hartford inform them via newspaper ads. Those with a household income of \$150,000 or more are less likely to prefer this method.
- Hartford community members aged 44 or younger and those with children in their household are more likely than others to prefer the Town of Hartford inform them via social media.

Technical Report

How the Surveys Were Distributed

In September 2016, the Hartford Community Survey was mailed out to all addresses and Post Office boxes in the Town of Hartford using EDDM (Every Door Direct Mail) with the United States Postal Service. Surveys were also sent to a small list of people who are registered voters in Hartford but do not have a mailing address in town. A reminder postcard was also sent to all addresses in order to encourage completing the survey. Additional surveys were available at multiple locations in town (the Municipal Building, Libraries, Quechee Club) for those who did not recall receiving a survey or those who had multiple adults in a household who wished to take one. In an effort to increase participation, surveys were also distributed to residents at the polls on voting day.

Response Rate

Overall, 931 community members completed the survey – 678 from a survey that was mailed to them, 52 from one of the locations in town, and 201 from voting day. Applying a response rate with only surveys completed that were mailed out (678) by the total number that were mailed out (6,630) yields a response rate of 10%. When including all 931 completed surveys the response rate is 14%. However, Hartford is a town with a large number of seasonal residences, and this should be taken into consideration when assessing response. According to the 2014 American Community Survey estimates, there are 4,430 occupied year-round households in the Town of Hartford. When using this number and taking the number of full-time residents who completed the survey via mail (618) the response rate is 14%. When including all 858 full-time residents who took the survey, the response rate is 19%, which is much more in line with response rates we've seen in similar types of surveys conducted in the past.

Sampling Error

Because the Hartford Community Survey was sent out to all addresses in town and was not a random sample, there is no sampling error that should be applied to these findings.

- Compare our school facilities and curriculum to Hanover, Lebanon, Woodstock. Our taxes are high and we don't have nice walking areas like other towns. We should have restaurants/chains up by Aquatic Center. People who stay at hotels up there go to West Lebanon for dinner, shopping, encourage business, health and education!!
- d. Quechee still regarded as a "cash cow". Only village without sidewalks and poor appreciation from residents in other villages for its contributions. a. School cost too high. g. School needs to be improved to attract young families.
- During times for plowing the trucks are plowing when there is not enough to plow, also they
 plow sidewalks before truck come to plow. Sidewalks get covered again
- Ever since we moved to this area, we are trying to relocate. We pay way too much in property taxes and do not see the return in schools quality, there is no garbage pickup, and I see almost half the kids in my kid's school are taking advantage of a system that is broken.
- Explore new materials and tech to lower the cost of \$150k per mile road paving cost, or try to last longer
- Fairly new to the area
- Find lower cost alternatives than \$150,000 mile
- Get out of the business of giving out handouts local and national
- Government keeps expanding, doing less work but costing more. Prices keep going up but wages and pensions don't
- Hartford is not attracting tuition students to the high school. Even former Hartford alums whose children have a school choice are going elsewhere.
- Hartford needs to attract technical industries to support our tax structure. The reliance on property taxes is not working to support all the "wants" of the town government.
- Have been involved in some town votes but they seemed close minded and pre-determined on outcome.
- High hopes for new town manager and realigned select board. I've heard nothing but good things about Mr. Pullar and Chief Kasten.
- Hopefully the new people in the last couple of years will make a large difference in the way I view this town's government. There may still be a few sour apples in the basket!

- I feel a family today cannot afford the property taxes and the elderly with fixed incomes are having to sell their homes because of this.
- I have felt for the taxes that we pay that some services and physical upkeep give the appearance of neglect. It is great to see the entrance to Hartford from West Lebanon get a Facelift with the bridge, Listen, the building on the other side, a light, new redone town building. However, condition of roads, sidewalks, buildings that should be torn down appears derelict.
- I have only lived in Hartford a few months, so there is still a lot I don't know.
- I strongly feel that the town must make it easier for other businesses to come to this area. People need to come and stay WRJ has come a long way these past few years. So enjoyable to walk around and dine and shop. Thank you
- I think the town does a very good job. Services I have used have all been very good. My
 opinion, given the rate of state income tax, real estate taxes are too high. I believe this
 contributes to not being able to attract new families and businesses. Thanks for sending this
 survey!
- I think the town government has the best interest of the people in mind and I think they do
 their best making important decisions affecting today and the future
- I think we are attracting wrong type of people. Not good citizens. We have high case of druggies + pedophiles.
- I would like to see Fairview Terrace repaired for the residents there. Sport center max field sporting can stop with more and more income to add sporting EVENTS. Not on sports but on residents lives!!
- I would like to see the town and school district do more to promote the wonderful opportunities for students and families in an effort to attract new residents
- I'm really happy to see the new businesses and restaurants in WRJ, especially because they're family run, not chains. I also love the Dothan Brook School but am scared to send my kid to the middle and high school. I think it's a great town with some big challenges and I commend and thank the people who are working hard to make it better
- In the past some decisions seem to be made by some "black box" effect at town hall without understanding where the decision was made, or by who, or whom. In this manner. Town government felt disconnected from the citizen & citizen involvement. To attract families, need affordable housing.

- In the past there has been a closed mindedness in the town government with a lot of secrecy. I'd like to see more openness with the new administration.
- It is interesting to note that many people coming or visiting area are totally confused about the set-up Hartford with 5 villages. Need to make clearer on website and materials promoting the area. For example: when using online searches for real estate, Quechee does not come up with listings. People don't know that they need to search "Hartford". This is problematic in attracting people to area.
- It's simply not sustainable when taxes (plus hidden fees of water and sewer) keep outpacing our income.
- I've emailed select board members and got no reply. New families can't afford to buy in Hartford!
- Just because you live in Quechee doesn't mean you're rich. Stop using Quechee taxes to support all of Hartford. Wasting time on renaming Columbus Day- REALLY?! Lower water rates- charge for wells! Lower senior real est. taxes. Give seniors more tax exemptions or lower water rates. You waste too much of lister's time- have appealed by taxes time and time and nothing changed
- Many families rent do not own, thus do not pay taxes; yet have full access to all town and school services
- More effort is needed (programs and facilities) to attract business (especially in WRJ) and families
- More families leads to higher taxers not less taxes
- Not increasing property & water/sewer should be the goal of each budget preparation & stressed to all Department heads. Cost of living is always increasing so when town & school board can operate most efficiently without needing more taxpayer it helps the entire community & attracts new business & residents.
- Not pleased with school sports fields- too expensive
- Not well informed + the meetings are too long + uninteresting; poor use of my time
- Overall very pleased with the town, schools, programs, infrastructure. Do feel taxes are at where if they go up they will become prohibitive between the school taxes and town taxes.
- Past history, F&G has not been very effective. Town planning and zoning need to be overturned
- Please make improvements/ spend money on the necessities, not the "I wants" or "it would be nice if." We can all dream, but we cannot always afford our dreams
- Property tax is too high, business property tax is counter to business!
- Quechee tends to be ignored in town government and there is too adversarial a relationship.
- Residents of Quechee pay a disproportionate share of RE taxes, and get very little in return, except disdain from town leaders and many other residents.
- Residents that live on Fairview Terrace and Maplewood Terrace should not have to live with the options I have heard the Selectboard discussing as follows: a one-lane road or a closed road.
- School costs/taxes are ridiculous for the declining enrollment we have. Limit all for education (without it we end up with trump) as to why is my water/sewer bill so high? Administrative costs are higher than my usage!
- School taxes are not included here. I think of "taxes" as a package. I do not receive value for the school taxes I pay.
- Seems like we only attract homeless families

- Sidewalk system is weak, taxes are high. Why is Hartford Village dilapidated diner still an
 eyesore? Dangerous intersection and depressing property that could provide a nice sitting
 area overlooking the river.
- Swapping of scale from disagree agree from page one is confusing. It is only a fraction of what people are looking for in a move. The area, the schools, the atmosphere, the neighborhoods, and lastly government
- Tax assessments are high here for what we get. compared to neighboring, more desirable towns, we don't have the same caliber schools, libraries, etc. it is tough to attract business plus others with the high taxes compared to NH
- Tax burden in VT too high. Why not just work/live over the river in NH
- Taxes are too high for attracting new families.
- Taxes in Vermont (state and local) are simply too high.
- Taxes too high new families cannot afford to live here.
- Taxes will drive away low income families and most business. Give a (illegible) tax incentive to attract new businesses and industry (manufacturers) no taxes first 3 years then gradual increase next 10 years. Pay for training for new employees for new business not to exceed 90 days and minimum of 30 at minimum wage or wage agreement with new business.
- The absence of school choice in this town is a major disadvantage!
- The Advance Transit bus was a big consideration for me deciding to buy in Wilder. I don't know if the town supports that at all but I am thankful it runs so often and reliably!
- The impact fee system used by the town is a) unreasonable b) not clear as to what impact some items have relative to additional tax revenue the town would receive in taxes
- The negative quality of my responses to Q7 is strongly influenced by my one interaction with the selectman over property taxes. A long story that I won't go into, except to say, that high handed, blatantly unjust, and for me, surprisingly dismissive way in which I was treated, has left a deep mark on my sense of town government. After that incident, I frankly did not want any interaction at all with those running my town. The incident had been that hurtful, that infuriating, and that disempowering. (It angered me once again even writing this much about it.)
- The only area where town government is effective in attracting new business is WRJ.
- The only families who move here is to get better welfare money. We have 5 able body men in this park (Olcott falls, wilder) who could work their wives/girlfriends get pregnant and welfare pays their way. Two families bought fairly new vehicles this year. Vermont has better welfare benefits than N.H. and 5 families have children 1 year and under.
- The price to live in Hartford is more than most families can afford. The price is too high for the people who struggle to make ends meet.
- The school rankings are poor in high school. The middle school has a poor reputation. Families are not moving to the town because of the school district.
- The town does not pay enough attention to Quechee residents. I feel as though we are an
 after-thought. We are an important tax base for the town but the senior town officials have
 been hostile to our village/QLAA
- The town is doing ok at attracting business (could always be better), but it must push aggressively to add to/refresh the housing stock. More/better housing=more revenue, more families, more "buzz" low or no interest to improve, make it easier to add new housing.
- The town of Hartford has NOT been effective at attracting ANY businesses that will significantly help lower our taxes, create employment opportunities, provide foods for

residents and tourists, or entertainment without leaving our town. We desperately need the following businesses back in the town of Hartford: Restaurants: More family style restaurants like Crossroads, including 'hi-end' chain and family type. Examples- Outback steak house, Cracker Barrel. Grocery Stores: Chain types that are affordable. Examples- Shaw's, Hannaford's, Price Chopper Department/Hardware Stores: Larger chain type that sells clothes, hardware, and building Entertainment: My opinion is we need to bring back a bowling alley/game room like we several years ago, and a cinema. Hartford has less of the services I mention above now than we did now 50 years ago. Our future depends on both future residents as well as tourists being attracted to our town. We have one of the best school systems and Parks/Recreation departments in the state of Vermont, and our infrastructure has improved dramatically in recent years. It is time now to bring in the businesses I have described above to provide our residents with the ability to make their purchases in their own town.

- The town of Hartford should invest in its biggest asset- Quechee!!
- The town rec department is fantastic, they are the people who tend to be the faces of town events-community day, fourth of July, etc. they are a relatively small staffed dept. what others could be trimmed? Benefits for most people living in the town have increased in cost and decreased in value. The people working for the town should expect nothing different and I'm sure the budget could be decreased there.
- There is an obvious partisan (anti-Quechee) town gov't. The Quechee funds park rebuild debacle shows town has little insight into attracting tourist, new business or families. The Selectboard effort to limit Quechee resident involvement in government is well known.
- There are too many homeless people without jobs and income. They do not make the town of Hartford look good at all. Some of the buildings look good but a lot are run down and do not look good for the town itself.
- Too much attention to Quechee citizens should pay for their own trash pickup (residential)
- Too expensive for new /young families to live in VT
- Too many red tape regulations plus stalls you scare businesses away
- Too much money allotted/spent: pocket park (Quechee),organized sports, Maxfield fields, football, W. Hartford Library
- Town government has been fairly responsive to my needs, but mostly lip service, problem is public apathy. Few of my neighbors even vote, let alone involve themselves in civic activities. Why?

- We live in QLLA full time. Many residents here are part time, I think if a representative would schedule a meeting here at the club, when more taxpayers are here to show a presence and that people know you are aware of what we give back, volunteering, monies, etc.
- We need lower taxes on properties.

- I have served in village/town governance in another state for over 20 years before moving to vt. -my general observation is that Hartford's governance is dedicated and satisfactory. however, meeting of the select board are inefficient and ineffective. E.G. After two meetings lasting over three hours on a trivial issues, there was no decision. It should have taken 10 minutes (with proper planning and presentation) to reach a decision. The only potential decisions/resolutions: Yes; No; Defer with Direction. Still, 10 minutes tops. The town manager need to do more work!

- I thought my financial advisor was a good one but lost about \$40000000 when the stock market went down, boo hoo!
- I travel a lot for my business so I cannot serve in my regular (?). My wife does enough with the town for four people... we love Hartford.
- I used to go to town meeting until the charter went into effect
- I was not born here but I am sick of taxes always going up and needless projects, like a baseball field being put in. Not impressed with the idea of solar panels especially since I can't afford to do any of the repairs needed. Don't care what deals are being fed to the town about it. Town always seems to make decisions not thinking about the people but just the politicians that run the town. If my husband wasn't from here would have moved years ago. even discouraged people I know from moving here
- I was very opposed to the Quechee highland project and am relieved it will not go forward. Invest in current villages! Harford is a great place to live!
- I wish that I were better informed, as I complete this survey.

- I wish the town and school were able to work together better. I think it's improved over the years, but both seem to struggle with communications to residents. Would be nice to have a strong chamber of commerce. Do we even have one? Continue supporting bus service (AT)... it's a huge benefit to citizens.
- I work for the DREAM program. A non-profit mentoring org which pairs college student with youth from low-income housing (Northwoods & Hollow Dr.). Many of the families and youth I work with have limited access to mental health services. Most resources locally (HCRS, Howard, Listen) are reactive resources- NOT PREVENTATIVE! We need more early intervention services. HCRS is swamped. Many of my youth have to go into crisis before receiving services. We need more funding for youth program and family support services (Howard Center in Burlington is a good model). Summer programming NEEDS funding. My families are hungry in the summer. Parks & Rec should run on-sight programming in low income housing communities and provide meals through government funding. Create a swim area at Watson Park with a life guard or at Kilowatt. Opiate addiction is in our community and we need resources, programming, mentoring, outdoor access, etc. for our youth-especially during the summer.
- I would like the town to consider doing a survey like this every year.
- I would like them to consider a different school tax rate for retired people. We raised 2 children in Hartford and paid the school tax. I feel that a lower rate for us would help keep the elderly in their homes. However I do feel we should not be exempt from all school taxes.
- I would like to see more business in the town.
- I would like to see a fairer way to support our schools. People who are not home owners but have children in school should have to shoulder some of the cost and people like me who no longer have children in school should have to pay less
- I would like to see more bicycling/walking trails that connect all villages (could be used in the
 winter for cross country skiing). As a Quechee resident who commutes to work to DHMC I
 would like the option to use the Advance Transit bus. It would be helpful to the large senior
 population that lives here also
- I would like to see school taxes (costs) controlled by consolidation of elementary and middle schools
- I'd love more solar! move energy projects
- If the town is not going to encourage economic development it need to pare spending. if the town elects to pursue development spending may be merited, but must generate tax revenue commensurate with spending
- Important to me that town focuses on safety and children's programs
- In business we all know it takes a lot more time, effort, and money to obtain and keep new customers than it does to retain your existing ones. The town would do well to take the same approach and cater to the existing businesses rather than shun them. Our children and our grandchildren could never afford to live where they grew up. THIS \$ LIABILITY IS UNFAIR TO SENIORS!.
- Our school is what needs funding!

- Overall, we're pleased to live WRJ.
- People who are allowed to serve on any board or committee should have lived in the town of Hartford, paid taxes for over 10 years and have demonstrated experience that can be utilized in the decision making process
- Please add sidewalks to neighborhoods!
- Please consider moving voting out of the school. Maybe there is another space? Break it up into wards? Libraries? This may be a logistical nightmare for which there is no clear solution but thank you for listening.

 that I believe the budget is good. I would like a reduction in the police budget in particular. I
 am strongly in favor of infrastructure upgrades and repairs.

- Please just once in my lifetime decrease taxes! Trim fat cut school administrations. Get rid of all unions. Have pay based on merit. Stop funding advance transit. If needed, it will pay for itself with fees.
- Please keep town taxes as they are for a couple of years- give us a rest to recuperate- thx
- Please move your focus to housing availability and affordability. So many would like to be/stay here but can't. Continue to encourage and attract housing dev. and working to help low income folks find a home

- "time wasted" by all depts. are there processes/procedure that could save time. work scheduling (highway) that would be more productive do we really need 2 workers riding pick up to check conditions, why not 1 person. Q.8- CATV not available
- Q2: What explicit services are we talking about? Is there no other areas that could be cut before these services? What priorities are we talking about?
- Q2-was too vague- what departments are under staffed and capital improvements have been neglected. Q4- what would change cost wise? Would curb side trash pickup be the same cost as a dumb ticket is not? Almost threw this in junk mail recycling. More warning it was coming and better representation needed!
- Quechee is very important to the town. Effort should be made to recognize such. Promote at least one Selectboard member from Quechee. Rebuild the Q-park in 2017. Give Quechee owners their fair share of tax revenue. Most have not kids in school and as any offer comments suggest we get little back from town. Increase EMS funds, lower fire funds, and save resident - not house.
- Quechee Main Street speed is set 25 MPH. Cars/trucks constantly go over 40 regardless of the time of day. Needs enforcement.

- Re: paving. I have lived on dirt roads and travel on them. In some situations, they are more economically feasible and actually feel safer to me in winter.
- Recycling and trash pick is very important! Do not Raise Taxes!! Snowplowers need to slow down!!!
- Reduce property taxes for childless residents, especially low-income seniors. Childless people are a tiny minority here, and less of our tax money would hardly make a difference to the town, but it would give us more to live on. With so many kids cutting classes, or being home schooled, it is a waste of my taxes to pay for their education. I need the money I'm pay in taxes more than the schools do. I don't have kids. If taxes continue to rise, nobody will want to move here. More people will move away, leaving fewer Vermonters paying too much.

- The biggest problem is the town is taxing the elderly out of the homes they have worked hard to buy and keep

- The community self-reliance plus sustainability initiative is wonderful! Please do again plus also more programs. it would be great to advertise it more, as most people I spoke to were totally unaware
- The CROH organization did a tremendous job with resilience week. Too bad they focus on adaptive and reactive work. It would be better to expand the group's scope to be Proactive when possible (i.e. switch to alternative power, replace administrative and police vehicles with energy efficient and non-polluting vehicles, etc...)
- The Hartford Village economic development is suffering because of the Hartford Diner debacle
- The hiring of chief Kasten is the best move the town has made in 20 years we have lived here.
- The tax burden is already large. We don't have the money to keep paying more. Fiscal restraint is needed.
- The tolls that taxes in the town has on Middle Class and Lower Class folks, when a person has to make the decision to pay taxes or buy the basic necessities, the taxes fall behind. I have fallen into that category through a series of events, and will probably never be able to pay them off
- The town needs to do a better job getting families to live in the town. Improving infrastructure and schools are key.
- The town of Hartford needs to do more to attract young families and should have a progrowth agenda. The biggest problem facing the town is our rapidly aging population. - This was a fairly good survey, but Q1, "Town Services" should have included data on what other VT towns of similar size spend (in %) for each specific service. There should be a "top to bottom" look at current town staffing levels as compared to other Vermont towns of similar size, and adjustments made with this in mind. Are 3 department heads (DPW, P+D, P+R) needed? One "Assistant Town Manager" with input from mid-level staff could likely do the job that the 3 current Dept. heads do, IF the town chose to do fewer thing, but do them well. The office of Planning & Dev., and the Planning Comm./ ZBA process is broken beyond repair. The P+D office has created a process that deters new business and even private citizens from doing anything with their property. Hartford should find a new, much simpler model with one Board and streamlined regulations.
- To be business friendly the town must allow that business to be known where it is located. At the beginning of a road/street should have a sign indicating that this business is located on that road/street. This shows that business that we are pleased it chose our town to do it's business in. Example: A street wilder we don't have even a business park sign. - We don't qualify for any financial aid through rec department but are in need due to lay off.

 -basketball T, Th, Sat. It's a lot to hope for but being mindful of schedules and conflicts would
 be helpful.
