Old Business

Motion by David Crocco to approve the Marketing and Community Relations Plan. The motion was seconded by Tom McCleary and approved by everyone.

There was a discussion on possible changes in Parks and Recreation ordinances relative to cannabis use in town's parks (see New Business in November's minutes, presentation by members of the Hartford Community Coalition).

A motion was made by David Crocco to support the idea of updating the ordinance to include cannabis and smokeless tobacco but hold off on making specific changes until review from Vermont League of Cities and Towns. Motion was unanimously approved.

New Business

Tom McCleary brought up that it was briefly mentioned at Monday's December 5th meeting of the town's Conservation Commission about a possible project to enhance the riparian buffer zone between Lyman Point Park and the White River. Scott spoke of how there is a separation between Municipal Building side of the river and the downtown area. He said the trees blocking views could be attended to; pruning and raising the tree canopy to improve views.

There is a meeting Monday, December 12th of members of Tree Board and Conservation Commission to further discuss this matter. There is grant money available for doing this work.

Parks & Recreation Department Significant Activity Report November 11th, 2022

Program and Park Highlights

- Our after-school programs continue to be a success with full enrollment. We have added a Board
 Game Club which started November 10th. In addition to Lego and Chess Club at the Hartford Town
 Hall, we will be working with OQS to offer a program at the school. This opens the door for Parks &
 Recreation to offer after school activities at the school.
- Trunk or Treat was a huge success with 25 Trunks and
- Small Games Camp started at the WABA Arena. We have 36 skaters enrolled in the boys program and 16 in the girls program. The Small Games Camp is for skaters in grades 7 through 12.
- Maxfield Monday Walks continue through November 28th. The walks have 14 enrolled in the dropin program and are led by Parks & Recreation Staff. In addition to Maxfield Monday Walks, we held at hike in the Hartford Town Forest on November 2nd with 5 participating.
- Pickleball at Maxfield has ended for the season. The Tuesday/Thursday program had a total of 82 registrations and will pick back up next spring.
- The Department took 8 teens to the Get Air Trampoline Park on November 3rd. The program was designed for the schools early release day.
- There were 15 enrolled in our No-School Fund Day on Friday, November 4th. The program was held at the WABA Arena where participants skated on the ice, played games, arts and crafts and were able to enjoy the nice outdoor weather.
- The Learn to Skate and Tiny Tots Program at the WABA Arena has 26 total enrollments. Session 1 for Tiny Tots and the Learn to Skate runs through December 4th.
- There are 15 enrolled in the Youth Karate. The program is a traditional Japanese Okinawa Karate and Kobudo Program instructed by Sensei Mayfield.
- Public Skating at WABA has started. As of November 6th we have had 136 day pass skaters, 21 noontime hockey, 38 skate rentals and have sharpened 20 pair of skates.
- Over the past two week our reservation report includes 91 facility reservations with 189.5 hours of usage.
- Staff in Parks and Facilities continue to transition from outdoor maintenance to the indoor operations of the WABA Arena. The arena schedule this season is 7 days per-week with mostly afternoon/night shifts and our weekend Saturday and Sunday operation consists of 12 to 16 hours each day.

ARTICLE I

PURPOSE

The purpose of this article shall be to preserve the public peace and maintain order on lands owned and managed by the Town of Hartford, Vermont, contribute to the safety and enjoyment of the users of such parklands by regulating the use of the properties and protecting users from exposure to the harmful effects of secondhand smoke/vapor and tobacco/cannabis product waste on the properties.

ARTICLE II DEFINITIONS

- "Town" the governing entity consisting of the following villages: Quechee, Wilder, West Hartford, Hartford and White River Junction.
- 2. "Park" is any area in the Town under the direct jurisdiction of the Town Parks and Recreation Department and Conservation Commission. Parks and Conservation Lands include: Quechee Green Park, Watson Memorial Park, Erwin Clifford Park, George Ratcliffe Park, Hurricane Wildlife Refuge Park, Frost Park, Kilowatt North and South Parks, Veterans Park, Quechee Green Park, Meeting House Common, Lyman Point Park, Fred Briggs Park (Engine 494), Hurricane Town Forest, Maanawaka Conservation Area, David Chang Conservation Area and all open public properties managed by the Parks and Recreation Department and Conservation Commission.
- "Person" is any individual, group, association, corporation, company or organization of any kind.
- 4. "Vehicle" is any conveyance, whether motor-powered, animal-drawn or self-propelled. The term shall include any trailer in tow of any size, kind or description.
- "Tobacco Products" include cigarettes, little cigars, roll-your-own tobacco, snuff, cigars, new smokeless tobacco, and other tobacco products as defined in 32 V.S.A. § 7702.
- 6. "Tobacco Substitute Products" are products, including electronic cigarettes or other electronic or battery-powered devices, that contain or are designed to deliver nicotine or other substances into the body through the inhalation of vapor and that have not been approved by the U.S. Food and Drug Administration for tobacco cessation or other medical purposes as defined by 7 V.S.A. § 1001(8) Products that have been approved by the U.S. Food and Drug Administration for tobacco cessation or other medical purposes shall not be considered to be tobacco substitutes.
- 7. "Cannabis" includes all parts of the plant Cannabis sativa L. as defined by 7 V.S.A. § 831.

ARTICLE III AUTHORITY AND ADMINISTRATION

The Department of Parks and Recreation is charged with the administration of this article and the posting of signs designating parkland within the town. The rules and regulations set forth herein shall apply to and be in effect in all parks under the control, supervision and jurisdiction of the department. Under authority granted in 24 V.S.A. §§ 2291 (4), 2291 (7), 2291 (14), 2291 (17), and 2291 (18), the Selectboard of the Town of Hartford, Vermont hereby adopts the following civil ordinance regulating the Parks.

ARTICLE IV NO PERSON IN A PARK SHALL

- 1. Buildings and grounds
 - a. Willfully mark, deface, disfigure, injure, tamper with, displace or remove, any building, bridges, tables, benches, grills, railings, paving/paving material, water lines, or other public utilities or parts or appurtenance thereof, signs, notices, or place cards (whether temporary or permanent), monuments, play equipment, facilities or park property or appurtenances whatsoever, either real or personal.
 - Dig or remove any soil, rock, stones, down timber or other wood or materials, or make any excavation by tool, equipment, blasting, or other means or agency.
 - c. Erect Structures: Construct or erect any building or structure of whatever kind, whether permanent or temporary in character, or run, or string public service utility into, upon or across such lands. Exception is here made as to any person acting by and under the authorization by permit of the Town.
- 2. Trees, Shrubbery, Lawns
 - a. Damage, cut, carve, transplant, or remove any tree, flower or plant or injure the bark, of any tree or plant. Nor shall any person attach any rope, wire or other mechanical device to a tree or plant. A person shall not dig in or otherwise disturb turf areas.
- 3. Hunt and Trap
 - a. Hunt or trap on Park Properties, with the exception of what may be permitted by the regulations as outlined in the Hurricane Town Forest Recreation Management Plan
- 4. Sanitation
 - a. Pollute the natural waters located in and next to the Parks.
 - b. Bring in or shall dump, deposit or leave any bottles, broken glass, ashes, paper, boxes,

- cans, dirt, rubbish, waste, in or contiguous to any park, or left anywhere on the grounds thereof, but shall be placed in the proper receptacles where these are provided; where receptacles are not provided, all such rubbish or waste shall be carried away from the Park by the person responsible for its presence, and properly disposed of elsewhere.
- Keep a dog or dogs off leash. Owner or person having custody of any dog shall keep the dog on a leash at all times, unless in an off-leash designated area on the park grounds. A dog may not defecate on any park properties, unless said defecation is removed immediately and properly disposed of in a designated dog waste container. No dogs are allowed on athletic fields. Cross reference Dog Ordinance Chapter Sections: 27-4, 27-

5. Traffic

- a. Fail to comply with State laws, Town ordinances and with the exception of what may be permitted by the regulations as outlined in the Hurricane Town Forest Recreation Management Plan in regards to recreational equipment and operation of vehicle of any
- Operate any vehicle or recreational equipment on any area except the designated road / driveway areas and or trails.
- c. Park a vehicle in other than established or designated parking areas
- 6. Recreational Activities
 - a. Frequent any waters or places of park grounds before or after park posted hours. Parks are open from dawn to dusk, unless said activity is approved by the Town to be conducted after park posted hours.
 - b. Carry or possess firearms of any description, or air rifles, spring-guns, paint-ball guns/rifles, bow and arrows, sling, knife, slingshot, dagger, or any other types a dangerous weapon(s), with the exception what may be permitted by the rules and regulations as outlined in the Hurricane Town Forest Recreation Management Plan.
 - c. Picnic Areas and Use 1) Picnic or have large food serving stations in a place other than those designated
 - for that purpose. 2) Large groups are required to submit a Park Use Permit. A large group consists of ten or more people.
 - 3) Light and create open fires, and/or fire pits with the exception of what may be permitted by the rules and regulations as outlined in the Hurricane Town Forest Recreation Management Plan.
 - 4) Leave a picnic area before the fire is completely extinguished and before all trash, garbage and all other refuse is placed in the disposal receptacles. If no such trash receptacles are available, all refuse is to be taken out of park and properly disposed of elsewhere.
 - d. No person shall set up tents, shacks, or any other temporary shelter for the purpose of overnight camping, nor shall any person leave in a park after closing hours any movable structure or special vehicle to be used for, or that could be for, such purpose of overnight camping, with the exception of what may be permitted by the rules and regulations as outlined in the Hurricane Town Forest Recreation Management Plan or without permission from the Hartford Parks and Recreation Department.
 - e. Take part in organized athletic games without written permission of the Department of Parks and Recreation.
 - f. Ride a horse or any other animal in the parks, with the exception of what may be permitted by the regulations as outlined in the Hurricane Town Forest Recreation Management Plan.

ARTICLE V BEHAVIOR- NO PERSON IN A PARK SHALL:

- 1. Bring or possess alcohol beverages, tobacco products, tobacco substitute products, or any illegal drug, nor shall any person drink alcohol beverages, or use any tobacco products, tobacco substitute products, cannabis, or illegal drug at any time in the park (including but not limited to parking areas, restrooms, off-leash areas of dog parks), except when allowed by the rules or regulations of the ordinance relating to the use of alcohol beverages. - 2. Engage in loud, boisterous, threatening, abusive, insulting or indecent language, or engage in any disorderly conduct or behavior tending to breach the public peace. Cross reference Noise Ordinance.

ARTICLE VI MERCHANDISING-ADVERTISING-SIGNS

- Expose or offer for sale the article of thing, nor shall he/she station or place any stand, cart, or vehicle for the transportation, sale or display of any such article or thing. Exception is here made as to any person acting by and under the authorization by permit of the Town.
- Announce, advertise, or call the public attention in any way to any article or service or service for sale or hire-without written permission from the Town.
- 3. Paste, glue, tack or otherwise post any sign, placard, advertisement, or inscription, nor shall any person erect or cause to be erected any sign on park properties. Exception is here made as to any person acting by and under the authority by permit of the Town.

ARTICLE VII BICYCLE, SNOW VEIDCLES AND MOTORBIKES

- No person shall ride a bicycle upon the lawns, walks, or foot trails in the parks unless otherwise posted.
- No motorized snow vehicles shall be permitted in the area of a park except where permitted by the Town.
- No motorized vehicle shall be permitted in any area of the parks, with the exception of those permitted by the rules and regulations of each park.

ARTICLE VIII NOTICE TO PARK USERS

Signs shall be prominently placed at all applicable town park and recreation areas and facilities, notifying the public of the prohibition against the use of all tobacco and cannabis products and use of tobacco substitutes (including vaping devices).

ARTICLE VIII VIOLATION AND PENALTIES

A violation of this ordinance shall be subject to civil enforcement in accordance with the provisions of 24 VSA Section 1974a and 1977 et seq. A civil penalty of not more than \$500.00 may be imposed for a violation of this civil ordinance and the waiver fee shall be set at \$50.00 for the first offense, \$100.00 for the second offense within a six month period, and \$200.00 for all subsequent offenses within a six month period. Each day violation shall constitute a separate violation of this ordinance.

ARTICLE IX EFFECTIVE DATE

Effective Date: This ordinance shall take effective sixty days after the adoption by the Select Board for the Town of Hartford, Vermont.

ARTICLE X NO PREEMPTION OF PRIVATE REMEDY

Nothing in this ordinance shall be construed to limit or modify any remedy which may be available to any private person under existing common law or statute for abatement of nuisance, nor shall any enforcement process begun or completed by the Town of Hartford against any person be deemed or construed to exempt such person from imposition of liability resulting from pursuit of civil remedy by any other person.

Adopted this 14th day of April at Hartford, County of Window, State of Vermont all in accordance with Title 24 VSA (14) and 24 VSA Chapter 59 (Civil Enforcement).
